## FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of Correction Officer Recruit (S9988R), Department of Corrections

CSC Docket No. 2015-3079

List Revival

The Department of Corrections requests that the eligible list for Correction Officer Recruit (S9988R), which expired on May 22, 2015, be revived and extended until a new list is available.

By way of background, the subject eligible list promulgated with 9,010 eligible names on May 23, 2013 and expired on May 22, 2015. The names of 8,989 eligibles remain on the list.

In the instant request, the appointing authority requests a two month extension to the subject eligible list as a precautionary measure so that it may issue one final certification from it. Lastly, the Division of Agency Services (DAS) recommends that the appointing authority's request be approved.

## CONCLUSION

N.J.S.A. 11A:4-6 and N.J.A.C. 4A:4-3.4 provide that an eligible list may be revived in order to implement a court order or decision of the Civil Service Commission in the event of a successful appeal instituted during the life of a list, to correct an administrative error, or for other good cause. Additionally, N.J.S.A. 11A:4-6 and N.J.A.C. 4A:4-3.3(b)1 provide that an eligible list may, for good cause, be extended, except that no list shall have a duration of more than four years.

In the present matter, the appointing authority seeks to extend the subject eligible list as a precautionary measure. A new list is set to issue in early July 2015 but because of the number of candidates that are expected to be hired, the appointing authority wishes to make one final certification from the subject eligible list. Moreover, DAS recommends extending the subject eligible list. Therefore, under these circumstances, good cause has been established to revive and extend the eligible list for Correction Officer Recruit (S9988R), Department of Corrections for one year or until a new list is available, whichever occurs first.

## ORDER

Therefore, it is ordered that this request be granted and the eligible list for Correction Officer Recruit (S9988R), Department of Corrections be revived and extended until May 22, 2016 or until a new list is available, whichever occurs first.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
