Sheneequa Ming appeals the determination of the Division of Agency Services (Agency Services) that she was below the minimum requirements in experience for the promotional examination for Senior Clerk (PS9475F), Department of Education.

:

The examination at issue was announced with specific requirements that had to be met as of the December 22, 2014 closing date (see attached). A total of six employees applied for the subject examination and three were deemed eligible. Certification PS150672 was issued containing the names of the three eligibles and one eligible was appointed. The list expires on May 6, 2018.

On Ms. Ming's application, she indicated that she was a Clerk from March 2014 to the December 22, 2014 closing date. Agency Services credited the appellant for her 10 months of experience as a Clerk, but determined that she lacked two months of experience.

On appeal, Ms. Ming presents that within the office of Adult Education, she assures statewide compliance to nationally established Adult Education testing standards, provides technical support to Adult Education testing sites, works with test vendors and test centers to ensure smooth operation of the testing program, generates official GED transcripts for verification, assists with conferences and meetings, responds to phone and written requests in an expedited fashion, and records and processes checks for Licensing and Certifications.

CONCLUSION

N.J.A.C. 4A:4-2.6(a) provides that applicants shall meet all requirements specified in the promotional announcement by the closing date. Further, N.J.A.C. 4A:1-1.2(c) states that the Civil Service Commission (Commission) may relax a rule for good cause in order to effectuate the purposes of Title 11A, New Jersey Statutes.

Based on her application, Agency Services correctly determined that Ms. Ming did not meet the required experience as of the December 22, 2014 closing date as she lacked two months of experience. However, the record evidences that the list is incomplete as one eligible has been appointed and only two names remain on the eligible list. Further, the appellant continues to serve in the next lower in-series title of Clerk and has gained the additional experience after the closing date to satisfy that requirement. Therefore, under these circumstances, good cause exists to relax the provisions of N.J.A.C. 4A:4-2.6(a) and accept Ms. Ming's experience after the closing date, for eligibility purposes, and admit her to the subject examination.

ORDER

Therefore, it is ordered that the appeal be granted, and Sheneequa Ming's application be processed for prospective employment opportunities only.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.



Clerk

Experience: One (1) year of experience in general clerical work.

License: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle rather than employee mobility, is necessary to perform the essential duties of the position. The responsibility for ensuring at employees possess the required motor vehicle license, commensurate with the class and type of vehicles they operate, rests with the Appointing Authority.
