Joanne Smith-Tavener appeals the decision of the Division of Agency Services (Agency Services) which found that she did not meet the experience requirements for the promotional examination for Program Monitor Americans with Disability Act (PS1424P), Department of Law and Public Safety.

The promotional examination was announced with specific requirements which had to be met as of the announced closing date of September 21, 2015 (see attached). It is noted that the appellant was the only applicant for the subject examination and that the examination was cancelled when she was found ineligible.

The appellant's application in conjunction with official records indicates that she has served as a provisional in the title under test from May 4, 2013 through the September 21, 2015 closing date of the subject examination, as a Standards and Procedures Technician 3 from May 2011 to May 2013, as a Principal Standards and Procedures Technician from April 2005 to May 2011, as a Senior Standards and Procedures Technician from November 2001 to April 2005, as a Standards and Procedures Technician from October 1999 to November 2001, as a Senior Technician Management Information Systems from September 1997 to October 1999, as a Technician Management Information Systems from December 1994 to September 1997, as a Secretarial Assistant 3 from February 1992 to December 1994, as a Principal Clerk Transcriber from November 1985 to February 1992, as a Senior Clerk Transcriber from April 1982 to November 1985 and as a Clerk Transcriber from October 1981 to April 1982. Agency Services determined that the appellant possessed the required education and credited her with two years and five

months of applicable experience for her work as a provisional in the title under test. Agency Services determined that none of her other work experience was applicable. Therefore, the appellant was found to be lacking seven months of applicable experience.

On appeal, the appellant argues that she has been performing the duties of Program Monitor Americans with Disability Act since July 1, 2011. In support of the contention, she submits a Performance Evaluation System (PES) evaluation from November 1, 2010 to October 31, 2011, which supports her claim that she performed out-of-title work. Additionally, the appellant submits a Classification Appeal Determination which found that she was performing the duties of a Program Monitor Americans with Disability Act and reclassified the position and gave an effective date of May 4, 2013. Further, the appellant details the duties she has performed.

CONCLUSION

N.J.A.C. 4A:4-2.6(a)2 provides that applicants shall meet all requirements specified in the promotional examination announcement by the closing date. *N.J.A.C.* 4A:4-2.6(c) provides that, except when permitted for good cause, applicants for promotional examinations with open competitive requirements may not use experience gained as a result of out-of-title work to satisfy eligibility requirements.

In the instant matter, the appellant's out-of-title work experience since July 1, 2011 along with her work as a provisional in the title under test was corroborated by her PES. This provides the appellant with more than the necessary three years of applicable experience before the closing date of the examination. Accordingly, since the examination has been cancelled and admitting the appellant to the examination would enable the appointing authority to effect a permanent appointment, good cause exists to accept the appellant's out-of-title work experience, for examination eligibility purposes, and admit her to the subject examination.

ORDER

Therefore, it is ordered that this appeal be granted, the examination cancellation be rescinded and Joanne Smith-Tavener's application be processed.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

Open to employees in the competitive division who have an aggregate of one year of continuous permanent service as of the closing date in any competitive title and meet the requirements listed below:

Education: Graduation from an accredited college or university with a Bachelor's degree.

Experience: Three (3) years of experience in a government agency involved in developing, administering, monitoring, or evaluating programs and policies relating to equal employment opportunity or civil rights.

Note: Applicants who do not possess the required education may substitute additional experience as indicated above on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

Note: A Master's degree in Business Administration, Public Administration, or Personnel Administration from an accredited college or university may be substituted for one (1) year of indicated experience.

License: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
