## FINAL ADMINISTRATIVE ACTION **OF THE CIVIL SERVICE COMMISSION**

**Examination** Appeals

In the Matter of Gregory Sayell and Micheal Wargo, Mechanic Diesel (M0316V), Vineland School District

Gregory Sayell and Micheal Wargo appeal the determinations of the Division of Agency Services which found that they did not meet the minimum experience requirements for the open-competitive examination for Mechanic Diesel (M0316V), Vineland School District.

The subject open-competitive was announced with specific requirements that had to be met as of the May 22, 2017 closing date (see attached). There was one admitted candidate, and the eligible list was certified once but no appointments have yet been made.

Mr. Sayell did not indicate possession of the required training, and per the substitution clause, was required to possess three years of applicable experience. He listed three positions on his application, Mechanic with Vineland, Diesel Mechanic with Seashore Asphalt, and Mechanic with R&R Machine Shop. The appellant was credited with two years, ten months of experience in the first two positions, and was found to be lacking two months of full-time experience. On appeal, the appellant provides a more complete listing of duties for each of his positions. The Supervisor of Garage Services indicates that the School District has approximately 200 school buses all powered by various diesel engines, and he provides some of the duties performed by Mr. Sayell.

Mr. Wargo has the required training, and he listed two positions on his application, Mechanic Diesel with Vineland School District, and Auto Technician with Lilliston Ford. He was credited with one year, nine months of experience in both positions, and found to be lacking three months of qualifying experience. On appeal, the appellant reiterates his training and experience. The Supervisor of Garage Services provides some of the duties performed by Mr. Wargo as well.

N.J.A.C. 4A:4-2.3(b) provides that applicants shall meet all requirements specified in the open competitive examination announcement by the closing date.

## CONCLUSION

Initially, the appellants were correctly denied admittance to the subject examination since they lacked two months and three months of qualifying experience, respectively. Nonetheless, only one eligible candidate appears on the certification. The appellants are still serving as provisional appointees and they have accrued additional months of qualifying experience, since the May 2017 closing date. Based on the particular circumstances presented, good cause has been established to relax the provisions of N.J.A.C. 4A:4-2.3(b) to accept the appellants' additional experience beyond the closing date and admit them to the examination.

### ORDER

Therefore, it is ordered that these appeals be granted, and the appellants' applications be processed.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

**EXPERIENCE:** Two (2) years of experience in the installation, maintenance, and repair of diesel engines.

**NOTE:** Possession of a certificate as a diesel mechanic issued by the National Institute for Automotive Service Excellence may be substituted for one (1) year of formal training. If you are substituting a certificate for the one year of formal training, please upload a copy of your certificate with your application. Failure to do so will result in ineligibility.

LICENSE: Appointees will be required to possess a valid New Jersey driver's license.

Appointees must possess a valid Commercial Driver's License (CDL) Class B. Please upload a copy of your license with your application.

**NOTE:** The responsibility for ensuring that employees possess the required motor vehicle license, commensurate with the class and type of vehicles they operate, rests with the Appointing Authority.
