# FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of William Wei, Forensic Analyst Information Technology, (C0153V), Bergen County

CSC Docket No. 2017-3921

**Examination Appeal** 

ISSUED: November 2, 2017 (RE)

William Wei appeals the determination of the Division of Agency Services (Agency Services) that he did not meet the education requirement for the open competitive examination for Forensic Analyst Information Technology, (C0153V), Bergen County.

The examination at issue was announced with specific requirements that had to be met as of the March 8, 2017 closing date (see attached). As there were no admitted candidates, the examination was cancelled on June 26, 2017.

Mr. Wei indicated on his application that he graduated with a Bachelor's degree in Economics from Rutgers University in 1990. He also possesses a Master's degree in Adult and Continuing Education, which he earned from Rutgers University in 1994. Mr. Wei also indicated that he was a provisional in the subject title from November 2016 forward, and was employed prior to that as an Associate Director of Data Forensics with Altep Inc., and as a Lieutenant County Investigators with the Monmouth County Prosecutor's Office. All of his experience from December 1995 to the closing date was accepted. Agency Services the noted that Mr. Wei possessed a Bachelor's degree, but it was not in the field of Computer Science, Computer Forensics, or other related field of technology with a specialization in digital forensics.

On appeal, Mr. Wei states that he created the Monmouth County Prosecutor's Office Computer crimes unit in 1999, which was the first county-wide computer forensics laboratory in New Jersey. He states that he was the first person

in New Jersey to obtain both the EnCE and CFCE computer forensics certifications. He indicates that he is taught computer forensics for guidance software, the manufacturer of EnCase, coached forensic examiners obtaining their EnCE certifications, and coauthored a book on the EnCE certification. He states that he taught computer investigations at Monmouth University for five years, from 2009 to 2013, and is the coach for the International Association of Computer Investigative Specialists members obtaining their CFCE certifications. The appellant explains that computer forensics is a relatively new science, and he was fortunate to be engaged in this field during its infancy. He states that degrees in computer forensics did not exist when he began performing data forensics in the late 1990s, and his training and experience came from like minded people who learn on the job and trained others. He states that he set Second Chair in the first computer theft case tried in New Jersey (State of New Jersey v. Arun Gaikwad, 349 N.J. Super. 62, 793 A.2d 39), and was an expert witness in the first prosecution against the fantasy defense in a child sexual exploitation case (New Jersey v. James R. Davis, 390 N.J. Super. 573, 916 A.2d 493).

The Bergen County Prosecutor sent a letter in support of this appeal. He states that Mr. Wei is a pioneer in computer forensics with many years of experience before it was offered as a curriculum at universities. He states that Ms. Wei teaches at the university level, is published author of a book on becoming a certified technician using the forensic software package EnCase, and he coaches candidates for certification in EnCase and other related forensic software. The Prosecutor and maintains that Mr. Wei's excellent work attests to the level of training he brings to the field.

### CONCLUSION

N.J.A.C. 4A:4-2.3(b)2 requires applicants to possess all the requirements specified in an announcement for an open competitive examination by the closing date. Further, N.J.A.C. 4A:1-1.2(c) states that the Civil Service Commission (Commission) may relax a rule for good cause in order to effectuate the purposes of Title 11A, New Jersey Statutes.

Initially, Agency Services correctly determined that the appellant lacked an appropriate Bachelor's degree. The appellant possesses a Bachelor's degree and a Master's degree. He is also an expert in the field of computer forensics, which is a relatively new area of science. Therefore, the Commission finds that the totality of his college education, his certifications, his experience in the subject title, and his teaching experience in the field are acceptable to meet the education requirements for the subject examination. See In the Matter of Meg-Anne McCarthy (MSB, decided August 11, 2004) (Totality of experience, Bachelor's degree in Food and Nutrition, and Master's degree in Health Administration acceptable for required Master's degree in a nutrition specialty).

It is noted that this remedy is limited to the particular circumstances of this matter and does not set a precedent in any other matter.

### ORDER

Therefore, it is ordered that this appeal be granted, the exam cancellation be rescinded, and the appellant's application be processed for current employment opportunities.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
