FINAL ADMINISTRATIVE ACTION OF THE

CIVIL SERVICE COMMISSION

In the Matter of Deborah Rodriguez and Damond Yearns, Supervising Program Support Specialist, Assistance Programs (PS1332K), Department of Children and Families

Deborah Rodriguez and Damond Yearns appeal the determination of the Division of Agency Services (Agency Services) that they either lacked the required amount of permanent status in a title to which the examination was open or were not permanent in a title to which the examination was open for Supervising Program Support Specialist, Assistance Programs (PS1332K), Department of Children and Families. These appeals have been consolidated due to common issues presented.

The examination at issue was announced with specific requirements that had to be met as of the July 21, 2016 closing date (see attached). There were ten employees who applied for, and four deemed eligible for the subject examination. The list expires on November 30, 2019.

A review of personnel records indicates that Ms. Rodriguez was permanently appointed as a Program Support Specialist 1, Assistance Programs, effective March 19, 2016 and currently serves in that title. She had been provisionally appointed to that title pending a Qualifying Examination on March 5, 2016. Previously, she had served permanently as a County Services Specialist from April 2013 to March 2016. The examination was only open to employees who had an aggregate of one year of continuous permanent service as a Program Support Specialist 1, Assistance Programs immediately preceding the closing date. Therefore, Agency Services determined that the appellant was not eligible for the subject examination since she

lacked one year of continuous permanent service as of the closing date in a title to which the examination was open.

A review of personnel records indicates that Mr. Yearns was permanently appointed as a County Services Specialist, effective April 19, 2014 and currently serves in that title. Therefore, Agency Services determined that the appellant was not eligible for the subject examination since he was not permanent in a title to which the examination was open.

On appeal, Ms. Rodriguez presents that her prior permanent title was County Services Specialist. She states that Human Resources advised her that County Services Specialist and Program Support Specialist 1, Assistance Programs were "equivalent titles" and after she passed a Qualifying Examination, her title was laterally changed and she was permanently appointed to that title effective March 19, 2016. Therefore, Ms. Rodriguez argues that since the County Services Specialist and Program Support Specialist 1, Assistance Programs titles are equivalent, she meets the eligibility requirements.

Mr. Yearns presents that he has more than six years of continuous permanent service as a County Services Specialist. He believes that he should be eligible for the subject examination based on his experience and education. He contends that County Services Specialist and Program Support Specialist 1, Assistance Programs are equivalent titles. Therefore, Mr. Yearns questions why this examination was only open to those who had one year of continuous permanent service as a Program Support Specialist 1, Assistance Programs.

CONCLUSION

- *N.J.A.C.* 4A:4-2.6(a)1 provides that applicants for promotional examinations shall have one year of continuous service for an aggregate of one year immediately preceding the closing date in a title or titles to which the examination is open.
- *N.J.A.C.* 4A:4-2.5(b) provides that when a promotion is made from a professional title to a professional title, it shall be open to permanent competitive division employees serving in one of the following:
 - 1. The next lower or next two lower in-series titles.
 - 2. The next lower, in-series title, and all other permanent competitive division employees who meet the complete open competitive requirements.
 - 3. To related titles, pursuant to an established plan approved by the Chairperson of the Civil Service Commission or designee;

4. Competitive division employees who meet complete open competitive requirements and all titles as described in (d)l or 2 above; or

N.J.A.C. 4A:4-7.6(a) provides that a lateral title change is the movement of permanent employee from his or her permanent title to an equivalent title within the same organizational unit.

N.J.A.C. 4A:1-1.3 provides that a "lateral movement" means an employee movement from one position to another with a similar salary and level of duties, responsibilities, and qualifications and, where applicable, the same class code.

N.J.A.C. 4A:4-6.3(b) provides that the appellant has the burden of proof in examination appeals.

In the instant matter, the subject promotional announcement was only open to employees who had one year of continuous permanent service in the Program Support Specialist 1, Assistance Programs title immediately preceding the June 21, 2016 closing date. However, Ms. Rodriguez only had three months of continuous permanent service in that title immediately preceding the closing date and her prior permanent title was County Service Specialist. Mr. Yearns has over one year of continuous permanent services as County Service Specialist immediately preceding the closing date, but this examination was not open to incumbents in this title. The appellants both assert that County Service Specialist is an equivalent title to Program Support Specialist 1, Assistance Programs and therefore argue that they should be determined to have met the eligibility requirements. compliance with N.J.A.C. 4A:4-2.5(b)1, this examination was only announced to the next lower in-series title. It is irrelevant that the County Service Specialist and Program Support Specialist 1, Assistance Programs are lateral titles. Thus, there is no evidence of misapplication of the controlling regulatory provision. Accordingly, Agency Service correctly determined that the appellants did not have one year of continuous permanent service in a title to which the exam was open.

With respect to Mr. Yearns question as to how the subject examination can only be open to the Program Support Specialist 1, Assistance Programs title, generally, the title scope for a promotional examination is determined by the appointing authority or by the title scope of the provisional incumbent in the title and the appointing authority is vested with the discretion to choose the appropriate title scope from the options set forth in N.J.A.C. 4A:4-2.5. See In the Matter of Mitchell Dinnerstein, Docket No. A-1680-05T5 (App. Div. September 29, 2006), cert. denied, 189 N.J. 647 (2007). Accordingly, the appointing authority had the discretion to limit the subject examination to those who served in the next lower inseries title.

ORDER

Therefore, it is ordered that the appeal be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
