Timothy Baggitt appeals the determination of the Division of Agency Services (Agency Services), which found that he was ineligible for the promotional examination for Sheriff's Officer Lieutenant (PC3000U), Monmouth County.

The subject examination was open to employees who had an aggregate of one year of continuous permanent service in the Sheriff's Officer Sergeant title as of the November 21, 2016 closing date. A total of eight employees applied for the examination and seven were admitted to take the test. The test administration date was May 4, 2017. The appellant's personnel record indicates that he was permanently appointed as a Sheriff's Officer Sergeant effective April 2, 2016. Thus, Agency Services found the appellant ineligible as he lacked the required amount of permanent services as of the closing date.

On appeal, the appellant presents that the test administration date for the Sheriff's Officer Sergeant (PC2153R) promotional examination was on May 8, 2014. However, he submits documentation indicating that he was out-of-state attending a training course that was approved by the Monmouth County Sheriff's Department on that date. Thereafter, the appellant was scheduled for a make-up examination, received a passing grade, and permanently appointed as a Sheriff's Officer Sergeant in April 2016. He asserts, based on his score from the make-up examination, if he had taken the Sheriff's Officer Sergeant test on May 8, 2014, he would have been permanently appointed in early 2015 and therefore he would have had more than one year of continuous permanent service in the required title as of the closing date.

He also submits a letter from Shaun Golden, Sheriff for the Monmouth County Sheriff's Office, in support of his appeal.

## CONCLUSION

N.J.A.C. 4A:4-2.6(a)1 provides that applicants for promotional examinations must have one year of continuous permanent service for an aggregate of one year preceding the closing date in a title or titles to which the examination is open.

N.J.A.C. 4A:2-1.1(b) provides that unless a different time period is stated, an appeal must be filed within 20 days after either the appellant has notice or should reasonably have known of the decision, situation, or action being appealed.

Initially, it is noted that, on May 28, 2014, the appellant signed an Agreement to Take a Make-Up Examination for Sheriff's Officer Sergeant The agreement stated that candidates who passed the make-up (PC2153R). examination will be considered for prospective appointment and will not receive retroactive appointments. Therefore, the appellant was on notice that he would only receive a prospective appointment if he passed the make-up exam and should have filed an appeal within 20 days of May 28, 2014 if he believed he was entitled to an earlier appointment based on his circumstances. Additionally, the Commission notes that the requirement that applicants must have completed one-year in a lower position does not contradict the constitutional mandate that employees be promoted "according to merit and fitness" but only sets a reasonable floor at which the Commission begins to evaluate the qualifications of applicants. The Constitution does not mandate that all promotional opportunities be made available to all employees. Therefore, while the circumstances are unfortunate, the year in grade requirement cannot be relaxed as the appellant must have actually served in and performed the duties of the Sheriff's Officer Sergeant title during the requisite year in grade in order to be eligible. See In the Matter of Peter Corbo, Docket No. A-2275-12T2 (App. Div. October 20, 2014). See also In the Matter of Albert Giordano (MSB, decided January 26, 2005).

Accordingly, based on the foregoing, the appellant has not met his burden of proof, and has not provided a basis to disturb the determination of the Division of Agency Services.

## ORDER

Therefore, it is ordered that this appeal be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

- 1. NJAC 4A:4-2.6 states that all requirements listed must be met as of the closing date, including assignment to jurisdiction/department, and satisfying the permanent status requirement.
- 2. ONLY ON-LINE APPLICATIONS WILL BE ACCEPTED. YOU MUST COMPLETE YOUR APPLICATION IN DETAIL. Your score may be based on a comparison of your credentials with the job requirements. Failure to complete your application properly may lower your score or cause you to fail.
- 3. This examination is open to full-time and part-time permanent employees. If an employment list results from this announcement, it may be certified to fill both full-time and part-time positions. If 35- and 40-hour positions are used within the department, the resulting list may be used to fill either work week position.
