# FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of Michael Martinez, General Supervisor Traffic Maintenance (PM1640U), Newark

Examination Appeal

Michael Martinez appeals the determination of the Division of Agency Services (Agency Services) that he was below the minimum requirements in experience for the promotional examination for General Supervisor Traffic Maintenance (PM1640U), Newark.

The examination at issue was announced with specific requirements that had to be met as of the August 22, 2016 closing date (see attached). The appellant was the only employee who applied for the subject examination that was cancelled due to a lack of qualified candidates.

On appeal, Mr. Martinez presents that he has over 30 years of experience performing traffic sign installations and other related duties. Additionally, he explains that, since May 2010, he has been performing the duties of the subject title while working as a Compressor Operator.

# **CONCLUSION**

N.J.A.C. 4A:4-2.6(a) provides that applicants shall meet all requirements specified in the promotional announcement by the closing date.

Initially, Agency Services determined that the appellant lacked the required duties because he did not clearly describe in his application that, as a Supervisor Traffic Maintenance from January 1999 to November 2005, he performed the

required duties. Further, his experience performing the required duties, as a Compressor Operator from May 2010 to the August 22, 2016 closing date, would be considered out-of-title work. However, in accordance with N.J.A.C. 4A:4-2.1(g), the Civil Service Commission (Commission) can accept clarifying information in eligibility appeals. For example, information submitted on appeal pertaining to duties performed in a given position that expands or enlarges on information previously submitted is considered clarifying. On appeal, Mr. Martinez clarifies the duties he performed while serving as a Supervisor Traffic Maintenance between January 1999 and November 2005. Additionally, the Commission notes that the appellant has been provisionally serving in the subject title since January 2016. Under these circumstances, the Commission accepts the clarification of Mr. Martinez's experience as a Supervisor Traffic Maintenance, and admits him to the examination.

## ORDER

Therefore, it is ordered that the appeal be granted, the examination cancellation be rescinded, and the appellant's application be processed.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
