Request for Interim Noncompetitive Appointments

The Division of Agency Services (Agency Services) requests the reallocation of certain titles to the noncompetitive division of the career service from August 18, 2018 to September 1, 2018.

Agency Services requests that the subject titles (attached) be designated as noncompetitive on an interim basis, for one pay period, to allow the employees on the attached list to be permanently appointed to career service titles. This request is in response to P.L. 2018, c. 62, which was passed on July 3, 2018, and directed, inter alia, the transfer of the State Medical Examiners Office from the Department of Law and Public Safety to the Department of Health. In order to comply with the law, the Department of Health requests certain actions in order to effect the transfer of the subject employees. Specifically, it states that the employees on the attached list are currently serving in career service titles, but due to their assignment in the Division of Criminal Justice in the Department of Law and Public Safety, they are, by law, unclassified employees. Upon their transfer to the Department of Health, no statutory authority exits to continue their service in unclassified titles. Agency Services conduced a review of the classifications of these employees. It asserts that allocation of the listed titles to the noncompetitive division on an interim basis will allow the Department of Health to comply with the recent legislation, ensure appropriate position classification, and avoid any negative impact on the subject employees. Therefore, it requests a relaxation of the criteria outlined in N.J.A.C. 4A:3-1.2(c) in order to allocate the subject titles into the noncompetitive division on an interim basis, for one pay period, in order to

effectuate the appointment of the subject employees into the appropriate career service titles.

Agency Services adds that since the listed employees are, by law, confidential, no notification was required to applicable collective negotiations representatives.

CONCLUSION

N.J.A.C. 4A:3-1.2(c) provides that a job title may be placed in the noncompetitive division on an ongoing or interim basis when it is determined that it is appropriate to make permanent appointments to the title, and that one or more of the following criteria are met:

- 1. Competitive testing is not practicable due to the nature of the knowledge, skills and abilities associated with the job;
- 2. Certification procedures based on ranked eligible lists have not or are not likely to meet the needs of appointing authorities due to such factors as salary, geographic location, recruitment problems and working conditions; or
- 3. There is a need for immediate appointments arising from a new legislative program or major agency reorganization.

Based on the legislation described above, interim noncompetitive status for the subject titles is appropriate in this matter. Additionally, *N.J.A.C.* 4A:3-1.2(g) provides that, if a title is designated noncompetitive on an interim basis, at the end of the interim noncompetitive period, which shall be no greater than one year, the job title shall be redesignated as competitive. Individuals appointed during the interim noncompetitive period shall, upon successful completion of their working test periods, attain permanent status in the competitive division.

ORDER

Therefore, it is ordered that this request be granted, and interim noncompetitive designations for the subject titles be effected. This designation will be effective from August 18, 2018 to September 1, 2018. At the end of this period, the subject titles will be returned to the competitive division of the career service.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
