In the Matter of Engineering Technician Apprentice

CSC Docket No. 2020-575

Establishment of a Noncompetitive Title

ISSUED: FEBRUARY 27, 2020 (DASV)

The Division of Agency Services (Agency Services) requests the establishment of a two-year Engineering Technician Apprentice title and its allocation to the noncompetitive division of the career service.

By way of background, as set forth in the attached request, Agency Services presents that the subject title series is currently "general" and used by other State agencies. However, the Department of Transportation (DOT) has requested that the title series be restructured to meet its current needs and to remove inconsistencies between the levels. In that regard, Agency Services indicates that the title series would be renumbered with the Engineering Technician 1 title being at the lowest level and the Engineering Technician 4 title being at the highest level in the title series. Incumbents will be laterally moved to the new levels with no loss of existing status. Additionally, the Engineering Technician 5 title will be made archaic and inactivated once the title is vacated. Proposed job specifications for the levels have been drafted to reflect the changes. These revised job specifications were forwarded to all agencies having incumbents and no objection was received.

Against this backdrop, DOT requests the creation of a two-year apprentice title to serve as an entry level title in the title series and to meet its rapid recruitment needs. Incumbents in the position will receive on-the-job training while learning semi-skilled technical engineering support functions of a routine nature.

Incumbents who successfully complete the apprenticeship program will be advanced to the restructured title of Engineering Technician 1. See N.J.A.C. 4A:3-3.7(j). Moreover, Agency Services requests that the new title be assigned to the noncompetitive division due to the impracticability of competitive testing. It notes that there are no experience requirements that applicants must meet, and thus, there is no skillset to be tested. Applicants will only require possession of a high school diploma and high school level mathematics courses. Agency Services also specifies that the appropriate negotiations representatives have been notified, in accordance with N.J.A.C. 4A:3-3.3(f), and that the Office of Employee Relations has reviewed and assigned the bargaining units.² Finally, Agency Services notes that the renumbering of the levels of the title series, the lateral title changes, and archaic designations will become effective the same date the Commission sets as the effective date for the establishment of the Engineering Technician Apprentice title.

CONCLUSION

N.J.A.C. 4A:3-3.2(a) provides that the Commission shall establish and maintain classification plans for all job titles in the career, senior executive and unclassified services. Additionally, *N.J.A.C.* 4A:3-3.3(a)2 and *N.J.A.C.* 4A:3-3.3(a)3 provide that the Chairperson of the Commission or designee shall implement and administer the classification plans and, in this regard, shall establish new titles, abolish unnecessary titles, consolidate titles, and modify specifications for existing titles or series to ensure their accuracy.

N.J.A.C. 4A:3-1.2(c) provides that a job title may be placed in the noncompetitive division on an ongoing or interim basis when it is determined by the Commission that it is appropriate to make permanent appointments to the title and one or more of the following criteria are met:

- 1. Competitive testing is not practicable due to the nature of the knowledge, skills, and abilities associated with the job;
- 2. Certification procedures based on ranked eligible lists have not or are not likely to meet the needs of appointing authorities due to such factors as salary, geographic location, recruitment problems and working conditions; or
- 3. There is a need for immediate appointments arising from a new legislative program or major agency reorganization.

Based on all of the foregoing, ample reasons exist to establish an Engineering Technician Apprentice title in the noncompetitive division of the career service

pursuant to *N.J.A.C.* 4A:3-1.2(c)1. The Engineering Technician Apprentice title is an entry-level title with no experience requirements and minimal education requirements. Incumbents will gain the necessary skillset during the apprenticeship program. Additionally, it is noted that incumbents would be required to complete a four-month working test period prior to attaining permanent status. *See N.J.A.C.* 4A:4-5.1(b) and *N.J.A.C.* 4A:4-5.2(b)2. Accordingly, competitive testing is impracticable for this title.³

ORDER

Therefore, it is ordered that this request be granted and that the title of Engineering Technician Apprentice be established and allocated to the noncompetitive division. This action shall be effective the first pay period following the Commission's approval.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

³ It is not necessary for the Commission to formally act on Agency Services' restructuring of the title series, *i.e.*, renumbering the levels and designating a title archaic, as these functions have been specifically delegated to the Chairperson or designee by *N.J.A.C.* 4A:3-3.3. See In re Changes in the State Classification Plan, 460 N.J. Super. 358 (App. Div. 2019). However, N.J.A.C. 4A:3-1.(c) specifically requires the Commission to determine if a title should be placed in the noncompetitive division of the career service.

Department of Transportation - Title Series Restructuring

The Division of Agency Services seeks to restructure the Engineering Technician title series at the request of the Department of Transportation (DOT). The title series is currently structured as follows:

Engineering Technician 5 (59957, A09) (10116, A11)

Engineering Technician 4 (10117, A15)

Engineering Technician 3 (59956, A15) (10118, A17)

Engineering Technician 2 (59955, R17) (10120, R19)

Engineering Technician 1 (59954, S20) (10122, S22)

The title series is being restructured to meet the current needs of the departments and to remove the inconsistencies between the levels. The job specifications of all the levels are being updated to reflect these changes.

The Engineering Technician title series is currently general and is used by other State Agencies. The revised draft specifications were forwarded to all agencies having incumbents in these titles, no objections were raised.

The DOT also requests to create an Apprentice title, which would serve as an entry level to the Engineering Technician series and assist the department in meeting its rapid recruit needs. The title would receive on-the-job training while learning semi-skilled technical engineering support functions of a routine nature. After successful completion of the two (2) year apprenticeship program, the incumbent shall be advanced to the restructured title of Engineering Technician 1 (A15, 10117), under the Civil Service Commission procedures.

The bargaining unit of the apprentice title was assigned by the Governor's Office of Employee Relations.

As requested by the DOT, we recommend assigning the Apprentice title to the noncompetitive division of the career service. The title has been identified as appropriate for the noncompetitive class of service based on the criteria defined in N.J.A.C. 4A:3-1.2(c), which states

- "(c) A job title may be placed in the Noncompetitive Division on an ongoing or interim basis when it is determined by the Commissioner that it is appropriate to make permanent appointments to the title and one or more of the following criteria are met.
- 1. Competitive testing is not practicable due to the nature of the knowledge, skills and abilities associated with the job."

It is our opinion that competitive testing is not practicable due to the knowledge, skills, and abilities associated with the job. The title has no experience requirements; hence there is no skill set to be tested. The required skill set would be learned on the job, as it's an Apprentice title. The title only requires a High School diploma, and high school level mathematics courses.

The title series is also being renumbered in accordance with current practice with "1" being the lowest level in the series and "4" being the highest level in the series.

The appropriate negotiations representatives have been notified in accordance with N.J.A.C. 4A: 3-3.3 (f).

Effective: The effective date of this action will be the beginning of the first pay period that follows the Commission's approval.
