Jeffrey Woodson requests a make-up for the open competitive examination for Sheriff's Officer (C0219D), Gloucester County.

By way of background, as indicated in the 2022 LEE Frequently Asked Questions (FAQs) page,<sup>1</sup> unlike previous LEE testing cycles, the 2022 LEE did not permit candidates to fill out a single application and indicate the titles for which they wished to be considered. Instead, titles that were included in the 2022 LEE testing cycle<sup>2</sup> were announced separately by jurisdiction. As also noted in the LEE FAQs, "the Law Enforcement Aptitude Battery (LEAB) will be used to test candidates who apply for any of the LEE titles . . . Because the same examination is used, candidates will only have <u>one</u> opportunity to take the examination, regardless of the number of announcements for which they apply, and their score achieved on the examination will be applied to all these 2022 LEE announcements for which they applied." Candidates who were admitted to the 2022 LEE were sent an email on April 8, 2022 which provided information and links for self-selecting a test center, date, and time via Sign-Up Genius. The email further indicated that "all candidates will be sent a paper scheduling notice by mail [(Notification to Appear)] approximately two weeks

prior to the test date. Please bring the paper scheduling notification you receive by mail with you to the test center."<sup>3</sup> In this regard, Notifications to Appear dated May 19, 2022 indicating an assigned test center, date, and time were mailed to all eligible candidates. It is noted that Woodson was scheduled to be tested on June 11, 2022 at Camden County College in Blackwood, New Jersey.

On appeal, Woodson submits notarized statements, dated July 1, 2022 and November 21, 2022, indicating that he received the above noted April 8, 2022 email "but [I] was unable to choose a date through the self-select. The email also stated that I'd receive a letter with a chosen date of any of the remaining test dates and sites. To date I have not received a letter at my address." He presents that he contacted the Civil Service Commission on June 13, 2022 but he was informed that he had missed his scheduled test date of June 11, 2022.

## CONCLUSION

N.J.A.C. 4A:4-2.9 provides that make-up examinations for open competitive and general promotional testing may be authorized for the following reasons: 1. Error by the Civil Service Commission or appointing authority; 2. Serious illness or disability of the candidate on the test date, provided the candidate submits a doctor's certificate specifying that the candidate was not able to take the test on that day for medical reasons; 3. Documented serious illness or death in the candidate's immediate family; 4. Natural disaster; 5. Prior vacation or travel plans outside of New Jersey or any contiguous state, which cannot be reasonably changed, as evidenced by a sworn statement and relevant documentation; 6. When required for certain persons returning from military service (see N.J.A.C. 4A:4-4.6A); and 7. Other valid reasons.

The Commission acknowledges the presumption that mail correctly addressed, stamped and mailed is generally received by the party to whom it was addressed. See SSI Medical Services, Inc. v. State Department of Human Services, 146 N.J. 614 (1996); Szczesny v. Vasquez, 71 N.J. Super. 347, 354 (App. Div. 1962); In the Matter of Joseph Bahun, Docket No. A-1132-00T5F (App. Div. May 21, 2001). It also recognizes that on occasion, such mail never reaches its intended destination.

In the present matter, a review of the record finds no evidence of error as the notice sent May 19, 2022 informing candidates of the test date, time and location, was sent to the address indicated on Woodson's application. Moreover, although being specifically advised and provided with multiple opportunities during the appeal process, Woodson did not submit a *sworn* notarized statement<sup>4</sup> that he did not

receive a Notification to Appear for the subject test. Absent such a sworn statement, the Civil Service Commission cannot credit the appellant's assertions.

A thorough review of the record indicates that the appellant has failed to support his burden of proof in this matter.

## **ORDER**

Therefore, it is ordered that this request be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
