P.G. requests that her applications for the 2023 Law Enforcement Examination be processed.<sup>1</sup>

By way of background, titles that were included in the 2023 Law Enforcement Examination (LEE) testing cycle<sup>2</sup> were announced separately by jurisdiction. Thus, candidates were required to file separate applications to indicate their interest in an announcement for a particular jurisdiction and title.<sup>3</sup> It is noted that the subject announcements were issued on March 1, 2023 with a March 31, 2023 closing date and all applications had to have been received by 4:00 p.m. on that date. A review of

the record finds that the petitioner filed three applications. During the application filing process, the petitioner requested an exemption of the application processing fee, see N.J.A.C. 4A:4-2.17(a)2, for each application pursuant to N.J.A.C. 4A:4-2.17(d). A review of the record finds that the petitioner submitted a copy of a New Jersey Department of Human Services Health Benefits Identification Card in her name with her applications. The Division of Agency Services was contacted regarding this matter and indicated that Health Benefits Identification Cards are not accepted but rather, applicants must submit a copy of their award letter for the current year with their applications, pursuant to N.J.A.C. 4A:4-2.17(d). Subsequently, by notice dated March 24, 2023, the petitioner was informed that she "failed to submit the required application processing fee as previously required. Your application will not be processed further."

On appeal, the petitioner argues that she received a notice "stating that I did not submit payment but I sent a copy of my Medicaid card."<sup>4</sup> In support of her appeal, she provides a copy of a letter dated March 27, 2023 addressed to the petitioner for the benefit of her **dependent** indicating her Supplemental Security Income (S.S.I.) payment information and a copy of a New Jersey Supplemental Nutrition Assistance Program (SNAP) Request for Verification form dated March 21, 2023 which indicates, "in order to receive assistance, the information checked above must be provided . . . If you cannot provide the information by 03/31/2023 or if you need help in providing the information, contact . . ."

## CONCLUSION

*N.J.A.C.* 4A:4-2.17(d) provides that an applicant for an open competitive examination will be granted a waiver of the fee if the applicant provides documentation showing that, as of the closing date, he or she is receiving General Assistance benefits, benefits under the Work First New Jersey Act or Supplemental Security Income. Proof must consist of one of the following:

- 1. General Assistance -- a copy of the applicant's benefits identification card (if one was issued) or a letter from the applicant's local municipal welfare director.
- 2. Work First New Jersey Act -- a copy of the applicant's Families First card.
- 3. Supplemental Security Income -- a copy of the **applicant's** latest annual award letter or proof of the applicant's Medicaid identification number for S.S.I. benefits (emphasis added).

It is noted that the Division of Agency Services, pursuant to N.J.A.C. 4A:4-2.17(d)3, will accept an S.S.I. award letter only if the applicant requesting a waiver and the recipient of the benefit are the same individual. In addition, while the petitioner, on appeal, and despite being provided ample opportunity, has provided a copy of a letter requesting information in order for her to qualify for SNAP benefits, she does not provide evidence showing that she received SNAP benefits or that **she** had been awarded S.S.I. as of the March 31, 2023 closing date, pursuant to *N.J.A.C.* 4A:4-2.17(d).

## ORDER

Therefore, it is ordered that this request be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
