In the Matter of Marco Rovelo, Police Captain, North Bergen	: FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION
CSC Docket No. 2023-1864	Administrative Appeal

North Bergen, represented by Drew D. Krause, Esq., requests that the Civil Service Commission (Commission), acknowledge a settlement agreement which provides for the retroactive appointment of Marco Rovelo to Police Captain.

By way of background, the eligible list for Police Captain (PM1311T), North Bergen, which promulgated on April 21, 2016 and expired on April 20, 2020, contained the names of four eligibles, in the following order: Marco Rovelo, Timothy Faranda, Thomas Ferrari and Christine Klag. The first and only certification of the PM1311T eligible list was issued on November 15, 2016 (Certification No. PL161353) on which Rovelo appeared at the second certification position.<sup>1</sup> In disposing of Certification No. PL161353, North Bergen appointed the eligible appearing at the first certification position effective December 12, 2016. However, in September 2019, Rovelo initiated an action in the Superior Court of New Jersey, Law Division, against the appointing authority. Subsequently, Rovelo and the appointing authority entered into a settlement which provides that "contingent upon revival of the [PM1311T] List by the Commission . . . the Township shall promote Rovelo to the rank of Police Said promotion shall take place within 7 days of the latter of the Captain. Commission reviving the [PM1311T] List and issuing any necessary certification to enable said promotion . . ." The terms of the settlement also provide that Rovelo will

receive a retroactive appointment date one year prior to the date he is promoted.<sup>2</sup> Further, the settlement provides that Rovelo "will be paid for the collective negotiated salary differential between the rank of Lieutenant and Captain for the one year immediately prior to his promotion."

## CONCLUSION

N.J.S.A. 11A:4-6 and N.J.A.C. 4A:4-3.4 provide that an eligible list may be revived in order to implement a court order or decision of the Commission in the event of a successful appeal instituted during the life of a list, to correct an administrative error, or for other good cause. Additionally, N.J.A.C. 4A:4-1.10(c) states that an individual may receive a retroactive date of appointment to correct an administrative error, for administrative delay or for other good cause. Moreover, the policy of the judicial system strongly favors settlement. See Nolan v. Lee Ho, 120 N.J. 465 (1990); Honeywell v. Bubb, 130 N.J. Super. 130 (App. Div. 1974); Jannarone v. W.T. Co., 65 N.J. Super. 472 (App. Div. 1961), cert. denied, 35 N.J. 61 (1961). This policy is equally applicable in the administrative area. A settlement will be set aside only where there is fraud or other compelling circumstances. See Nolan, supra.

In the present matter, the appointing authority submits a copy of the Stipulation of Dismissal Without Prejudice dated February 3, 2023, which acknowledges a settlement agreement between the parties. As the settlement agreement does not violate any Civil Service law or rules, the Commission finds a sufficient basis to acknowledge the settlement agreement between the parties. Moreover, good cause exists to revive the Police Captain (PM1311T), North Bergen eligible list and to appoint Rovelo with a retroactive appointment date effective one year prior to his regular appointment date for seniority purposes only.

## ORDER

Therefore, the Commission acknowledges the settlement agreement between the parties and orders that the Police Captain (PM1311T), North Bergen, eligible list be revived to provide Marco Rovelo with a regular appointment to the Police Captain title with a retroactive appointment date of one year prior to his regular appointment date.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
