Examination Appeal

**ISSUED:** December 17, 2025 (HS)

Alexandre Gabler appeals the determination of the Division of Agency Services (Agency Services), which found that he was not eligible for the promotional examination for Manager 1 Information Processing (PS2255H), Department of Health, because he was not employed in the announced unit scope.

The PS2255H examination was announced with requirements that had to be met as of the September 22, 2025 closing date and was open to unit scope H200 (Administration and Operations). The appellant was found ineligible by Agency Services as he was employed in unit scope H365 (Greystone Park Psychiatric Hospital). The only other applicants for this examination are individuals N.S. and J.S.

On appeal to the Civil Service Commission (Commission), the appellant states his “understanding” that one P.D.<sup>1</sup> also applied for this examination. The appellant claims that P.D. improperly moved from unit scope H365 to H200 in first quarter 2025. The appellant complains that he was never given the opportunity to move unit scopes. He states that he held seniority in title at both Greystone Park Psychiatric Hospital and the Department of Health as a Supervisor Information Technology because he is a veteran. The appellant proposes that either he should be admitted to the PS2255H examination or P.D. should also be deemed ineligible.

## CONCLUSION

*N.J.A.C.* 4A:4-2.6(a)2 provides, in pertinent part, that applicants for promotional examinations shall be currently serving in the announced unit scope by the announced closing date.


Agency Services correctly determined that the appellant was not eligible for the PS2255H promotional examination. The promotional announcement clearly indicated that it was open to employees serving in unit scope H200, and the appellant is serving in unit scope H365. P.D. is not among the applicants for this examination.

## ORDER

Therefore, it is ordered that this appeal be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
