A regular meeting of the Merit System Board was held on Wednesday, May 4, 2005, in Trenton, New Jersey.

**SUBJECT:** Change in the State Classification Plan

**DEPARTMENT OF HEALTH AND SENIOR SERVICES**

The Department of Health and Senior Services requests a two-range upward change in class code for the title of Supervising Health Care Evaluator.

The title is currently evaluated at a range 25, but is compensated at a 27 because it is part of the group of nursing titles that received raises unlinked to class code in 1990. The title required a license as a Registered Nurse at that time, because the scope of responsibility was limited to the evaluation of health care facilities. The license requirement was removed in 2000, and the scope of responsibility was expanded to include the review of health care plans and health care organizations, expanding the scope of eligibility beyond registered nurses. The changes at that time were necessary to acknowledge changes in health care needs and trends, and expand use into different divisions.

The Compensation Compendium indicates that incumbents in titles in the nursing group must possess licenses as nurses to be eligible for the special incentive salary program. This title no longer fits the criteria for inclusion in this group, and should be removed from the special incentive salary program. The Department of Health and Senior Services requests that the experience requirements be increased to reflect the broadening of responsibilities and, that the class code be raised from 25 to 27. There is no cost impact.

This action has the consent of the Office of Employee Relations and the appropriate negotiations representatives.
