HAMILTON TOWNSHIP FIRE DISTRICT NO. 7 AND JASON BERGSTROM V. HAMILTON TOWNSHIP FIRE DISTRICT NO. 7, CSC DOCKET NO. 2012-780; PEOSH NO. C65-01-140; LWD DOCKET NO. D-65-03-139; OAL DOCKET NOS. CSV 11240-11, OSH 15289-12 AND LID 11629-12**

Administrative Law Judge (ALJ) Edward J. Delanoy issued an Order of Consolidation and Predominant Interest in *In the Matter of Jason Bergstrom and the Public Employees Occupational Safety and Health Review Commission and the Department of Labor and Workforce Development v. Hamilton Township Fire District No. 7 and Jason Bergstrom v. Hamilton Township Fire District No. 7*. Based on the ALJ's Order, the Civil Service Commission and the Public Employment Relations Commission developed a Joint Order. The proposed Order is now submitted for the Commission's adoption.
