SECTION B – MISCELLANEOUS MATTERS**B-30 B.N. – CSC DOCKET NO. 2017-1541**

B.N., represented by Anthony J. Chirles, Esq., appeals his rejection as a Fire Fighter candidate by the City of Elizabeth and its request to remove his name from the eligible list for Fire Fighter (M1518T) on the basis of psychological unfitness to perform effectively the duties of the position.

The Borough of Stanhope, represented by Deborah J. Bracaglia, Esq., petitions the Civil Service Commission for a stay of the final decision rendered on March 22, 2017, which ordered Stanhope to pay Fortunato Montella \$34,862.21 in gross back pay and \$2,825.82 to maintain his health benefits, pending the outcome of its appeal to the Superior Court, Appellate Division.

In In the Matter of Records Support Technician 2 (M0157S), East Orange (CSC, decided October 19, 2016), the Civil Service Commission (Commission) held in abeyance East Orange's request for waiver of the appointment requirement pending the determination of the Division of Agency Services (Agency Services) regarding India Cole's position. Agency Services determined that based on a classification review of Cole's position, that she was to be considered serving provisionally, pending promotional examination procedures, in the title of Records Support Technician 2, effective December 8, 2017, and the matter is now being presented to the Commission.
