TRENTON - As part of its commitment toward ensuring a more diverse civil service workforce, the New Jersey Civil Service Commission (CSC) will host a Virtual Diversity in Law Enforcement Forum on Thursday, October 22, 2020, from 9:30 a.m. to 12:00 p.m.

This Forum is part of an ongoing effort by the Civil Service Commission to promote diversity and inclusion within State and Local government. The free event will offer insight on how to apply for the law enforcement exam, and is the ideal opportunity, for diverse candidates seeking to enter the Law Enforcement field, to meet with CSC staff to ask questions related to the application and testing process, as well as hearing from CSC's partners on the importance of diversity in Law Enforcement.
