Proposed movement of local government titles from the 'competitive' to 'noncompetitive' class of service

The New Jersey Civil Service Commission continues to evaluate titles that are appropriate for reallocation from the competitive to the noncompetitive class of service. These actions will provide local agencies with the flexibility and timeliness needed to meet their staffing needs.

The CSC plans to reallocate the titles listed below from the Competitive to the Noncompetitive class of service. These titles have been identified for reallocation based on the criteria defined in N.J.A.C. 4A:3-1.2.

Competitive testing is not practicable due to the knowledge, skills, and abilities associated with the job, and it has not been demonstrated that the competitive testing process has met the needs of appointing authorities.
