Request for Proposal No. 12-30-2014

NEW JERSEY HISTORIC TRUST

Heritage Tourism Theme Development

Created by statute in 1967, the New Jersey Historic Trust is an agency affiliated with the Department of Community Affairs whose primary mission is to provide funding to nonprofit organizations and entities of government for the restoration and rehabilitation of historic property. The Trust also administers the Discover New Jersey History License Plate grant program to support the development of heritage tourism. Heritage Tourism is defined by the National Trust as traveling to experience the places and activities that authentically represent the stories and people of the past. It includes historic, cultural and natural resources. A recent study by Tourism Economic found that heritage tourism comprised 8% of the state's total revenue generated through tourism. The nearly 11 million visits created \$2.6 billion in GDP and a total of \$335M in state and local taxes. Given this huge return on investment, the Trust is seeking proposals from qualified consultants to develop a web presence for heritage tourism and to create tourism products that will facilitate our efforts to promote the state's history.

BACKGROUND

In 2010, New Jersey unveiled a heritage tourism master plan to guide the development, marketing and promotion for heritage tourism statewide. The entire plan and all of its appendices can be found: http://www.njht.org/dca/njht/touring/plan/index.html

As a component of the plan, an historical narrative — The Contours of New Jersey History: An Essay on Context for the Heritage Tourism Master Plan - was prepared identifying six major themes from which to organize tourism efforts. The themes were to be used in historic site interpretation, heritage education curriculum and tourism promotion. The six themes are:

New Jersey in Conflict New Jersey at Work New Jersey Land and Sea New Jersey at Play Many Faces of New Jersey New Jersey by Design

The Trust has preliminarily identified 46 sites (attached) whose significance falls within the theme of New Jersey in Conflict. The selected sites appear to be open to the public either on a regular or intermittent basis, but may or may not minimally meet the visitor ready criteria as outlined in the State Heritage Tourism Master Plan. The Trust desires to bring representatives from these sites together to explore ways to interpretively link these sites for the purposes of marketing and promotion. Under separate contract, the Trust will be designing a theme based heritage tourism web site that should become the primary source for heritage tourism travel opportunities in New Jersey.

Theme Development – NJ in Conflict

The NJ Historic Trust is seeking a proposal from a consultant team to develop theme based content for a web site to support heritage tourism development and promotion for the first of six identified themes, New Jersey in Conflict.

TASKS

Consultant shall develop a <u>survey</u> of theme related sites that minimally meet visitor ready criteria to determine what types of programming is currently being offered and identify opportunities for further development.

In cooperation with NJHT, consultant shall organize and invite representatives from a minimum of 20 organizations to attend a one day facilitated <u>workshop</u> to identify potential marketing linkages, based on theme, locations and visitor readiness and to promote coordination among the sites. (NJHT will distribute invitations, reserve facility and arrange for refreshments.) Participants should also include representatives from the tourism community. Consultant shall prepare a summary report for distribution from this workshop with emphasis on recommendations for next steps.

Consultant shall develop a <u>context narrative</u> of 9-10 pages in length to support NJ in Conflict, justifying the pivotal role New Jersey played in the formation of the nation and describing the military tradition that continued into the 20th century. The narrative shall identify the likely sub-themes to be further developed on the tourism website. The development of sub-themes for heritage tourism purposes should incorporate both historical chronology and regional flexibility. (Note: The remaining five themes are not part of this work effort and will be bid under separate contract at some time in the future.)

While the context narrative should be written in a more scholarly manner, complete with footnotes and references cited, consultant shall synthesize this narrative into a <u>shorter</u>, <u>engaging summation</u> suitable for general audiences to be used as <u>content</u> for the web site.

The Historic Trust has preliminarily identified two sub-themes having a higher number of visitor ready sites that are ready to be promoted. Consultant shall develop the <u>content and web presence for the following two sub-themes</u>, but not limited to those sites listed below:

- Revolutionary War highlighting the battlefields and places where strategic activities and events occurred; consultant shall also connect and incorporate the Crossroads of the American Revolution Heritage Area
- 20th century defense highlighting sites such as the Naval Air Station Wildwood, Battleship NJ,
 Camp Evans, Fort Hancock, Fort Mott and the Fire Control Tower #23

QUALIFICATIONS & PROPOSAL SUBMISSION

The Historic Trust seeks a consultant team with five years of demonstrated expertise in historic site interpretation, programming and historical content development, with knowledge of web site design. The proposal should include methodology for completion of this scope of work, a proposed schedule noting milestones, samples of completed heritage tourism products, examples of content material to illustrate writing style, a writing sample, and other promotional material relevant to this REQUEST.

In addition to client list and references, the proposal should also include resumes for the individuals that would be principally involved in executing this project.

The project cost proposal should be itemized by the tasks outlined above. Any anticipated travel and/or reimbursable expenses should also be itemized. The Historic Trust estimates these services to cost between \$25,000 and \$35,000, inclusive of expenses.
