He stated that the Committee believes the language should stay in line with the definition. Department staff explained that they would clarify this item further but recommended the language remain to remove the possibility of buildings being reclassified into high-rise structures due to the occupancy of roofs that already exist, to which Art Londensky agreed. No additional comment was reported by other Board members or the Committees.

c. Supplemental Review/Information 2024 IBC – N.J.A.C. 5:23-3.14

Rob Austin questioned if the Board had any comment on this item. Michelle Wood noted that the Building Subcommittee recommends not adopting the provisions requiring guards on retaining walls and stated that this item should remain with municipal engineers. No additional comment was reported by other Board members or the Committees.

d. One- and Two-Family Dwelling Subcode (IRC/2024) – N.J.A.C. 5:23-3.21 Rob Austin reviewed this item and highlighted the major changes. Art Londensky noted that it is the opinion of the Fire Protection Subcommittee to maintain the requirements of door self-closing devices due to safety concerns. Board members further discussed concerns regarding self-closing devices on energy storage system rooms, shared accessory rooms, and garages. Safety, cost, and inspection issues were highlighted as the predominant factors in this discussion.

Additionally, Art Londensky noted his opposition to the removal of the automatic sprinkler requirements for one- and two-family dwellings.

Art Londensky made a motion, which was seconded by Michelle Wood to maintain the requirement for self-closing devices on shared accessory room doors. The motion carried unanimously.

  - Tony Neibert, in reference to pending legislation A4360/S3402 (self-certification), noted that legislators do not consult with the Code Advisory Board on matters that concern the Uniform Construction Code. He explained that this causes significant problems because stakeholders are not being involved in discussions. He and various members of the Board noted their strong disagreement for the proposed legislation concerning self-certification of certain construction projects by approved architects.

# F. Public Comments

- Bob LaCosta agreed with the sentiment of Board members concerning A4360/S3402 (self-certification). He stated the proposed legislation dilutes the provisions of the Uniform Construction Code.

- John Drucker objected to the proposed legislation, A4360/S3402 (self-certification). He noted his work in New York City when they passed similar legislation and explained the significant problems and inspection failures of self-certified buildings following the implementation of self-certification. He stated that accelerating the electronic permitting process and solving the licensing board issues concerning raised seals would be far more beneficial than implementation of the self-certification.
- Brian Miller, Chairman of the Municipal Construction Officials of New Jersey, noted his organization's objection to the proposed self-certification legislation. He stated a letter has been sent to the Governor detailing the organizations issues, such as, circumvention of stakeholder input, conflict of interests, and lack of oversight.
- John Fiedler noted that the proposed self-certification legislation is a foot in the door of what's to come and will lead to a deterioration of the Unform Construction Code.
- Dennis Butler agrees with the Code Advisory Board's comments regarding the self-certification legislation.

## **D. New Business**

1. Draft Rule – Responsibilities, Fuel Gas Subcode and Rehabilitation Subcode, cleanup – N.J.A.C. 5:23-3.4, 3.22 and 6.8

Ms. Marie Daniels introduced this item, which amends the UCC for various changes. Specifically, the proposal clarifies the application of N.J.A.C. 5:23-3.4, Responsibilities. In addition, this proposal amends the fuel gas subcode, N.J.A.C. 5:23-3.22, to delete sections related to liquefied petroleum gas motor vehicle fuel dispensing facilities, as these facilities are outside the jurisdiction of the UCC. Lastly, the proposal will amend N.J.A.C. 5:23-6.8 of the Rehabilitation subcode to reflect proper terminology for swimming pool, spa, and hot tub barriers, as well as setting forth the requirements for completely replaced and newly installed swimming pools, spas, and hot tubs.

Mr. Bob Mellohusky noted a typo regarding roman numeral ordering within N.J.A.C. 5:23-3.22(b)4 and recommended amendment to fix the error.

Mr. Art Londensky made a motion, which was seconded by Ms. Michelle Wood to approve the proposal as amended. The motion carried unanimously.

2. Draft Rule – Park Model Subcode, updated standard – N.J.A.C. 5:23-4D.3

Mr. Rob Austin introduced this proposal concerning subchapter N.J.A.C. 5:23-4D of the Uniform Construction Code, which governs the design, manufacture, and installation of recreational park trailers. This proposal would update the UCC from the ANSI 2015 A119.5 Standard for Park Model Recreational Vehicles to the 2020 edition. The updated standard would incorporate minor technical changes, such as roof extension of vent termination at 1 inch instead of 2 inches and increased non-permanent propane capacity. Mr. Rob Austin noted that these updates largely concern seasonal aspects of these structures.

Mr. Tony Neibert requested additional clarification on the seasonal aspect of these changes

Mr. Art Londensky made a motion, which was seconded by Ms. Michelle Wood to approve the proposal. The motion carried unanimously.

3. Form F-100 – Emergency Responder Communication Systems

Mr. Rob Austin introduced this item, which adds check box 13 to Form F-100 for confirmation of emergency responder communication systems. This addition was brought about by the 2018 International Building Code and adopted as the Building Subcode at N.J.A.C. 5:23-3.14. Section 918 of the International Building Code requires that emergency responder radio coverage be provided in all new buildings.

Mr. Art Londensky provided additional clarification on this item before proposing to approve.

Mr. Art Londensky made a motion, which was seconded by Ms. Valerie Waricka to approve the form. The motion carried unanimously.

Ms. Michelle Wood made a motion, which was seconded by Mr. Art Londensky, to approve the minutes. The motion carried unanimously.

# C. Old Business

1. Draft Rule, Supplemental Private On-Site Inspection Agencies P.L.2022, c.139 – N.J.A.C. 5:23-2 and 4 Revisions.

Ms. Marie Daniels introduced this item for further discussion. In the previous Code Advisory Board meeting, the proposal was given to the Subcode Committees for review and comment. The Barrier Free Subcode Committee stated that rule does not address low staffing issues in municipal construction offices and that the additional paperwork will make the burden on those offices worse. The Building Subcode Committee stated that the rule raises concerns of unfamiliar inspectors performing work, does not adequately establish reimbursement stipulations, and questioned the exemption of Department of Community Affairs local municipalities from the rules. Additionally, the Committee noted that these rules will only help a small number of larger developers and would lead to an exodus of inspectors from municipalities to private supplemental inspection agencies. The Electrical Subcode Committee stated that the root cause for missed inspection deadlines is the inability for municipalities to follow UCC guidelines concerning the allocation of construction office generated income. The Elevator Subcode Committee noted that the rules will make retaining qualified inspectors more difficult and that there are considerable fee structure issues that are not addressed. The Fire Protection Subcode Committee agreed with many of the same comments and voted to change the minor work requirement from 30 to 15 days. The Mechanical Energy Subcode Committee agreed with the other committee comments and stated that municipalities should be able to set guidelines when signing a Certificate of Occupancy for a supplemental private inspection. The Plumbing Subcode Committee noted they had similar concerns as the other committees, they also questioned how to properly value an inspection and if there is an incentive for the private inspection agency to fail an inspection. In addition, they proposed changing minor work requirements from 30 days to 10 days.

Further discussion centered predominately on the financial issues surrounding the proposed rules, such as fees and reimbursement. Many board members stated that language on fees and reimbursement needs extensive work. Mr. Art Londensky noted that this will possibly change the revenue stream for municipalities, and they may in turn need to raise fees. Mr. Tony Neibert noted the UCC regulation (N.J.A.C. 5:23-4.17(c)2) concerning revenue generated from inspections is required to fund the construction office and many municipalities are using this revenue for other purposes. Ms. Michelle Wood stated that a dedication by rider pursuant to the requirements of the Uniform Construction Code is necessary. Board members stated that if all municipalities were required to comply with 5:23-4.17(c)2 and utilize a dedication by rider, there would be no issues in ensuring timely inspections.

Board members also expressed concern with the requirement to allow the owner to choose between the municipality or the private on-site inspection agency for the remainder of the project after the first missed inspection and felt that this could lead to a situation where municipalities must reimburse entire projects even if they would have been able to perform all other inspections on time but faced one unexpected delay. The Board requested that language be added to ensure that after a missed inspection, the project first goes back to the municipality.

Ms. Michelle Wood made a motion, which was seconded by Mr. Tony Neibert to deny the proposal until rewritten. The motion carried 11 in favor, 1 opposed.

# 2. Bulletin 13-1A – Elevating Existing Homes – Revision

Ms. Michelle Wood stated that the Building Subcode Committee approves the bulletin as written. Mr. Greg Moten noted that he approved the bulletin, however, the companion text in the regulations does not define, "addition." Ms. Marie Daniels noted that this can changed after review.

Mr. Art Londensky made a motion, which was seconded by Mr. Greg Motel to approve the bulletin. The motion carried unanimously.

# 3. Electronic permitting – N.J.A.C. 5:23-2.15, 2.15A, 2.15B, 4.5, 4.12, 4.14, and 4.22

The Board noted that every committee is in favor of the draft rules. Ms. Michelle Wood questioned if end user training can be provided and if there will be a surcharge fee for the use of credit cards on the electronic permitting portal. Mr. Anthony Menafro requested and was granted approval to share the draft rules with the various licensing boards. Mr. Bob Mellohusky agrees with the convenience of the electronic system but does not believe there should be a surcharge. Ms. Valerie Waricka questioned if municipalities will have to remit to the Department if they use their own software, Ms. Marie Daniels stated that she will look this up and confirm. In addition, Ms. Michelle Wood and Ms. Valerie Waricka noted spelling errors in the draft rules on page 8 and 12.

Further discussion centered on security of the electronic seal. Ms. Beth Pochtar sated that they need a list of trustworthy third party programs/companies to lock plans and seals.

Ms. Valerie Waricka made a motion, which was seconded by Mr. Art Londensky to approve the proposal with suggested changes. The motion carried unanimously.

# **D. New Business**

1. Draft Rule, Responsibilities Correction – N.J.A.C. 5:23-3.4

Ms. Marie Daniels introduced this item, which amends the UCC to consolidate inspection responsibilities. Specifically, the proposal allows for an electrical inspector to check if solar panel roof pathways are appropriately sized based on the approved locations via the plan review. In addition, this proposal amends two sections that refer to the National Electrical Code, which fall into differing responsibilities. The proposal will add electrical to the responsibility to align both of these sections.

Mr. Tony Neibert made a motion, which was seconded by Mr. Art Londensky to approve the proposal. The motion carried unanimously.

## 2. Draft Rule, IBC and IRC Corrections – N.J.A.C. 5:23-3.14 and 3.2

Ms. Marie Daniels introduced this proposal that concerns window well and foundation drains in the UCC. The proposal correlates similar provisions in the International Residential Code/International Building Code, as the foundation drain may relate to a potential installation of a window well and the applicable sections of the National Standard Plumbing Code.

Jenn Newton, on the proposed Private Supplemental Inspection rules, asked if the municipality is capable of performing an inspection in a timely manner, would they be able to deny the private inspection agency. Additionally, they asked if this was only at the time of submission of planning documents or at any point of the process. Ms. Marie Daniels confirmed that the municipality can deny the private supplemental inspection agency and that the applicant can only request for a private on-site inspection agency to perform inspections for the entire project during the planning stages of the project.

Daniel O'Gorman, on the proposed Private Supplemental Inspection rules, noted that the rules would be a positive change, as salaries and local staffing would increase.

Ken Rogers, on the proposed Private Supplemental Inspection rules, noted their agreement with the Board's comments. Additionally, they asked if the developer were to use a private supplemental inspection agency due to a municipality missing the inspection deadline, would the private agency be able to take up inspection responsibility for the entire project. Ms. Marie Daniels responded that it would depend on the contractor. Mr. Ken Rogers suggested that the rules should be amended to bar the private supplemental inspection agency from receiving the entire project. Lastly, Mr. Rogers noted that the central issue is the lack of enforcement of N.J.A.C. 5:23-4.17(c) and that municipalities are resistant to change as they will lose a source of additional funding for other offices by following the regulation.

1. Supplemental Private Inspection Agencies P.L.2022, c.139 – N.J.A.C. 5:23-2 and 4 Revisions Ms. Marie Daniels introduced this item to the Board, which is a draft rule to incorporate the provisions of P.L.2022, c.139, into the UCC. This draft rule will permit supplemental private inspection agencies to provide inspections in municipalities that are late on inspection deadlines on construction projects.

The discussion centered around questions and comments over potential issues with the implementation of the law and the proposal. The issues posed by the Board largely concerned the refunding of fees for missed inspections and the potential for conflicts of interests caused by the ability for developers to choose their own inspection agencies. Additionally, there was concern among the Board members that this law may negatively impact municipal construction offices and impact their ability to hire experienced construction officials. The Board decided to send this item to all Subcommittees to review the proposal and report their comments.

# 2. Bulletin 13-1A – Elevating Existing Homes – Revision

Ms. Marie Daniels introduced this item to explain a revision to Bulletin 13-1A, Elevating Existing Homes, to further define that the connection between the foundation and the existing home are to meet addition standards in the new code, the revision also included changes in terminology in the "Wind Load" section. One member noted that the Uniform Construction Code should include companion language changes to clarify that it is applicable to additions as well as new construction. The Board determined that further review is needed, and the Building Subcode Committee would review and report their comments.

3. Electronic permitting – N.J.A.C. 5:23-2.15, 2.15A, 2.15B, 4.5, 4.12, 4.14, and 4.22 Ms. Marie Daniels introduced this item and explained that this is a draft rule to amend the UCC and incorporate the requirements of P.L.2021, c.70, which requires all municipalities in the State have the ability to accept construction permits electronically. Mr. Tony Neibert explained that hazardous locations are a defined term which largely entails industrial locations such as petrochemical and manufacturing plants, but also includers some areas in gas stations.

The Board indicated that this change seemed positive and noted the importance of outreach and communications to ensure that all impacted are aware of the change. The Department agreed that, upon the adoption of any change, a *Construction Code Communicator* article would be published.

Mr. Art Londensky made a motion, which was seconded by Mr. Tony Neibert, to approve the draft rule. The motion carried unanimously.

3. NJ DEP Energy Efficiency Upgrades – Guidance Bulletin for Final Inspection – N.J.A.C. 5:23-2.18 for UCC related items

Mr. Robert Austin introduced this item and explained that there is a new Appliance Standards Law P.L.2021, c.464, that establishes minimum efficiency standards for a number of appliances; largely, this law falls under the purview of the Department of Environmental Protection (DEP). The law also states that any items that fall under UCC jurisdiction for inspection, code officials will have to see proof that the appliance complies with the increased energy efficiency standard. The draft rule change and Bulletin are still in early stages; because DEP is authorized to adopt regulations pursuant to this Law, the Department will not be moving forward with any rule changes to the UCC until DEP undertakes its rulemaking process. However, the Department wanted to seek the Board's thoughts and opinions to ensure that it is able to move forward when the time comes. Mr. Austin noted a number of changes he had incorporated into the Bulletin between the time the draft was first shared with the Board and today's meeting.

Board members noted challenges with the language of the law, including that the UCC inspection cited is the final inspection; ensuring appliances are compliant during plan review or rough inspections would be an easier and more cost-effective time to catch any noncompliance, especially since there are times where the appliance is not fully accessible at a final inspection. Further, to find a non-compliant appliance CAB MINUTES December 9, 2022

during a final inspection could be very costly to the owner to replace a newly installed non-compliant appliance with one that meets the requirements of the law.

Board members also noted the tremendous financial burden this Law could impose on a number of small businesses, especially restaurants, because it does not allow for resale of refurbished appliances that do not meet the new Law. In many cases, restaurant owners seek to replace broken commercial fryers with refurbished fryers to save money; this Law prohibits that practice.

In reference to the first point, the Board again discussed potential ways to ensure appliances were compliant with the new law before final inspections. This may include ensuring permit applicants are aware of the law at the time of application and engagement with design professionals during the plan review process, though it was understood that referencing non-compliant appliances in a plan would not be grounds for denial; instead, there must be cooperation to remedy issues before they are found upon final inspection. Further, Board members discussed whether paperwork or manuals for an appliance could be used if the equipment labels were not easily accessible at a final inspection. Board members expressed frustration over the practicality of implementation.

Department staff asked the Board if they would like to table this matter until such time as DEP has further guidance or regulations. One Board member noted that, because this is a law, even if it is tabled, it will still need to be addressed later.

Mr. Art Londensky made a motion, which was seconded by Mr. Greg Moten, to approve the draft rule and Bulletin with the amendments noted by Mr. Austin. The motion carried with 10 in favor and 1 opposed. The Board Members noted that, although they have voted to approve the Draft Rule and Bulletin, they only did so in recognition that this is a new Law, thus its requirements supersede the concerns noted during discussion.

Mr. Bob Mellohusky made a motion, which was seconded by Mr. Art Londensky, to adjourn the meeting. The motion carried unanimously. The meeting was adjourned at 10:30 a.m.

## **D. New Business**

1. Building Subcode and Electrical Subcode update – Special Inspections and Informational Notes; N.J.A.C. 5:23-2.20, 3.14 and 3.16 – Draft Rule

Mr. Robert Austin introduced this item, along with Bulletin 03-5 and explained that since 2000, there has not been an overhaul and update. Multiple deficiencies were found in the building subcode regarding the improper use of building official and construction official and this draft rule is proposed to ensure consistency of the subcode with the UCC. This will also apply to 5:23-2.20 of the UCC because of the lack of inclusion regarding special inspections, as specificity and format correction were needed to the reference of mass timber elements for IV-A, IV-B, and IV-C construction.

Additionally, in 5:23-3.14, changes to the electrical subcode informational notes are proposed, Mr. Robert Austin referenced a bulletin that showed which informational notes are enforceable. The Electrical Subcode Committee looked carefully into those Informational Notes, and Mr. Robert Austin stated that when the notes first began, the Department adopted them as a Formal Technical Opinion, and over time, the requirements included in the Fine Print Notes (now Informational Notes) were then brought into the model code editions. The NEC itself also says that Informational Notes are not enforceable. The Department would like to come in line with the NEC and wants the bulletin revised to state that the Informational Notes are purely information, rather than regulatory. The Department would also like to amend the text of the electrical subcode as well to reference this.

Mr. Greg Moten noted in regard to special inspections within Chapter 17, "registered design professional" does not line up with the language of the current edition of the subcode and should be amended to state "person in responsible charge."

Ms. Michelle Wood made a motion, which was seconded by Mr. Greg Moten, to approve the draft rule as amended by discussion

Mr. Robert Austin then stated that the related Bulletin 03-5, concerning special inspections will also be amended to incorporate the new special inspection requirements and updated links. This amendment also removed the table from the code to aid in clarity and adds three examples to help differentiate and explain the applicability of the Bulletin.

Ms. Michelle Wood made a motion, which was seconded by Mr. Greg Moten, to approve the related Bulletin 03-5 as written. The motion carried unanimously.

# 2. Additional Bulletin Updates

-Bulletin 19-2, Energy Subcode compliance (currently Bulletin 22-1 and includes Form F392)-

Mr. Robert Austin introduced this item that proposes a small update to show that the ASCE has a link to the aforementioned updates related to Bulletin 03-5 and Bulletin 22-1, which is the current updated version of this Bulletin. He notes that the residential table is edited for clarity and updated with the new numbers and presented differently to be more user friendly. Additionally, energy efficiency package information, inspection for envelope tightness, and a revised air barrier insulation checklist are included.

Ms. Beth Pochtar commented that on page 5, in the section referencing duct pipes, that she believed the Department did not require the leakage requirement as it was voted down. However, she was informed that the Code Advisory Board did vote it down, but the Commissioner overruled this vote to align with the Energy Master Plan.

The Committee discussed this Bulletin and stated that they would like to refer it to the Building and the Mechanical/Energy Subcode Committees for discussion and clarity.

## -Bulletin 19-3, Informational Notes-

Mr. Robert Austin introduced a proposed update to Bulletin 19-3 that would explain how informational notes are background information and not enforceable. The update would state that if the Informational Notes need to be applied, then Article 695 within the NEC would explain what sections of NFPA would apply.

Ms. Michelle Wood made a motion, which was seconded by Mr. Art Londensky, to approve the related Bulletin 19-3 as written. The motion carried unanimously.

# -Bulletin 19.1, Design loads

Mr. Robert Austin introduced a proposed update to Bulletin 19-3 to include a reference to direct users to ASCE provisions for design loads regarding snow on roofs.

Ms. Beth Pochtar questioned whether other counties need to send case studies as only counties we encountered were included, and if the Department will update if additional case studies are completed or if to include Bulletin 94-8. Mr. Robert Austin commented that the update was done to direct users to the appropriate sources, but the Department will include information in the Fall Construction Code Communicator detailing the updated bulletins and to inform the Department if there is an applicable case study for their area. Ms. Beth Pochtar stated that this would be very helpful.

Ms. Michelle Wood made a motion, which was seconded by Mr. Art Lodensky, to approve the related Bulletin 19-1 as written. The motion carried unanimously.

#### E. Information

Mr. Robert Austin took a moment to wish Mr. Tom Pitcherello, plumbing subcode official, well in his retirement after serving the Department for 23 years. The Committee took this time to congratulate Mr. Pitcherello and thank him for his service to the Department.

## F. Public Comments

Mr. Alex Palmer, Sustainable South Jersey, commented that he had solar panels installed on his roof. However, the plumbing the on roof interfered with the placement of the panels. He noted that recently, the International Plumbing Code (IPC) was revised to allow installation of solar panels over roof plumbing. He was aware of the recent discussion on past Committee meetings concerning switching to IPC versus the National Standard Plumbing Code (NSPC) and that the State went with NSPC. He believes that the NSPC does not accommodate installation of solar panels in the same fashion as the IPC and that adoption of the IPC would encourage more solar installations.

Mr. Robert Austin stated that they spoke on the phone and explained that Appendix E has the design portion for NSPC, which could permit solar panels over plumbing vents. The solar panels must be listed and labeled to be applicable for this installation. Certain manufactured items do allow for solar panels over vents and there are systems that have been developed to accommodate solar panels where roof vents are present. If necessary, a Construction Code Communicator article based on this information to help guide users to the appropriate resources will be published.

Ms. Beth Pochtar questioned the accuracy that it allows solar panels on top of vents.

Mr. Tom Polino, who sits on standard Committees explained that solar panels were never allowed on top vents.

Mr. Tom Pitcherello commented that one of the problems in many solar panel designs is that the clearance is not determined until after installation and further review of codes and Committee discussions may be necessary.

Mr. Austin noted that the draft rule states "contractor," but the Department will be revising to the appropriate term, "mechanic."

Mr. John Scialla stated that the Building Subcode Committee reviewed the documents provided and felt that the IPC interfaced better with the other adopted subcodes and noted that the Department had switched from BOCA to the ICC codes in the past, and that has served the State well. In addition, he noted that because the codes are not substantially different, there should be no undue burden in adopting and adapting to the IPC.

Mr. Tony Neibert, Mr. Doug Boydston, and Mr. Art Londensky all stated that their Subcode Committees deferred to the Plumbing Subcode Committee for recommendation, since they represent those who are using the code most.

Mr. Bob Mellohusky stated that the Mechanical Subcode Committee deferred to the Plumbing Subcode Committee for recommendation. In addition, many Committee members use the NSPC and felt that the way the NSPC is written serves them most appropriately.

Mr. Steve Rodzinak noted that there was a letter attached to the minutes of the Plumbing Subcode Committee's meeting which speaks to the comparison. Each member reviewed and agreed with the sentiments shared in the letter and the Committee's recommendation, for many reasons, is to stay with the NSPC.

After hearing the recommendation from each Subcode Committee, Mr. Robert Austin invited discussion from the entire board.

One member asked whether there were FEMA implications in staying with the NSPC, and another member stated that FEMA only rewarded grant money to States which adopt ICC codes. Another board member stated that this was untrue, and FEMA did not use any specific code in determining compliance with its grant programs. Discussion ensued on this issue, and one board member noted that the State should not give FEMA any occasion to deny money, because it is already a fight to acquire those grants.

One Board member expressed preference for the fixture requirements and roof draining systems in the IPC. The Board member further asked how the secondary drainage system requirements would apply if the Department were to switch to the IPC. Mr. Austin explained that, because these requirements are State-specific, the Department would need to bring the language from the NSPC forward into the IPC, leading to a hybrid-code in this and possibly other sections.

One Board member stated that there is no substantial difference as it relates to the health, safety, and welfare of residents of the State. The primary difference is that the NSPC is more prescriptive, and the IPC is more performance based. The Board member felt that the IPC is preferable because it is more goal-oriented in application. He provided a brief description of the history of code development over time and noted that the driving factor in development has always been to protect inhabitants and create resiliency in the built environment. He noted that while he appreciates the consideration to those who are using the code, he has never seen a code adoption based on what is easier for the people that use the code. The decision should be based on the health, safety, and welfare of the residents.

One Board member noted that the NSPC continues to appropriately serve the health, safety, and welfare of New Jersey residents, especially in regard to water conservation and waste treatment. He expressed that even though there is an emphasis on the potential burden in training, that is not the only concern with adopting the IPC.

One Board member noted that NAIOP and commercial owners prefer the IPC for its interfacing with other jurisdictions.

Mr. Henry Kelly made a motion, which was seconded by Mr. Michael Seeve, to adopt the IPC. The motion was tied with 5 in favor, 5 opposed, and 1 abstention. Chairwoman Beth Pochtar voted in favor of the motion to break the tie. The motion carried.

After the meeting was adjourned, one member shared a letter sent from FEMA which confirms that their public assistance is not dictated in any way by local codes.

In addition, after the meeting was adjourned, due to multiple members who were in attendance being unable to vote due to technical difficulties, the Division chose to send an email seeking further advisement on this important issue. The goal of this email was to have a further piece of information for the Commissioner to review in rendering her final decision; this information did not impact the action taken at this meeting in any way and served as supplementary guidance to the Commissioner.

#### 2. Responsibilities, N.J.A.C. 5:23-3.4 – Draft Rule

Mr. Robert introduced this item and noted that the Department would revising the responsibilities assigned for Section 906 in the building subcode. This Section contains requirements for portable fire extinguishers, and electrical is not the appropriate assignment. Then, he opened to the Board for discussion.

One Board member noted two Sections within the electrical subcode, 110.2.9.1, and 110.33(a)(3), which should be corrected to correspond with Section 110.26(c)(3).

One Board member noted the following:

- Section 907.3.4 of the building subcode should be assigned to Fire Protection rather than Electrical. Board members agreed that this amendment was appropriate.
- At Section 909.20.6 of the building subcode Fire Protection should be added to plan review responsibility. Board members agreed that this amendment was appropriate.
- Section 329.2 of the mechanical subcode should be assigned to Electrical for plan review and Electrical and Fire Protection for inspection. This would align with Section 915 of the mechanical subcode. Board members agreed that this amendment was appropriate.
- Section 929 of the mechanical subcode delineates the requirements for unvented fuel burning equipment and should be the responsibility of Fire Protection rather than Building. Board members agreed that this amendment was appropriate.

Mr. Tony Neibert made a motion, which was seconded by Mr. Art Londensky, to approve the draft rule as amended by discussion. The motion carried unanimously.

# 3. Rehabilitation Subcode, N.J.A.C. 5:23-6 – Draft Rule

Mr. Robert Austin introduced this rule and opened to the Board for discussion. He noted that the plumbing was left unamended pending the advisement of the Board and the Commissioner's final decision. He also noted that under 6.2, the proposed language is meant to make explicitly clear what code is in effect based on the adoption date. He noted that during the grace period when the updated subcodes are adopted, it is the prerogative of the design professional to use whichever code they would like until the grace period is done. This is because the adoption of the updated rehabilitation code was delayed during the last cycle, so there was confusion as to which code to use.

Mr. Art Londensky made a motion, which was seconded by Mr. Steve Rodzinak, to approve the draft rule. The motion carried unanimously.

#### 4. UCC Updates to Match Model Codes, N.J.A.C. 5:23-2, 3, and 5 – Draft Rule

Mr. Robert Austin introduced this item and noted that there would be a wording change based on the advice of the Building Subcode Committee. He also stated that the changes are not substantial and are intended to incorporate the certification requirements for special inspections that were not previously listed.

One Board member noted that there was a Bill signed into law which requires municipalities to utilize electronic permitting systems starting in April of 2022. He asked whether this proposal could address that. Mr. Robert Austin explained that the PermitsNJ staff is hard at work to implement that law and disseminate information as the effective date comes closer; he stated that any questions about how municipalities should proceed in the meantime should be directed to PermitsNJ staff.

Mr. Art Londensky made a motion, which was seconded by Mr. Steve Rodzinak, to approve the draft rule. The motion carried unanimously.

#### **D. New Business**

1. "Make Ready" EV Chargers (P.L. 2021, c. 171), N.J.A.C. 5:23-2.36 – Draft Rule

Mr. Robert Austin introduced this item and stated that this law was signed and effective immediately in July 2021. He explained that it is largely a planning issue, but it does require us to enact provisions. He referred Board members to the Division of Local Planning Services for information on the allocation of parking and further explanation of the law. The draft rule presented to the Board includes the language of the law almost verbatim, and the exception within Section 1107 of the building subcode is also modified accordingly.

Mr. Art Londensky made a motion, which was seconded by Mr. John Scialla, to approve the draft rule. The motion carried unanimously.

2. Solar Ready Warehouses (P.L. 2021, c. 290), N.J.A.C. 5:23-3.18 – Draft Rule

Mr. Robert Austin introduced this item and explained that it was another Bill signed into law. This would require the solar ready appendix of the International Energy Conservation Code (IECC) for warehouses 100,000 sq. feet and larger, effective for any project approved after July 1, 2022. He confirmed that this doesn't apply to anything under construction or approved before the effective date.

Mr. Art Londensky made a motion, which was seconded by Mr. Steve Rodzinak, to approve the draft rule. The motion carried unanimously.

He thanked the Board for their time in hearing his comments.

#### A. Approval of Minutes of the Code Advisory Board Meeting August 13, 2021

Mr. Tony Neibert made a motion, which was seconded by Mr. Art Londensky, to approve the minutes without change. The motion carried unanimously.

# **B.** Subcode Committee Reports

**Barrier Free Subcode Committee** – Ms. Marie Daniels reported that the Committee met virtually and discussed agenda items.

**Building Subcode Committee** – Mr. John Scialla reported that the Committee met virtually and discussed agenda items.

**Elevator Subcode Committee** – Mr. Doug Boydston reported that the Committee met virtually and discussed agenda items.

**Electrical Subcode Committee** – Mr. Tony Neibert reported that, because no items were referred to the Committee, no meeting was held.

**Fire Protection Subcode Committee** – Mr. Art Londensky reported that the Committee met virtually and discussed agenda items.

**Mechanical/Energy** – Mr. Bob Mellohusky reported that the Committee met virtually and discussed agenda items.

**Plumbing Subcode Committee** – Mr. Steve Rodzinak reported that the Committee met virtually and discussed agenda items.

#### C. Old Business

1. Plumbing Subcode – NSPC and IPC Comparison

Mr. Robert Austin explained that, because the Board was wholly in favor of the Department undertaking a comparison, the Department would like to refer the comparison to each Committee for review purposes to ensure fairness in review. He noted that there is an introductory document which explains the distinctions between the two codes and any major differences, including that the NSPC is more design-based, and the IPC is performance-based.

- 2. Building Subcode, N.J.A.C. 5:23-3.14 IBC, with Elevator, ICC A117.1-2017, and ISPSC. Mr. Robert Austin introduced this item and opened to the Board for discussion. Overall, the Board agreed with the draft rule except for the following items:
- 1. Section 903.2.7.2, related to automatic sprinkler systems in Group M buildings containing more than 2,000 square feet of upholstered furniture, was amended to require sprinklers only in the area with the furniture. This was done to protect the area without adding sprinklers throughout a building that otherwise would not require sprinklers. The Board felt that the old (2018) requirement ensured a greater level of safety by requiring sprinklers throughout the structure. It was recommended that the 2018 requirement be retained.
- 2. In Section 907.5.2.2.5, the 2021 IBC is amended to change the required power source for voice activation for fire alarm systems from emergency to standby power. Emergency power, which was required in 2018, requires the power to come on in ten seconds; standby power is 60 seconds. It was recommended that the 2018 requirement be retained. Mr. Art Londensky made a motion, which was seconded by Mr. John Scialla, to maintain the requirements from the 2018 IBC for these two Sections. The motion carried unanimously.

Mr. Robert Austin asked whether there were further comments or questions on the draft rule. A few clarifying questions were asked; there were no comments on the ISPSC or the Elevator Sections. Ms. Marie Daniels noted that there were minor inconsistencies between the ICC A117.1 and the IBC regarding nosing measurements. Both the Barrier Free Subcode Committee and Building Committee recommended utilizing the IBC, which has a greater maximum allowance by 1/8-inch. *Mr. Doug Boydston made a motion, which was seconded by Mr. Steve Rodzinak, to utilize the IBC. The motion carried unanimously.*

Mr. Art Londensky made a motion, which was seconded by Ms. Valerie Waricka, to approve the draft building subcode, as amended by discussion. The motion carried unanimously.

## 3. Fire Protection Subcode, N.J.A.C. 5:23-3.17 – Cross Reference Update

Ms. Marie Daniels introduced this item and noted that all changes reflected renumbering within the model codes and changes for stylistic consistency.

Mr. Art Londensky made a motion, which was seconded by Mr. John Scialla, to approve the draft rule without change. The motion carried unanimously.

# 4. One- and Two-Family Dwelling Subcode – IRC and ISPSC

Mr. Robert Austin introduced this item and reminded the Board that the same changes contained within the residential portion of the IECC, as discussed at the August 13 meeting, are incorporated in Chapter 11 of the IRC.

Mr. Tony Neibert made a motion, which was second by Mr. Steve Rodzinak, to approve the draft rule with the amendments noted for the IECC incorporated in Chapter 11. The motion carried unanimously.

#### **D. New Business**

# 1. Responsibilities, N.J.A.C. 5:23-3.4 – Draft Rule

Mr. Robert Austin explained that the changes address renumbering and new sections within the model codes without any changes to assignments. The Draft Rule was referred to all Subcode Committees.

#### 2. Rehabilitation Subcode, N.J.A.C. 5:23-6 – Draft Rule

Mr. Robert Austin explained that the changes incorporate new or revised numbers without substantive changes. The Draft Rule was referred to all Subcode Committees.

#### 3. UCC Changes to Incorporate 2021 Editions, N.J.A.C. 5:23 – Draft Rule

Mr. Rob Austin explained that these changes align with the updated model codes. In addition, the licensing provisions are amended to reflect certification requirements for a number of special inspections that were not previously listed. This reflects what has been done with special inspection certifications in the past. The Draft Rule was referred to all Committees.

#### E. Information

# A. Approval of Minutes of the Code Advisory Board Meeting June 11, 2021

Mr. Art Londensky made a motion, which was seconded by Mr. Greg Moten, to approve the minutes without change. The motion carried unanimously.

# **B.** Subcode Committee Reports

**Building Subcode Committee:** Mr. John Scialla reported that the committee met virtually and discussed agenda items.

**Electrical Subcode Committee**: Mr. Tony Neibert reported that the committee met virtually and discussed agenda items.

**Fire Protection Subcode Committee:** Mr. Art Londensky reported that the Committee met virtually and discussed agenda items.

**Mechanical Subcode Committee:** Mr. Bob Mellohusky reported that the committee met virtually and discussed agenda items.

**Plumbing Subcode Committee:** Mr. Steve Rodzinak reported that the committee met virtually and discussed agenda items.

#### C. Old Business

- 1. 1. 2020/2021 Model Code Adoption, Part 1
  - a. Plumbing Subcode N.J.A.C. 5:23-3.15, National Standard Plumbing Code and International Plumbing Code

Mr. Robert Austin informed the Board that the Division is undertaking a comparison of the National Standard Plumbing Code and the International Plumbing Code and aims to have the comparison completed for Board review in October.

No action was needed for this item at this time.

b. Electrical Subcode – N.J.A.C. 5:23-3.16, National Electrical Code (NEC 2020)

Mr. Robert Austin introduced this item and explained that there are very few major changes to the National Electrical Code. The Board discussed three items for consideration for the electrical subcode, as follows:

The Board discussed the issue of Tentative Interim Amendments (TIAs) in the NEC. While TIAs are meant to correct outstanding errors in the publication, they are being used by the NFPA to make code changes in between code cycles. TIAs are still vetted and approved the same way code changes are, but they can be problematic, because they are published in the NEC before the latest edition is published. This means that, depending on the publication date of the 2020 NEC used, different TIAs may be incorporated than those included in older publications of the 2020 NEC. For example, the version of the NEC reviewed by the Division and used for this discussion includes TIAs 1-9. One Board member noted that these TIAs are largely helpful, and one establishes an effective date of January 2023 for a new provision which requires GFCI for any outdoor outlets up to 50 amps; this is because, since the time the code change was approved, it has been found that the GFCIs are regularly tripping out.

The Board then discussed that the Division is proposing to stop amending the electrical subcode for other outlet provisions. This is because, at this time, the technology is so widely available that the State-specific revisions are no longer necessary.

Lastly, one Board member noted that the Division still deletes Article 334.12(a)(2), which prohibits the use of Romex. Another Board member explained that Romex has not proven to be a fire hazard compared to other materials. The Board agreed that there was no reason to prohibit the use of Romex.

Mr. Art Londensky made a motion, which was seconded by Mr. Tony Neibert, to approve the draft rule, which includes TIAs 1-9, without change. The motion carried unanimously.

c. Energy Subcode – N.J.A.C. 5:23-3.18, International Energy Conservation Code 2021 (IECC 2021) and ASHRAE 90.1-2019

Mr. Robert Austin introduced this item and explained that the sections would be reflected within the International Residential Code. He noted that the Commercial code is federally preempted, and ASHRAE 90.1-2019 is to be utilized. The US Department of Energy released its final determination in July 2019, so the Division will be moving to adopt the updated ASHRAE 90.1 standard.

Mr. Austin then explained that the residential portion of the IECC provides a more in-depth look at the current trends in energy conservation. He explained that the 2021 IECC does align with the Governor's Energy Master Plan and the Global Warming Alliance through the Department of Environmental Protection. With that in mind, the Division would like to adopt the 2021 IECC mostly unamended, with the increased insulation values, and with the Division's modification related to the air barrier test deleted; this would mean that the test would be a requirement rather than an option.

The main topic of discussion was focused on the increased insulation values in ceilings. One Board member noted that the increase from R-49 to R-60 will be burdensome on new housing construction. He expressed that the cost is prohibitive in comparison to the payback. Another Board member agreed and noted that material prices are high, and product availability is low due to COVID-19.

One Board member asked whether there is any reason for requiring the air barrier test, and specifically asked if there are any known insulation issues that exist because the State allows for a visual test. Division staff explained that, because no one is performing the test, there is no way of knowing whether the building is 100 percent properly sealed even when a visual inspection has been performed. Board members stated that they did not see a benefit in requiring the test because it is another cost burden, especially to remediate large residential buildings in the event they do not pass the air barrier test.

Another Board member noted that, because there is no way to express how energy efficiency adds value to a home, the increased cost to the homeowner is viewed as a loss rather than a payback in time. He expressed that he understood the goals of the Energy Master Plan but felt that the IECC was advancing too quickly in comparison to the market curve and stated that there has to be a balance, otherwise it could price people out of their homes.

Mr. Art Londensky made a motion to approve the draft rule without change. The motion was seconded by Mr. Steven Rodzinak. Upon further discussion, all Board members voted in opposition to this motion; the motion failed.

One Board member asked whether the administration could propose regulations that do not align with the Board's recommendation. Mr. Robert Austin reminded the

Board that they are advisory, and the Commissioner is charged with making the final decision for any rulemaking.

Mr. John Scialla made a motion to adopt the 2021 IECC without the increased insulation, and with the current modification to the air barrier test. The motion was seconded by Mr. Art Londensky.

Mr. Robert Austin explained that, should this motion carry, the Board should be aware that REScheck would no longer be able to accommodate the previous insulation values alongside the updates throughout the rest of the table that the insulation values are incorporated within, so the State would have to develop software to accommodate this change. One Board member asked if there was any way to move forward without the insulation values and still utilize REScheck, and Mr. Austin explained that the Division could propose to retain the 2018 IECC Table.

Mr. John Scialla retracted his motion.

Mr. Henry Kelly made a motion, which was seconded by Mr. Art Londensky, to adopt the 2021 with all 2018 insulation values, and maintain the Division's modification to the air barrier test. The motion carried unanimously.

d. Mechanical subcode – N.J.A.C. 5:23-3.20, International Mechanical Code (IMC 2021) Mr. Robert Austin introduced this item. Board members felt that the changes within the code were modest and had no further questions or discussion.

Mr. Art Londensky made a motion, which was seconded by Mr. Steve Rodzinak, to approve the draft rule without change. The motion carried unanimously.

e. Fuel Gas Subcode – N.J.A.C. 5:23-3.22, International Fuel Gas Code (IFGC 2021)

Mr. Robert Austin introduced this item. Board members felt that the changes within the code were modest and had no further questions or discussion.

Mr. Steve Rodzinak made a motion, which was seconded by Mr. Bob Mellohusky, to approve the draft rule without change. The motion carried unanimously.

- 3. The List of Pending Legislation was provided electronically.

#### F. Public Comments

Mr. Dan O'Gorman thanked the Board for their time during this meeting and expressed his appreciation for their work. He noted that the National Electrical Code specifies that the requirement for outdoor 50-amp GFCI outlets would not take effect until January 2023 and asked what would happen at that time. Division staff explained that the requirement would be effective in January of 2023 unless there is still uncertainty in the practicability of the requirement, in which case then the Division can revisit the issue. Mr. O'Gorman also asked if NEC Errata can be utilized in enforcement. Division staff explained that, because they correct publication errors, errata are always applicable.

#### G. Adjourn

Mr. Tony Neibert made a motion, which was seconded by Mr. Art Londensky, to adjourn the meeting. The motion carried unanimously. The public portion of this meeting was adjourned 10:45 a.m.

Mr. Robert Austin called the meeting to order at 9:35 a.m. Roll call was performed.

#### A. Approval of Minutes of the Code Advisory Board Meeting April 9, 2021

Mr. Tony Neibert made a motion, which was seconded by Mr. Art Londensky, to approve the minutes without change. The motion carried unanimously.

#### **B.** Subcode Committee Reports

**Barrier Free Subcode Committee:** Mr. John Del Colle reported that the committee met virtually and discussed agenda items.

**Building Subcode Committee:** Mr. John Scialla reported that the committee met virtually and discussed agenda items.

**Electrical Subcode Committee**: Mr. Tony Neibert reported that the committee met virtually and discussed a number of items that are included as new business for this meeting.

**Elevator Subcode Committee:** In the absence of Mr. Doug Boydston, Chair, Ms. Marie Daniels reported that the committee met virtually and discussed agenda items.

**Fire Protection Subcode Committee:** Mr. Art Londensky reported that the Committee met virtually and discussed one of the items included as new business for this meeting.

**Mechanical Subcode Committee:** Mr. Bob Mellohusky reported that the committee met virtually and discussed agenda items. One member passed away due to COVID.

**Plumbing Subcode Committee:** Mr. Steve Rodzinak reported that the committee met virtually to discuss one of the items included as new business for this meeting.

#### C. Old Business

1. Draft Rule – Inspections: Fire Suppression versus Protection – N.J.A.C. 5:23-2.18

Mr. Robert Austin introduced this item, which was referred to all Committees, and noted that each of the Subcode Committee Minutes came to the same conclusion. Board members agreed, and stated that the Committees all felt that, rather than requiring a stop inspection for "fire suppression," it was appropriate to maintain "fire protection," and add "and alarm/detection systems" to the stop inspection.

Mr. Art Londensky made a motion, which was seconded by Mr. Tony Neibert, to approve the draft rule as amended by discussion. The motion carried unanimously.

# 2. Draft Rule – Conflict of Interest: Software Reporting – N.J.A.C. 5:23-4.5

Mr. Robert Austin introduced this item, which was referred to all Committees for review. One committee member noted that the language could be made clearer to ensure that the conflicted agency is aware that it has the authority to input information for reporting, since the conflicted agency is responsible for reporting the project. Staff agreed that the language could be modified to ensure clarity for the reporting requirements.

Mr. Steve Rodzinak made a motion, which was seconded by Mr. Art Londensky, to approve the draft rule as amended by discussion. The motion carried unanimously.

3. Rehabilitation Subcode: Exit Access Stair – N.J.A.C. 5:23-6

Mr. Robert Austin introduced this item and reminded the Board that it came from a proponent who wanted to see Exit Access Stairs included in the rehabilitation subcode. The Board discussed whether this item was truly needed at this time, and it was referred to the Building and Fire Protection Subcode Committees for further review. Both Committees felt that this was a variation issue rather than a widespread matter impacting the majority of rehabilitation projects.

Mr. Steve Rodzinak made a motion, which was seconded by Mr. Art Londensky, to deny this item. The motion carried unanimously.

4. Draft Rule – Rehabilitation Subcode: New Building Elements – N.J.A.C. 5:23-6

Mr. Robert Austin introduced this item, which reorganizes the New Building Elements section of the Rehabilitation Subcode to align with the Materials and Methods section. This draft rule was referred to all Committees for review, and all Committees agreed that the reorganization was appropriate.

Mr. Art Londensky made a motion, which was seconded by Mr. Greg Moten, to approve the draft rule. The motion carried unanimously.

5. Draft Rule – Rehabilitation Subcode and Elevator Subcode – N.J.A.C. 5:23-6 and 12

Ms. Marie Daniels introduced this item and explained that the Elevator Subcode

Committee carefully reviewed the standards for the maintenance of elevator devices and recommended changes to the draft rule to ensure that elevators are appropriately maintained. All changes, along with explanations, are included in the Committee's minutes.

Mr. Tony Neibert made a motion, which was seconded by Mr. Art Londensky, to approve the draft rule as amended by the Elevator Subcode Committee. The motion carried unanimously.

6. Draft Rule – Completely Inclusive Playgrounds (Jake's Law) – N.J.A.C. 5:23-7 and 11 Ms. Marie Daniels introduced this item, which was referred to the Barrier Free, Building, and Electrical Subcode Committees for review. The draft rule relates to the construction of Completely Inclusive Playgrounds. The Board discussed the enforcement of playgrounds and the decision as to whether a play item is accessible, which remains problematic, because that responsibility falls to the owner or manager of the playground. The Board recognized that this matter is outside the scope of the Uniform Construction Code, but worth noting. Within the draft rule text, the Barrier Free Subcode Committee recommended that family or assisted use toilets be provided for completely inclusive playgrounds where facilities are provided. The Committee also recommended that the definition of unitary surfacing be clear, and Mr. Robert Austin explained that the term is defined by CPSC 325, Handbook for Public Playground Safety, which we adopt as part of the playground safety subcode. Lastly, the Committee recommended that the shade requirements may be met by natural or manmade means. The Board agreed with these recommended changes and noted that this draft rule, with the Committee's recommendations, meet the intent of this law and ensure that children with disabilities are provided with the services they need to have an equal opportunity for play.

Mr. John Del Colle made a motion, which was seconded by Ms. Valerie Waricka, to approve the draft rule as amended by discussion. The motion carried unanimously.

# D. New Business

Mr. Robert Austin noted that Board Members should have received digital copies of the codes introduced as new business.

#### 1. 2020/2021 Model Code Adoption, Part 1

a. Plumbing Subcode – N.J.A.C. 5:23-3.15, National Standard Plumbing Code and International Plumbing Code

Ms. Marie Daniels introduced this item and stated that Staff had finalized its review of the National Standard Plumbing Code (NSPC 2021) and was seeking to refer this item to the Plumbing Subcode Committee for review. Ms. Daniels noted that, in addition, the Department would like to invite discussion on the International Plumbing Code (IPC 2021) to gain an understanding of Board members' thoughts for each code.

One Board member noted that builders are in favor of the IPC for a number of reasons; he cited that the International Residential Code (IRC) is a standalone code and contains requirements for low-rise residential construction, including plumbing, fuel gas, mechanical, and electrical requirements for those structures. He argued that, because the Department deletes the plumbing and electrical chapters and defers to the NSPC and the National Electrical Code (NEC), it forces people to buy books that would not be necessary if the IRC was adopted without amendment. He further noted that the Design Services Act of New Jersey allows homeowners to design and build their own single-family dwellings but felt that homeowners are discouraged by how complex the State's building codes are. As such, the builders are in favor of adopting the IRC without amendments. Another Board member disagreed and stated that building codes are complex regardless of the model codes used, and that for buildings other than low-rise residential uses, multiple code books still must be purchased regardless of the publisher (i.e., referenced standards).

One Board member stated that, without any vested interest in the NSPC versus the IPC, he felt that it was important to remind the members that they are stewards who are appointed to uphold the principles of the Uniform Construction Code Act. He noted that they represent many disciplines throughout the State, from builders to design professionals, and public health officials to consumers, and ultimately, they serve for the citizens of the State so that they have the best possible regulations. He noted that, no matter the choice, he wanted to ensure that the decision is not simplistic or done without careful consideration. He was in favor of a comparative process whereby the Board be presented with a qualitative analysis of the IPC and the NSPC. He finally noted that regardless of what other regions and States are doing, the Code Advisory Board serves the State before it serves the Region.

One member stated that the State plumbing industry is in favor of the NSPC. They feel that because New Jersey is the only State that adopts the NSPC on State-wide basis, the code is highly tailored to suit the needs of New Jersey. The NSPC addresses the State's needs when it comes to fixtures, venting, and piping in a timely fashion. He noted that there are some amendments to the NSPC despite it being specific to New Jersey, but that those amendments address gray areas where the NSPC is unclear. In addition, it is what has been in place since the adoption of the UCC in 1977, and it is what the industry has been trained on. He agreed that a comparison should be undertaken but wanted to note that his preference was with the NSPC.

Members of the Committee agreed that a comparison is appropriate and necessary.

Mr. Henry Kelly made a motion, which was seconded by Mr. Greg Moten, to table the NSPC until the Department provides a side-by-side comparison and analysis of the NSPC and the IPC for the Board's review. The motion carried with 8 in favor and 4 opposed.

- b. Electrical Subcode N.J.A.C. 5:23-3.16, National Electrical Code (NEC 2020)
   Mr. Robert Austin introduced this item.
   This item was referred to the Fire Protection and Electrical Subcode Committees.
- c. Energy Subcode N.J.A.C. 5:23-3.18, International Energy Conservation Code 2021 (IECC 2021) and ASHRAE 90.1-2019

Mr. Robert Austin introduced this item.

This item was referred to the Building, Mechanical/Energy, and Plumbing Subcode Committees.

d. Mechanical subcode – N.J.A.C. 5:23-3.20, International Mechanical Code (IMC 2021) Mr. Robert Austin introduced this item.

This item was referred to the Building, Fire Protection, Mechanical/Energy, and Plumbing Subcode Committees.

e. Fuel Gas Subcode – N.J.A.C. 5:23-3.22, International Fuel Gas Code (IFGC 2021) Mr. Robert Austin introduced this item.

This item was referred to the Building, Fire Protection, Mechanical/Energy, and Plumbing Subcode Committees.

2. Draft Rule – Height and Area References in UCC – N.J.A.C. 5:23-3.2 and 6.31

Mr. Robert Austin introduced this item and explained that, over time, Section 503 was split into separate tables, and these amendments address sections where this split was not accounted for. It adds a third table to reflect the breakdown of Section 503.

Mr. Steve Rodzinak made a motion, which was seconded by Mr. Greg Moten, to approve the draft rule. The motion carried unanimously.

3. Draft Rule – Rehabilitation Subcode, Electric Materials and Methods – N.J.A.C. 5:23-6.8(d)

Mr. Robert Austin introduced the draft rule, and Mr. Tony Neibert explained that the Electrical Subcode Committee had been working on this change. Currently, where a building has existing three-wire cables, a new installation would cause the current panel to be a subpanel, which is not permitted pursuant to the electrical subcode without further modification to the electrical system. As such, anyone undertaking a new installation would have to replace the branch circuit wiring to all other appliances. This is expensive, and the installations, often whole-house generators, do not pose any hazard to the homeowners. The draft rule circumvents this issue by allowing the replacement of the current wire or by insulating the neutral wire by stating that, in applying the provisions of the NEC related to this project, the branch circuit does not have to originate at the service equipment.

Mr. Art Londensky made a motion, which was seconded by Mr. Tony Neibert, to approve the draft rule. The motion carried unanimously.

#### F. Public Comments

John Heine, President, Plumbing, Heating, Cooling Contractors (PHCC), vocalized his support for the NSPC and stated that he supports the comparison of both plumbing codes, but feels that the NSPC is appropriate for the State of New Jersey and has worked well for decades. Thus, he does not feel the need to switch to a different code. He also noted that, if the Department were to go with the IPC, all contractors and technicians would have to be retrained to the new code sections and differing requirements, which would entail a cost to be passed onto the consumers. He felt that, with the hardships of COVID, these additional expenses should be avoided. He thanked the Board for their work and for hearing his comments.

Brian Miller, Plainsboro Township, thanked Fire Protection Subcode Committee Chairman Art Londensky for his discussion and recommendation regarding Fire Protection at N.J.A.C. 5:23-2.18 and thanked the Board for their consideration on the draft rule.

# G. Adjourn

Ms. Beth Pochtar, Chair, Uniform Construction Code Advisory Board (Board), called the meeting to order at 9:35 a.m. Roll call was performed.

**A.** Approval of Minutes of the Code Advisory Board Meeting December 11, 2020 *Mr. Art Londensky made a motion, which was seconded by Mr. Greg Moten, to approve the minutes without change. The motion carried unanimously.* 

# **B.** Subcode Committee Reports

**Barrier Free Subcode Committee:** Mr. John Del Colle reported that the committee met virtually and discussed the status of current and upcoming regulations.

**Electrical Subcode Committee**: Mr. Tony Neibert reported that the committee met virtually and discussed a number of items that are included as new business for this meeting.

**Fire Protection Subcode Committee:** Mr. Art Londensky reported that the Committee met virtually and discussed one of the items included as new business for this meeting.

**Plumbing Subcode Committee:** Mr. Steve Rodzinak reported that the committee met virtually to discuss one of the items included as new business for this meeting.

#### C. Old Business

There was no old business for discussion.

#### **D.** New Business

1. Draft Rule – Inspections: Fire Suppression versus Protection – N.J.A.C. 5:23-2.18

Mr. Robert Austin provided background for this section of the Uniform Construction Code (UCC), which details stop inspections for buildings other than one- and two-family dwellings. He explained that this section of the UCC has said cited fire suppression as a stop inspection for quite some time, and a proposal was received to replace the word "suppression" with "protection." Mr. Austin noted that this would require all requirements under Chapter 9 of the building subcode to be a stop inspection.

Members of the Board stated that including all of Chapter 9 would be overly burdensome, but stressed that this rule seeks to avoid situations where an alarm or detection system is placed incorrectly and it is not seen until the final inspection, since that also adds undue burden to the construction process.

This item was referred to all subcode committees.

#### 2. Draft Rule – Responsibilities Update – N.J.A.C. 5:23-3.4

Ms. Thea Popko explained that this change incorporates sections that were overlooked in prior updates to the Responsibilities of the UCC. This was brought to our attention by the Plumbing Subcode Committee, and includes references to valves in the ISPC which involve the

plumbing subcode official. The Plumbing Subcode Committee has already seen these changes and is in favor of the draft rule.

Mr. Steve Rodzinak made a motion, which was seconded by Mr. Greg Moten, to approve the draft rule. The motion carried unanimously.

# 3. Draft Rule – Conflict of Interest, Software Reporting – N.J.A.C. 5:23-4.5

Mr. Robert Austin explained that this rule change would clarify a misunderstanding in the regulations when there is a conflict of interest. Where a building department (conflicted town) has a conflict of interest and asks another department to help, the conflicted town is responsible for the reporting. In addition, the fee schedule utilized and prior approvals met must be those of the conflicted agency. The Board members agreed that this was an important clarification, as some have had issues in their towns when conflicts of interest arise.

This item was referred to all subcode committees.

### 4. Draft Rule – Rehabilitation Subcode, Grounding Systems – N.J.A.C. 5:33-6

Mr. Robert Austin explained that this item has been discussed by the electrical subcode committee many times. It corrects language that was added to reconstruction and then uses that same corrected language for alteration and renovation to apply when a rehabilitation project includes changes in a service. This item has been pending for quite some time, and most contractors are already upgrading panels during rehabilitation projects. This change would align our standards with current industry practice and establish enforceability.

Mr. Tony Neibert made a motion, which was seconded by Mr. Steve Rodzinak, to approve the draft rule. The motion carried unanimously.

### 5. Draft Rule – Rehabilitation Subcode, Exit Access Stair – N.J.A.C. 5:23-6

Mr. Robert Austin explained that this issue was brought to our attention by an architect who was working on a specific rehabilitation project. By way of background, in the 2012 IBC, which the State did not adopt, Section 1019 was created to allow for an exit access stair which is not enclosed. This came into the building subcode for the State with the adoption of the 2015 IBC. In short, this section allows for an open egress stair. The issue at hand is whether Section 1019 should be added to the rehabilitation subcode in order to allow for an open egress stair in an existing building.

This item was referred to the building and fire protection subcode committees.

#### 6. Draft Rule – Rehabilitation Subcode, New Building Elements – N.J.A.C. 5:23-6

Mr. Robert Austin explained that, as New Building Elements section of the Rehabilitation Subcode has gotten longer over the years as more items have been added, this draft rule would reorganize the section so that it is consistent with the Materials and Methods section of the Rehabilitation Subcode. In reorganizing the section, this draft rule would include section titles for each subcode and correct an outdated cross-reference.

This item was referred to all subcode committees.

# 7. Draft Rule – Rehabilitation and Elevator Subcodes, ASME A17.1-2016 – N.J.A.C. 5:23-6 and 12

Mr. Robert Austin explained that, in adopting the 2016 ASME A17.1, the Department overlooked a few items. The information provided to the Board contains the items from the

elevator subcode committee minutes from that time. These changes were missed, and the Board felt that it would be appropriate to look these items over once more.

This item was referred to the elevator subcode committee.

8. Draft Rule – Completely Inclusive Playgrounds (Jake's Law) – N.J.A.C. 5:23-7 and 11 Ms. Thea Popko explained that Jake's Law, which was enacted in August 2018, tasked the Department with the design, installation, and maintenance requirements for a new, completely inclusive playgrounds. This draft rule reflects drafted amendments to the barrier free recreation subcode and the playground safety subcode to meet the requirements set forth pursuant to Jake's Law.

This item was referred to the barrier free, building, and electrical subcode committees.

9. Draft Rule – Building Subcode, Slow and Impractical Evacuation – N.J.A.C. 5:23-3.14

Mr. Rob Austin explained that, when the Department adopted the 2000 edition of the national model codes, the phrase "incapable of self-preservation," was deleted for the New Jersey edition and substituted by NFPA definitions, "impractical evacuation" and "slow evacuation". Since that time, more sections within the model code has used that term, and this draft rule seeks to amend those sections to properly reflect the appropriate NFPA terms. Facilities that utilize these terms are healthcare facilities reviewed by the State, so the bulk of applicable sections are reserved to the Department; thus, this draft mainly ensures that the rule text aligns with procedure. The Bureau of Construction Project Review has reviewed this text and found that it would be an appropriate rule, as it would ensure that all code users understand the applicability of each term.

Mr. John Scialla made a motion, which was seconded by Mr. Art Londensky, to approve the draft rule. The motion carried unanimously.
