SUMMARY OF RULE CHANGES IN JANUARY 19, 2021 TRANSMITTAL

October 5, 2020, New Jersey Register

<u>N.J.A.C.</u> 5:23-2.15 and 2.15A – Heating, Ventilation, Air Conditioning, and Refrigeration Contractors – This adoption incorporates the requirements for HVACR contractors to be licensed into the Uniform Construction Code.

N.J.A.C. 5:23-3.11 – Notice of Administrative Correction, Subcodes: Enforcement Activities

Reserved to the Department – This Notice of Administrative Correction corrects a cross reference at N.J.A.C. 5:23-3.11(a)7 to N.J.A.C. 5:23-4A.7 from 4A.10; this is the result of previous recodification to Subchapter 4.

November 2, 2020, New Jersey Register

N.J.A.C. 5:23-3.4 – **Responsibilities** – This adoption updates the enforcement responsibilities to reflect the updated editions of the national model codes.

November 16, 2020, New Jersey Register

<u>N.J.A.C.</u> 5:23-2.14, 2.18D, and 2.20 – Electrical Systems for Carnivals and Fairs – This adoption updates the manner in which electrical systems for carnivals and fairs are regulated.

December 7, 2020, New Jersey Register

N.J.A.C. 5:23-2.16, 2.18, and 2.29 – Administrative Warrants – This adoption brings the UCC into alignment with a 2013 law on permit updates and an Appellate Division decision requiring local code inspectors to secure administrative warrants in order to make a non-emergent entry onto a property without the owner's consent.

<u>N.J.A.C.</u> 5:23-1.4, 2.15, 3.11, 4.3A, 4.5, 6.2, 6.7, and 6.8 – Various Amendments – This adoption encompasses proposed amendments encompass a number of unrelated changes to the UCC to correct a cross-reference, reassign jurisdiction, and clarify the regulations.

January 4, 2021, New Jersey Register

<u>N.J.A.C.</u> 5:23-3.14, 3.16, 3.21, and 3.22 – Subcodes – This adoption corrects publication errors made upon adoption of updated editions of the national model codes.

<u>N.J.A.C.</u> 5:23-10.2, 10.3, and 10.4 – Radon Hazard Subcode, Radon for Educational Group E Buildings – This adoption updates the construction techniques of the UCC in recognition that the increasing complexity of modern school design necessitates more flexibility in the standards for radon mitigation techniques.
