# **Overall Progress Narrative**

The State of New Jersey (State), Disaster Recovery and Mitigation Division (DRM), Department of Community Affairs (DCA), as the grantee of Community Development Block Grant Disaster Recovery (CDBG-DR) funding allocated to New Jersey by the U.S. Department of Housing and Urban Development (HUD) for Tropical Storm Ida (Ida) recovery, has prepared this Quarterly Performance Report (QPR) addressing CDBG-DR funding and expenditures. This QPR covers the fourth quarter of 2023 (October through December).

The Tropical Storm Ida Action Plan was approved by HUD on November 1, 2022. This QPR illustrates that, through December 31, 2023, the State disbursed \$2.498M in CDBG-DR funds. All Ida recovery programs are underway. The Action Plan and all amendments are available in English and Spanish on DCAâ¿¿s website at: https://www.nj.gov/dca/ddrm/plansreports/idaplansreports.shtml.

In the fourth quarter of 2023, the State submitted two Action Plan Amendments to



HUD for review.

Amendment 5 was considered substantial because it implements policy changes for certain areas in Manville Borough that affect applicants of the Small Rental Repair Program (SRRP) and Homeowner Assistance and Recovery Program (HARP), and it changes the damage impact thresholds in HARP. The amendment process followed the guidance in the applicable Federal Register notice related to substantial amendments and was posted on the DCA website in accordance with HUD requirements. The public comment period for APA 5 was open from 9 a.m. on October 9, 2023, to 5 p.m. on November 7, 2023. The amendment was approved by HUD in the fourth quarter 2023 and modifies the existing Ida Action Plan so that applicants who live in certain areas of Manville are eligible for buyout funding only; they are ineligible for housing repair or elevation assistance. If an applicant declines the buyout grant, funding for neither an elevation nor repair assistance may be offered as an alternative. Also, the changes in the damage impact thresholds in HARP remove the level of flooding and the monetary amount of damage as thresholds and replace them with alternative ways to demonstrate damage impact caused by Hurricane Ida to the home including a damage assessment, proposals/invoices evidencing repairs, and storm-related mitigation measures immediately following the storm, or a program assessment.¿

Amendment 6 was considered non-substantial since the changes did not involve a new allocation or transfer/reallocation of funds above the threshold between programs, did not create a new program, and did not change program beneficiaries or eligibility criteria. The amendment process followed the guidance in the applicable Federal Register notice related to non-substantial amendments and was posted on the DCA website in accordance with HUD requirements. This amendment modified HARP to add a pathway for construction contracts for nonprofit contractors. It also moved funding between HARP and the Homeowner Temporary Relocation Assistance (HRA) program. The amendment was effective on December 18, 2023.

Also, in the fourth quarter of 2023, HUD approved Amendment 4, which had been submitted in the previous quarter. The amendment was effective on December 12, 2023.

The State is committed to affirmatively further fair housing through its disaster recovery programs, following all applicable federal and state statutes and regulations, and enforcing fair housing laws. The State will ensure that recovery assistance for Tropical Storm Ida is prioritized and allocated solely based on disaster-related need, without regard to race, color, national origin, religion, sex (including gender identity and sexual orientation), familial status, and disability. Information relating to demographics of impacted communities will be utilized to ensure that assistance is accessible and reaches New Jerseyans in need.

For Ida recovery, the Tenant Based Rental Assistance (TBRA) Program is planning to serve 2,000 renters while the Housing Counseling and Legal Services Program could assist as many as 5,000 residents, both tenants and homeowners. Tehousing counseling component of the program, through community-based and grassroot organizations, ensures that all citizens have access to civil rights and fair housing information. Also, the addition of contractual funding for legal services for the first time will further fair housing efforts.

The Ida Blue Acres program is also focused on fair housing with its program design and targeted homeowner outreach, an approach that affirmatively attempts to address the disparities often found with other buyout programs.

Housing programs like HARP and SRRP are focused on reaching Ida-impacted homeowners based on income and on expanding periods of affordability, effectively addressing housing disparities and ensuring that CDBG-DR funds in the state will have a long-term impact on affirmatively furthering fair housing.





The Resilient Communities and Smart Move programs are making considerable efforts to advance fair housing with their targeted approach to competitive investments in low- to moderate-income (LMI) communities and otherwise socially vulnerable neighborhoods.

New Jersey Governor Phil Murphy recently signed into law Bill S3110/A4783, which also affirmatively furthers fair housing. The new law makes New Jersey the 30th state to require disclosures from landlords and home sellers that better inform renters and homebuyers of the flood risk they face. To implement the law, the State has published new property disclosure forms notifying prospective homebuyers and tenants of a propertyâżis known flood history and potential flood risks, as well as launched a user-friendly internet look-up tool searchable by mailing address that identifies properties in flood hazard areas. Pursuant to the law, sellers and landlords will be required to use the new forms, which are now available on the New Jersey Division of Consumer Affairs and DCA websites, beginning on March 20, 2024. Efforts like this will minimize the disparate impact of LMI homeownership in climate vulnerable communities.

The following report highlights the Stateâ¿¿s continued progress in executing CDBG-DR recovery programs.

# Grantee Program Progress Narrative

# **Blue Acres**

Blue Acres is a voluntary buyout and incentive program that will acquire residential properties located in the floodway, floodplain, or other Disaster Risk Reduction Area in an effort to reduce the risk from future flooding. In the fourth quarter 2023, Blue Acres held two virtual homeowner meetings to inform residents about HUD-specific buyout work. Forty-five (45) homeowners participated. Staff worked with homeowners who participated in the initial eligibility intake process to secure supporting documentation related to income and storm damages. Tiered environmental review work began. There are 187 households that met program criteria within HUD and State MID areas that are interested in participating in the program. Of these, 163 households remain eligible and 29 LMI buyout households have been deemed eligible by DCA to date. Also, in this quarter, Blue Acres staff worked in tandem with DCA on tenant relocation workflows and SIROMs module updates. Application intake for a second set of homeowners was opened and income verification documentation collection was ongoing through the end of the quarter.

Blue Acres staff canvased Manville homeowners on several occasions during the fourth quarter 2023 to ensure they were aware of their buyout option. There was an emphasis on Manville homeowners who previously requested elevations but were deemed ineligible given the Stateâ¿s risk reduction policy. Activity deliveryrelated costs have been incurred for the program. These costs are associated with policy development, environmental review documentation prep, applicant selection/eligibility screening, and implementation launch preparation. Costs are defined under interchangeability and reported in the Superstorm Sandy quarterly performance report.

# FEMA Non-Federal Cost Share

This program funds the non-federal cost share for State and local facilities eligible under FEMAâ¿¿s Public Assistance program to help offset the burden of the nonfederal share requirements faced by those entities. Ida Action Plan Amendment 4, which was approved by HUD in the fourth quarter of 2023, includes a modification to move all funding from the FEMA Non-Federal Cost Share program to the Homeowner Assistance and Recovery Program (HARP).

# Homeowner Assistance and Recovery Program

The Homeowner Assistance and Recovery Program (HARP) provides grants for activities necessary to restore storm-damaged homes, including rehabilitation,



reconstruction, elevation, and/or other mitigation activities. In the fourth quarter of 2023, the program continued collecting and reviewing applicantsâ¿¿ eligibility documentation, as well as scheduling initial site inspections and beginning te processof generating project scopes of work. The program will oversee all initial site inspection scheduling by the start of the first quarter 2024. Phase 1 LMI applicants totaled 933 in the fourth quarter 2023. Of these, 253 have either had initial site inspections scheduled or completed. HARP has focused on prioritizing initial site inspections for properties built pre-1978 so as to capture all necessary lead abatement scope as early as possible. Lead assessments are in program waitlist in the fourth quarter had 1,028 urgent need (UN) applicants, all of whom were contacted to update their income information to ensure accurate phase designation. HARP expenditures for the quarter were approximately \$473,976. The expenditures include Ida CDBG-DR funding and Superstorm Sandy CDBG-DR funding through interchangeability.

# HARP Housing Rental Assistance

Applicants who have executed a HARP grant agreement may qualify for Housing Rental Assistance (HRA) once construction on their Ida-damaged home begins. As of the fourth quarter 2023, there were no finalized HARP grant agreements, thus no funds were allocated for HRA.

# Housing Counseling and Legal Services

This program was developed by DCA to offer grants to subrecipients to deliver critical supportive services and provide a wide range of counseling services to both renters and homeowners impacted by Tropical Storm Ida. It is anticipated that many applicants from the Homeowner Assistance and Recovery Program (HARP) and the Small Rental Repair Program (SRRP) will need the services provided by this program. In the fourth quarter 2023, approximately 1,057 Ida-impacted households received housing counseling services through the program. Expenditures for this quarter were approximately \$1.03M in support of this program.

# **Resilient Communities Program**

The program application period concluded in the fourth quarter 2023 with 26 applications received from local government entities. All applications have been preliminarily reviewed for completeness, which will aid the program in completing the initial threshold review process. The program anticipates notifying applicants of the results of their threshold reviews by the end of the first quarter 2024. In the fourth quarter 2023, application scoring criteria were refined in preparation for future technical scoring reviews, with particular attention to cost effectiveness criteria. Resilient Communities expenditures for the quarter were approximately \$77,595. The expenditures include Ida CDBG-DR funding and Superstorm Sady CDBG-R funding through interchangeability.

# **Resilient New Jersey**

This program will make direct allocations to units of general local governments, regional teams, and consultant teams to support local and regional resilience planning. The program policies are now complete. Ida Action Plan Amendment 4, which was approved by HUD in the fourth quarter of 2023, includes a modification to move all funding from the Resilient New Jersey program to the Housing Counseling and Legal Services Program. The State is now funding the Resilient New Jersey program with Superstorm Sandy CDBG-DR funding as detailed in Superstorm Sandy Action Plan Amendment 53, which was approved by HUD in the fourth quarter of 2023.

# Small Rental Repair Program

The Small Rental Recovery Program (SRRP) is designed to assist storm-impacted homeowners and renters of rental properties. The program provides assistance for activities necessary to restore storm-damaged homes, including rehabilitation, elevation, and/or other mitigation activities. In the fourth quarter 2023, the



program continued collecting and reviewing applicantsâ¿¿ eligibility and program documentation and engaging with applicants during initial site inspections. This quarter the process of generating project scopes of work began. Phase 1 applicants totaled 147 in the fourth quarter 2023. Of these, two (2) had initial site inspections scheduled. The program has focused on prioritizing initial site inspections for properties built pre-1978 so as to capture all necessary lead abatement scope as early as possible. The program will initiate lead and environmental assessments once initial site inspections have been completed. The program waitlist in the fourth quarter 2023 had 19 applicants. SRRP expenditures for the quarter were approximately \$29,366. The expenditures include Ida CDBG-DR funding and Superstorm Sandy CDBG-DR funding through interchangeability.

# Smart Move

The Smart Move Program subsidizes new development of quality, energy-efficient, resilient, and affordable housing in lower risk areas out of the floodplain within or near disaster-impacted communities that are participating in Blue Acres or other buyout programs. In the fourth quarter 2023, the Smart Move Program launched its application period, which is currently slated to conclude in the second quarter of 2024. In an effort to raise awareness about Smart Move, the program organized an information session this quarter for interested municipalities and developers Additionl information sessions will be held in the first quarter of 2024. Smart Move Program expenditures for the quarter were approximately \$47,783. The expenditures include Ida CDBG-DR funding and Superstorm Sandy CDBG-DR funding through interchangeability.

# Statewide Housing Mitigation Strategy Tool

The Statewide Housing Mitigation Strategy Tool will assess the housing stock in disaster-impacted and at-risk areas that includes such components as taking inventory of housing by type, risk, accessibility, and other components needed to understand community and regional residential vulnerabilities. Over the fourth quarter 2023, the program has procured software necessary to begin development and visualization of impacted housing stock. Funding for this program has moved out of the Ida CDBG-DR grant via Ida Action Plan Amendment 4, which was approved by HUD in the fourth quarter of 2023. The program is now fully funded by Sandy interchangeability via Superstorm Sandy Action Plan Amendment 53, which was approved by HUD in the fourth quarter of 2023.

# Tenant-Based Rental Assistance

Through the Tenant-Based Rental Assistance program, the State will supplement rental housing costs for rental families impacted by Tropical Storm Ida, thereby making rental housing more affordable. In the fourth quarter 2023, applications continue to be reviewed for eligibility and amount of assistance needed. TBRA voucher payments have been made to 144 residents affected by the storm and the invoices are in process. The program continues to process additional applicants in partnership with housing counseling organizations throughout the state.

Section 3

DCA is making the following efforts to help meet its Section 3 goals:

• Ensure that Section 3 requirements are outlined in all applicable contracts and subrecipient agreements.

• Build the capacity of stakeholders, including subrecipients and contractors, to meet Section 3 standards through technical assistance, tools, and guidance.

• Designate a Section 3 coordinator who manages, supports, and facilitates an effective Section 3 program, and who is able to effectively communicate program requirements to stakeholders.

DCA will report Section 3 accomplishments in the Disaster Recovery Grant Reporting system. Recovery programs implemented by DCA and its subrecipients will incorporate uniform best practices of construction standards for all



construction contractors performing work in all relevant jurisdictions. As required in 2 CFR 200.321, DCA will take all necessary steps to ensure that minority-owned businesses and women-owned business enterprises are used when possible.
