In addition to the above qualifying requirements, the applicant must meet one of the credentialing requirements specified below. Application Form Instructions

Note: Please type or print clearly on the application form.

Section

1. Enter your Social Security Number (SSN) and DFSID Number, if issued to you in the space provided. The collection of the SSN is **mandatory**, and is collected under authority of N.J.S.A. 54:50-24 et seq. and Administrative Rule N.J.A.C. 5:3-1.2. The mandatory provision requires the collection of your SSN which enables both the Division of Fire Safety within the Department of Community Affairs and the Division of Taxation within the Department of Treasury to conduct more efficiently, the necessary background check before issuance, denial, renewal, suspension or revocation of a certification.

On the next lines enter your name, home address, city, state, zip code and county where you reside. Please supply your telephone numbers so that we may reach you if we receive undelivered mail or need to reach you during the day. Please list your fax number and email address to further assist us in forwarding information and contacting you.

2. Fire Investigator Certification Requirements:

- A) Be at least 18 years of age;
- B) Has a high school diploma or equivalent;
- C) Holds **ONE** of the following certifications, licenses or titles: Firefighter I, Fire Inspector, Fire Official, Police Officer, Police Detective, Police Investigator, Certified Fire Investigator (CFI) through IAAI, certified Fire and Explosion Investigator (CFEI) through NAFI, or Certified Fire Investigator designated by the U.S. ATF;
- D) Satisfactorily complete a Basic Fire Investigation course that meets the requirements of NFPA 1033, 2014 edition and NFPA 92, 2017 Edition. Only an educational program completed within the three years prior to, or at the time of, application shall be accepted toward fulfilling the education program requirements for Fire Investigator certification;
- E) Satisfactorily pass the State Fire Investigator written and skills exams specified by the Office of Training and Certification. Only exams completed within the three years prior to, or at the time of, application shall be accepted toward fulfilling the examination requirements for Fire Investigator certification; and
- F) Submit a certification application with the required \$91.00 application fee.

Equivalency Provision: Please note that if the applicant has previously passed an examination and received certification as a Certified Fire Investigator, Basic Arson Investigator, or Certified Fire Explosive Investigator, they can obtain a NJ Fire Investigator certification through an 'equivalency' provision. The following courses can be substituted for the Basic Investigation course as specified in N.J.A.C. 5:73-18: A Basic Fire/Arson Investigator course administered through the NJ Division of Criminal Justice, the National Fire Academy, or sanctioned through the International Association of Arson Investigators (IAAI) or the National Association of Fire Investigators (NAFI), or a course evaluated as 'equivalent' by the Office of Training and Certification. There is no timeline restrictions for equivalency determination. The equivalency provision shall be a one-time issuance by the Office of Training and Certification.

4. A non-refundable fee of **\$91.00** is required for each application. A personal check, money order, or purchase order/voucher must accompany your application payable to the "**TREASURER, STATE OF NEW JERSEY.**" Your application will not be processed unless payment is attached.
