



### **The Defusable “Bomb” Alarm Clock**




The Division of Fire Safety has recently been made aware of a “novelty” product on the market called the “**Defusable Bomb Alarm Clock**.” The device is an alarm clock that is made to resemble a bomb that also functions as a game whereby the player pushes a button on the device that starts a 10 second countdown. The player then has the ability of “defusing” the device by cutting or removing any one of four colored replaceable wires. Only one of the wires will stop the countdown. The other wires will not stop the countdown if they are cut or removed, resulting in the bomb “detonating.” Of course the bomb doesn’t actually explode, the player simply loses the game.

The main problem with this device and similar novelty items such as this is that they look frighteningly realistic and can cause alarm if found by civilians or emergency responders during incidents. Further, it is possible that this type of a device could be used as a prank designed to cause panic.

If emergency responders encounter these devices it is imperative that they not attempt to determine if they are in fact novelty devices. Instead, responders should leave the area immediately and evacuate civilians to a safe distance and contact law enforcement to mitigate the incident.

## **NATIONAL ASSOCIATION OF STATE FIRE MARSHALS OFFERS ONLINE TRAINING**

*(from the National Volunteer Fire Council)*

Last year, fires killed over 3,000 people, injured more than 15,000, and caused an estimated \$11.5 billion in damage. Over a five-year period, the cause of ignition in the National Fire Incident Reporting System (NFIRS) was unknown in almost three out of every five home fire deaths, according to the United States Fire Administration and the National Fire Protection Association. Recognizing the reporting gap in NFIRS, the National Association of State Fire Marshals (NASFM) has launched a free, online training program for the fire service, *“Understanding Your Role in Fire Incident Data,”* available at NASFM’s training portal.

The new training program is the result of a project by NASFM’s Fire Education Research Foundation, funded by a FEMA Fire Prevention and Safety Grant, to determine the root causes contributing to the reporting gap and develop a training solution to help fire departments across the nation with stronger reporting practices.

“The new training program addresses such an important gap in our national fire incident data,” said Butch Browning, NASFM President and Louisiana State Fire Marshal. “If we don’t know what is causing these fires, we really can’t work effectively to prevent them with solutions that specifically address the root problems. “

To ensure that the program was applicable in as many environments as possible, the NASFM Foundation developed it in close collaboration with the International Association of Fire Chiefs, International Association of Fire Fighters, National Fire Information Council, National Fire Protection

Association, National Volunteer Fire Council, the North American Fire Training Directors, the United States Fire Administration, and the Vision 20/20 project.

- **Closing the loop.** So often, there is a disconnect within fire departments between those who make the initial fire report entry, such as the line officer, and the fire investigator who later determines the cause of the fire, and the initial report is not updated with the new information.
- **Clearing the litigation cloud.** Fire departments are often reluctant to enter the cause of the fire unless they are 100% sure because of the potential for being called to task later during any court proceedings.
- **Black Hole.** A number of people interviewed for the project had an inaccurate impression that the information went into a “black hole” and didn’t really make any difference, either locally or nationally.
- **Complexity.** The current NFIRS systems is perceived as being overly complex and not user-friendly, which discourages those using it from taking the time to accurately enter the information.

This online course takes approximately one hour and a certificate of completion is available after finishing the course that can be used for continuing education requirements. In addition, since this training program is self-guided, it can be easily incorporated into recruit training at a fire academy or station level and used by full-time, call, and volunteer fire departments.

# **2014 NATIONAL FIRE PREVENTION WEEK A MONTH-LONG NEW JERSEY CELEBRATION**

During National Fire Prevention Month the Montclair State University Department of Fire Safety, with the assistance of the Little Falls Fire Department, staged a “mock dorm room burn” to show students how quickly a fire can spread in a dorm room.

The event, was billed as the “Big Bohn-Blanton Burn,” was held at the University’s Blanton/Bohn Quad, and was witnessed by many students.

“The mock dorm room burn is a training tool that is used around the country to inform residents about how fast a fire can grow and how important it is to evacuate on every fire alarm,” said Robert Ferrara, Director of Fire Safety at Montclair State University.

“We will also show what happens when smoke detectors are covered or tampered with.”

According to Ferrara, this event is the first time that currently enrolled students are able to take part in a program like this.

New Jersey’s Uniform Fire Code contains a mandatory requirement that all on campus college and university housing in the state be equipped with fire sprinkler systems.


The University has staged similar mock burns in years past. Students saw first-hand a fire’s stages – ignition, growth, flashover and decay – as they watched a replica of a dorm room burn. They saw just how rapidly a fire can increase, by doubling every 30 seconds, how certain fire code violations accelerate a fire, how much toxic smoke is released and the amount of damage a fire can do to a dorm room in a short period of time.

The mock dorm room burn is intended to change students’ mindsets about the importance of fire drills. The goal is to stop students from being complacent about drills by showing them that evacuating a dorm as quickly as possible during a drill is a necessary step in saving lives should a fire break out.

The fire safety education event is made possible by the Montclair State University Department of Fire Safety, the Montclair State Department of Residence Life and the Little Falls Fire Department. Additional assistance and support is provided by Montclair State University Facilities/ Grounds, the Montclair State Center for Student Involvement, the New Jersey Department of Environmental Protection, the New Jersey Division of Fire Safety and Firefighter University. # **NATIONAL FIRE ACADEMY OFFERS CAREER TRACK MANAGING OFFICER COURSES**



**National Fire Academy, Emmitsburg, Maryland**

The United States Fire Administration's National Fire Academy (NFA) announces a new training program aimed at improving the professional skills of America's fire and emergency medical services first responders. Called the Managing Officer (MO) program, the curriculum emphasizes leadership, safety, community risk reduction, training, and technology for those men and women who may be embarking on supervisory roles in their organization.

The MO program differs from other NFA programs by providing new officers a defined nationally-recognized curriculum. Students will be able to complete the program in as little as two years, and will receive a NFA capstone certificate when they finish.

NFA Superintendent Dr. Denis Onieal explained, "The MO program will fulfill the four universal elements of professional development: higher education, training and certification, continuing education and experience. This includes a combination of self-study, state and local training, and resident courses at the National Emergency Training Center in Emmitsburg, Maryland."



The program curriculum and entrance requirements were established by the NFA Board of Visitors.

The four resident courses include *Contemporary Training Concepts for Fire and EMS, Applications of Community Risk Reduction, Transitional Safety Leadership* and *Analytical Tools for Decision-Making*.

#### *FIREFIGHTER EQUIPMENT PROTECTION ACT*

[H.R. 5483](#) was introduced by Congressman Tim Griffin (AR-2) on September 16, 2014. The bill prevents the Defense Logistics Agency from basing any decisions about firefighting equipment donations on Environmental Protection Agency emissions standards.

#### *FISCAL YEAR 2015 HOMELAND SECURITY APPROPRIATIONS ACT*

[H.R. 4903](#) was introduced by Congressman John Carter (TX-31) on June 19, 2014.  
[S. 2534](#) was introduced by Senator Mary Landrieu (LA) on June 26, 2014. Summary: The bill makes appropriations for programs and activities of the Department of Homeland Security for Fiscal Year 2015.

#### *FEDERAL FIREFIGHTERS FAIRNESS ACT*

[H.R. 3718](#) was introduced by Congresswoman Lois Capps (CA-24) on December 12, 2013.  
[S. 2266](#) was introduced by Senator Thomas Carper (DE) on April 29, 2014. The legislation creates a presumption that federal firefighters who are disabled by heart disease, lung disease, specified cancers and infectious diseases, contracted such illnesses while performing their duties as firefighters.

#### *PROTECTING VOLUNTEER FIREFIGHTERS AND EMERGENCY RESPONDERS ACT*

[S. 1798](#) was introduced on December 10, 2013 by Senator Mark Warner (VA).

[H.R. 3685](#) was introduced on December 10, 2013 by Congressman Lou Barletta (PA-11). The legislation ensures that volunteers are not counted as full-time employees under the shared responsibility requirements contained in the Patient Protection and Affordable Care Act.

#### *NICHOLAS AND ZACHARY BURT MEMORIAL CO POISONING PREVENTION ACT*

[S. 1793](#) was introduced by Senator Amy Klobuchar (MN) on December 10, 2013. The legislation establishes a federal grant program to assist states in carrying out CO education programs.

#### *HONORING HOMETOWN HEROES ACT*

[H.R. 2386](#) was introduced on June 14, 2013 by Congressman John Larson (CT-1). The bill amends the U.S. flag code, allowing Governors to declare the flag to be flown at half-staff in the event of a first responder line-of-duty death.

#### *FIRE SPRINKLER INCENTIVE ACT*

[S. 1163](#) was introduced on June 13, 2013 by Senator Thomas Carper (DE). The legislation amends the Internal Revenue Code of 1986 to include automated fire sprinkler systems as section 179 property and classify certain automated fire sprinkler systems as 15-year property for purposes of depreciation.

## *SAFE BUILDING CODES INCENTIVE ACT*

[H.R. 1878](#) was introduced on May 8, 2013 by Congressman Mario Diaz-Balart (FL-25).

[S. 924](#) was introduced on May 9, 2013 by Senator Robert Menendez (NJ). The bill would provide an additional funding for post-disaster grants under a program administered by the Federal Emergency Management Agency to states that adopt and enforce state-wide building codes.

## *FIRE POLICE FAIRNESS ACT*

[H.R. 1828](#) was introduced on May 6, 2013 by Congressman Joe Courtney (CT-2).

[S. 876](#) was introduced on May 7, 2013 by Senator Richard Blumenthal (CT). The legislation would extend coverage under the Public Safety Officers' Benefits (PSOB) program to fire police officers.

## *CAMPUS FIRE SAFETY EDUCATION ACT*

[S. 750](#) was introduced on April 17, 2013 by the late Frank Lautenberg.

[H.R. 1609](#) was introduced on April 17, 2013 by Congressman Bill Pascrell, Jr. (NJ-9). The legislation establishes a grant program at the Department of Education to make awards to institutes of higher education for fire prevention and education programs.

## *THE HONORABLE STEPHANIE TUBBS JONES COLLEGE FIRE PREVENTION ACT*

[H.R. 1437](#) was introduced on April 9, 2013 by Congresswoman Marcia Fudge (OH-11).

The legislation directs the Secretary of Education to make competitive demonstration grants to institutions of higher education, fraternities, and sororities for up to half the cost of installing fire sprinkler systems, or other fire suppression or prevention technologies, in student housing and dormitories owned or controlled by such entities.

## *VOLUNTEER EMERGENCY SERVICES RECRUITMENT AND RETENTION ACT*

[H.R. 1009](#) was introduced on March 6, 2013 by Congressman Peter King (NY-13).

[S. 506](#) was introduced on March 7, 2013 by Senator Susan Collins (ME). The legislation modifies the federal tax code to make it easier for fire departments and local governments to provide recruitment and retention incentive to volunteer emergency response personnel through length of service award programs (LOSAPs).

## *VOLUNTEER RESPONDER INCENTIVE PROTECTION REAUTHORIZATION ACT*

[S. 501](#) was introduced on March 7, 2013 by Senator Charles Schumer. (NY)

[H.R. 3747](#) was introduced on December 12, 2013 by Congressman John Larson (CT-1). The legislation exempts from federal income tax any property tax benefit and up to \$600 per year of any other type of benefit that a state or local unit of government provides to volunteer emergency responders as a recruitment or retention incentive.


