Beginning March 19, 2020, Princeton House Behavioral Health moved all outpatients to a telehealth format. The intensive outpatient program is offered three hours per day, three or five days per week.

All patients are evaluated and followed by a psychiatric provider (psychiatrist or psychiatric Advance Practice Nurse), and participate in a full intensive outpatient schedule of therapy, psycho-educational groups, allied clinical therapies and services specific to their individualized treatment plan, including nursing and nutritional consults as needed.
