

Major Needs Identified in December 2019 Stakeholder Meeting

- Prioritize supportive housing for special needs populations – elderly, mentally ill, substance abuse, veterans, developmentally disabled
- Construction of affordable rental housing for single individuals, small and large families
- Additional housing vouchers especially for disabled, homeless and youth transitioning out of foster care
- More housing first initiatives
- Rental housing rehabilitation
- Preservation of existing affordable housing when deed restrictions end
- Financial assistance for business creation
- Funds for homeless prevention and rapid re-housing
- Supportive services
- Employment training
- Restoration of the Office of Housing Advocacy
- Build small scale affordable housing developments (up to 20 units)
- Increase shelter beds
- Expand mobility initiatives
- More case management funds for homeless initiatives
