At 9:48 am, a motion was made by Ms. Walter and second by Mr. Mapp to go into open session. A voice vote was taken. Motion passed.

Concerning the matter of III.A.7. A motion was made by Mr. Mapp and second by Mr. Blee to dismiss the complaint against the accused for lack of jurisdiction. A roll call was taken: 6 affirmative, 2 absent (Mr. DiRocco and Ms. Rodriguez). Motion passed.

Concerning the matter of III.A.8. A motion was made by Mr. Blee and second by Mr. Light to dismiss the complaint as without any reasonable factual basis. A roll call was taken: 6 affirmative. 2 absent (Mr. DiRocco and Ms. Rodriguez). Motion passed.

Concerning the matter of III.A.9. The matter was deferred.

Concerning the matter of III.A.10. A motion was made by Mr. Blee and second by Mr. Mapp to find the local ethics board is not precluded from rendering a decision in the matter. A roll call was taken: 6 affirmative, 2 absent (Mr. Di Rocco and Mrs. Rodriguez). Motion passed.

The Local Finance Board determined to break from the Ethics portion of the meeting and take a brief recess. A brief recess was taken. The Local Finance Board will reconvene to consider applications.
