Concerning the matter of III.A.3. A motion was made by Mr. Close and second by Mr. DiRocco to authorize an investigation against the accused. A roll call was taken: 6 affirmative, 1 abstain (Mr. Mapp) and 1 absent (Ms. Rodriguez). Motion passed.

Concerning the matter of III.A.4. A motion was made by Mr. Avery and second by Mr. Light to issue a Notice of Violation under NJSA 40A:9-22.6(a)(1) against the accused and to waive the fine. A roll call was taken: 7 affirmative, 1 absent. (Ms. Rodriguez). Motion passed.

At 9:25 am, a motion was made by Mr. Blee and second by Mr. Mapp to go into closed session for the purpose of discussing complaints and to receive related legal advice. A voice vote was taken. Motion passed.

At 9:27 am, Ms. Walter exited the room. At 9:33 am, Ms. Walter entered the room. At 9:37 am, Ms. Walter exited the room. At 9:43 am, Ms. Walter entered the room.

At 9:47 am, a motion was made by Mr. Blee and second by Mr. Avery to go into open session. A voice vote was taken. Motion passed.

The Local Finance Board determined to break from the Ethics portion of the meeting and take a brief recess. A brief recess was taken. The Local Finance Board will reconvene to consider applications.
