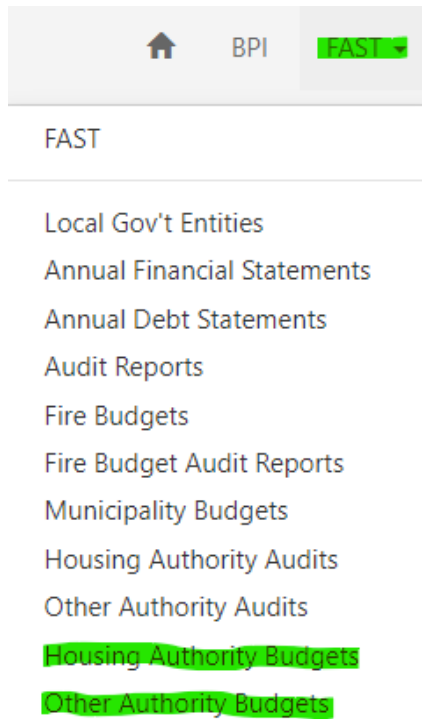


## Financial Automation Submission & Tracking (FAST)

### Authority and Housing Authority Post-Adoption Amendments Submission Process User Guide

Per N.J.A.C. 5:31-2.8, Authorities and Housing Authorities are required to submit budget amendments that occur after the adoption of the annual budget through the FAST portal within three days after adoption. To do so, the adopted budget for the current year must already be submitted and certified in FAST. The below process must be completed each time the adopted budget is amended. To submit a post-adoption amendment:

- 1) Login to the system and click "FAST" in the upper right corner of the screen. Select either Other Authority Budgets or Housing Authority Budgets from the dropdown menu, depending on your authority type.



- 2) Select the adopted budget folder for the current budget year:

- 5) On the amendment screen, enter the date that the amendment was adopted by the governing body of the authority. The following must be uploaded as part of the amendment submission:
  - a) Amended Budget (**a full copy of the budget, as amended, is required to be uploaded; do not upload only the pages that were amended**)
  - b) Resolution of the authority commissioners amending the budget
  - c) Any additional documentation related to or in support of the amendment

- 6) Once the date has been entered and required documentation has been uploaded, click “Submit Amendment”. **This button must be clicked in order for Division of Local Government Services staff to receive the amendment.**

Division of Local Government Services staff will review amendments as they are submitted and contact the individual who submitted the amendment if additional information or clarification is required. Upon approval, the adopted budget will reflect a status of “Amended Adopted Budget Certified”.
