Instructions for accessing the meeting via Microsoft Teams

There are three ways to access the meeting:

- 4. The Board will be using video capabilities in the meeting for participants who need to be sworn in. Video capability is required for this meeting if you anticipate offering testimony on an application. Microsoft Teams has the capability to hold meetings with video and audio. Please use option 1 or 2 from the above list to access and testify during the meeting via Microsoft Teams.
