INTRODUCTION

The New Jersey Department of Community Affairs (DCA)'s Language Access Plan (LAP) ¹ explains the actions DCA and its subrecipients will take to ensure compliance with Title VI of the Civil Rights Act of 1964, Executive Order 13166 and U.S. Department of Housing and Urban Development (HUD) issued Final Guidance 72 FR 22732 related to the Superstorm Sandy Recovery programs and services. Title VI of the Civil Rights Act of 1964, Executive Order 13166 and HUD's 72 FR 2732 require that recipients of federal financial assistance must take reasonable actions to ensure meaningful access to their activities, programs and services for individuals with Limited English Proficiency (LEP).

DCA is responsible for administering Community Development Block Grant Disaster Recovery (CDBG-DR) funds in the nine counties most impacted by Superstorm Sandy including Atlantic, Bergen, Cape May, Essex, Hudson, Middlesex, Monmouth, Ocean, and Union counties. This revised LAP outlines how DCA plans to ensure that LEP persons have meaningful access to its CDBG-DR programs and services. The LAP describes (1) the Four-Factor Analysis DCA conducted to identify the needs of LEP persons throughout the nine most impacted counties and (2) the accompanying protocols, training and outreach efforts DCA will develop and implement in order to ensure LEP persons can access Superstorm Sandy disaster recovery programs and services.

POLICY

It is DCA's policy to provide language access services to LEP individuals needing access to CDBG-DR funded programs; to manage and train DCA staff, contractors and subrecipients on procedures for implementing the LAP; to inform LEP individuals that language access services are available; and to continuously monitor and evaluate the implementation of this plan. DCA will also review and update its LEP Four Factor Analysis when new Census data becomes available.

PURPOSE

The purpose of the LAP is to provide direction on DCA's LEP needs as identified by the Four Factor Analysis data. The LAP also describes how DCA and its subrecipients will provide meaningful language access services to address those needs. DCA and its subrecipients will provide two primary types of services: oral and written. Oral language access services may come in the form of "in-language" communication (a demonstrably qualified bilingual staff member communicating directly in an LEP person's language) and interpreter services. Written language access services will come in the form of written translation provided by DCA translators or a DCA-approved translation contractor.

DCA and its subrecipients will engage in specific outreach efforts to ensure that LEP persons are aware of the language access services available to them. DCA and its subrecipients will also provide training to program level LAP Coordinators and direct service staff on how to implement this LAP and methods of assistance available to LEP individuals. This training will be periodically updated and delivered as DCA's LEP needs and language access services evolve. DCA and its subrecipients are committed to this LAP as

the appropriate response to meeting our LEP clients' needs, as well as complying with Title VI, Executive Order 13166 and Final Guidance (72 FR2732).

BACKGROUND

DCA is the grantee for all HUD CDBG-DR funding allocated to the State of New Jersey in response to the damage sustained as a result of Superstorm Sandy. DCA is implementing many of the Sandy Recovery Programs directly and is working with the following subrecipients to implement the remainder:

- New Jersey Department of Environmental Protection (DEP);
- New Jersey Housing Mortgage Finance Agency (HMFA);
- New Jersey Economic Development Authority (EDA); and
- New Jersey Redevelopment Authority (NJRA)

DEFINITION OF LEP PERSONS

LEP is defined as persons who have a limited ability to read, write, speak, or understand English, and may require language assistance with respect to a particular type of service, benefit, or encounter.

FOUR FACTOR ANALYSIS: IDENTIFYING LEP INDIVIDUALS NEEDING LANGUAGE ASSISTANCE

As described in HUD's 72 FR 2732, the starting point for ensuring meaningful access is a Four Factor analysis that takes into account the:

- 1) number or proportion of LEP persons in the eligible service population,
- 2) frequency with which LEP individuals come in contact with the programs,
- 3) nature and importance of the service provided by the programs, and
- 4) resources available to the recipient and costs

Below is DCA's analysis of each of these four factors across the nine most impacted counties. A complete version of the Four Factor Analysis DCA completed is included in <u>Appendix 5</u>.

Number or Proportion of LEP persons Served or Encountered in Eligible Service Population All data used to estimate the proportion of LEP persons in the nine county service area comes from the Census Bureau's American Community Survey (ACS) 3-year file (2009–2011) – Table "B16001: Language Spoken at Home by Ability to Speak English for the Population 5 Years and Older." DCA received a file, prepared by the Migration Policy Institute, from HUD's Office of Fair Housing and Equal Opportunity (FHEO), which provides county level ACS estimates of the LEP population by language spoken. Estimates in the file were rounded to the nearest hundred.

For all counties in New Jersey, including the nine most impacted, no LEP population other than Spanish speakers exceeds 5% of the county's population. Each county, however, with the exception of Cape May, has more than 1,000 individuals that speak a language other than English or Spanish. Bergen County has the most, with 18 different languages meeting the threshold. Across the nine counties, there are 24 languages that meet the threshold (see Table 1 in Four Factor Analysis included in *Appendix 5*.

DCA worked with FHEO to determine how many languages to focus on in its LAP. DCA observed that the fourth highest LEP population in each county does not exceed 1% of the total population. Based on this analysis of the data, DCA and HUD FHEO met on June 23, 2014 and agreed that DCA would focus on the top three languages in each county where the specific LEP population is equal to or exceeds 1,000 people. Moreover, this focus is consistent with the Voluntary Compliance Agreement (VCA) entered into between DCA, FHEO, the Latino Action Network, New Jersey State Conference of the National Association for the Advancement of Colored People (NAACP), and the Fair Share Housing Center.

Accordingly, Table 2: Top Three LEP Populations of 1,000 or More in Nine Impacted Counties of the Four Factor Analysis (see <u>Appendix 5</u>), lists the top three foreign language speaking populations in the nine most impacted counties. This includes 11 different language speaking populations. DCA will also provide language access services upon request to foreign language speaking populations that do not constitute the top 3 in the county but are one of the 11. For example, in Essex County, there is a small LEP population that speaks Gujarati (600 individuals). Even though Gujarati is not one of the top three languages in Essex County, DCA will provide these LEP individuals with language access services upon request.

DCA has also compiled data on the top three LEP populations in the nine most impacted counties at the Census tract level. The total number of LEP individuals, the percentage of low- and moderate-income (LMI) individuals, and the total number of units that sustained major or severe damage in each census tract by county are included in <u>Attachment 2</u> of the Four Factor Analysis. The maps included in <u>Attachment 1</u> visually illustrate this information with shading to represent the relative cumulative percentage of LEP individuals in each tract. The cumulative percent ranges are as follows:

- 1. 0%
- 2. >0% to 25%
- 3. >25% to 50%
- 4. >50% to 75%
- 5. >75% to 100%

This allows DCA to analyze where the greatest numbers of LEP individuals by language are located in each county. DCA is also taking into account those census tracts with a high concentration of LMI populations and where damage was sustained as it plans its LEP outreach. For further explanation regarding the cumulative percentage methodology, refer to <u>Attachment 3: Further Explanation of Cumulative Percentage Map Methodology</u>.

Frequency with which LEP Individuals Come into Contact with the Programs

CDBG-DR programs address the long-term needs of New Jersey's Sandy-impacted residents and communities by providing direct assistance to homeowners, tenants, landlords, and small businesses. Specifically, the LAP encompasses services provided at the individual applicant level. LEP individuals will receive direct language assistance commensurate with the frequency with which these individuals interact with the programs. For example, homeowners, renters, rental property owners, and small business owners who apply for various CDBG-DR programs are likely to have frequent contact with the program, and therefore are afforded meaningful access to program. This may include such interactions as completing applications, meetings with advisors to review applications, initial site inspections,

approval of final construction designs, preconstruction meetings, grant award closings and submission of receipts and proof of construction work. For program activities such as these, DCA's strategy will ensure that these populations have meaningful access throughout the process. Language assistance will not be provided to public entities such as municipalities and non-profits that receive CDBG-DR funding.

Nature and Importance of the Program, Activity, or Service Provided by Programs
The more important the activity, information, service, or program, or the greater the possible consequences of the contact to the LEP persons, the more likely language services may be needed.

LEP outreach will focus on the programs that provide critical services to homeowners, landlords, renters, and small business owners. Those programs that provide a means of helping individuals obtain or get back into damaged housing or re-open their businesses are critically important to LEP individuals. The next section, *Interaction with LEP Persons by Program*, outlines how DCA anticipates LEP persons will need to, or already do, interact with each program.

Resources Available to DCA and costs

DCA is taking all reasonable steps to provide meaningful access for LEP persons to DCA CDBG-DR programs and activities. The availability of resources, however, may limit the provision of language services in some instances. "Reasonable steps" may cease to be reasonable when the costs imposed substantially exceed the benefits. DCA's LAP balances the needs of the LEP community with the funding resources available.

Activities aimed at providing meaningful access to the LEP population will be incorporated and funded across all of the CDBG-DR programs outlined in DCA's Action Plans as well as the new programs outlined in the VCA.

INTERACTION WITH LEP PERSONS BY PROGRAM

LEP persons are most likely to come into contact with CDBG-DR funded programs that are intended to serve homeowners, tenants, special needs individuals, landlords, and small businesses. Meanwhile, programs benefitting municipalities and nonprofits; large scale development projects benefitting housing developers; infrastructure programs; and environmental programs are not likely to require much, if any, direct interaction with LEP persons. DCA will provide appropriate language access services for LEP persons when Substantial Action Plan Amendments are considered and public citizen participation periods are opened.

DCA evaluated which of its CDBG-DR programs are most likely to require language access services based on the program's audience. Programs whose audiences are exclusively comprised of public entities (as defined above) do not require language access services. The table below lists all of the programs, the administering agency (either DCA or one of its subrecipients), the intended audience for each program and how each program is likely (or not likely) to interact with or require outreach to LEP persons. Where potential interaction with LEP persons is anticipated, the administering agency is responsible for providing language access services. Applicants that indicate s/he are not LEP will stop receiving LEP related materials.

Through these programs, DCA and its subrecipients will interact with LEP individuals through a variety of means. These may include, but are not limited to:

- In person and telephone contact with program applicants and participants;
- Hotline or information line calls;
- Outreach programs;
- Public access to agency websites;
- Written correspondence, notices or complaints sent to an agency; and
- Agency brochures intended for public distribution.

DCA will also provide appropriate language access services for LEP persons when Substantial Action Plan Amendments are considered and public citizen participation periods are opened.

LANGUAGE ASSISTANCE MEASURES

DCA, along with its subrecipients, has undertaken or will undertake the following tasks in order to provide meaningful access to CDBG-DR funded services, programs and activities to LEP individuals. These tasks are predominantly focused on addressing the needs of LEP individuals accessing DCA administered housing assistance and small business programs.

Appointment of LAP Coordinator

DCA has appointed an LAP Coordinator to serve as the primary point of contact responsible for the implementation of the LAP across all CDBG-DR funded programs. These language access programs include, but are not limited to, provision of language assistance services, training programs, outreach activities, maintenance of the language bank, and review of data collected on individuals needing LEP assistance. The DCA LAP Coordinator's contact information is listed below and posted on the Sandy website:

² For the vast majority of projects, the Flood Hazard Risk Reduction Program will work directly with municipalities. However there are a small percentage of homeowners that own easements and will work directly with DEP, the program administrator. For these projects, DEP will need to send communications to homeowners in English and Spanish and where appropriate provide additional LEP services.

The DCA LAP Coordinator oversees and ensures that subrecipients adhere to this LAP and procedures for providing meaningful access to LEP individuals for each program. All subrecipients have identified a Program Level LAP Coordinator responsible for securing language access services as applicable for their agency's CDBG-DR program(s). Each subrecipient is responsible for sending the name and contact information of each subrecipient's LAP Coordinator to DCA's LAP Coordinator as well as to Dave Reiner, DCA Assistant Commissioner and Elizabeth Mackay, Assistant Director of Legal and Procurement. Additionally, DCA will ensure that the name and contact information of all subrecipient LAP Coordinators managing language access services for specific programs is posted on the DCA website. (Contact information for DCA LAP Program Level LAP Coordinators is included in Attachment 2: CDBG-DR LAP Program Contacts)

The Program Level LAP Coordinator is the primary point of contact for the DCA LAP Coordinator and the Sandy Recovery Division leadership on language access questions related to that specific program. This individual is responsible for collecting data on LEP requests and contacts and forwarding this information to DCA as requested. The Program Level LAP Coordinator also assists their agency staff with all language access issues. If the need for language access services is identified either by phone, email, mail correspondence, or in person, staff are instructed to immediately contact their Program Level LAP Coordinator, and the DCA LAP Coordinator in turn takes appropriate action to ensure meaningful communication through the methods described in this LAP.

If, for any reason, a Program Level LAP Coordinator is not available for a particular program, center or agency, program staff should contact the DCA LAP Coordinator at the telephone/email listed above. The DCA LAP Coordinator is also available as a resource in identifying personnel for providing LEP services.

Development of a Language Bank

DCA and all subrecipients are identifying staff and contractors who are fluent in a language other than English. The DCA LAP Coordinator has developed a roster of these individuals, along with their contact names, telephone numbers, email addresses, and hours of availability. DCA's current Language Bank is included in <u>Appendix 3</u>. The DCA LAP Coordinator disseminates this list to all programs having direct contact with the public and is responsible for verifying and revising it as needed, depending on changes in staff and demand for LEP services. The Language Bank is used to support the provision of interpreter services in all locations that have regular interactions with the public. Bilingual staff members and contractors are assessed and receive regular training on the following:

- Role and responsibility of a Language Bank Interpreter;
- Interpretation ethics;
- Specialized terminology; and

Program specific information as needed.

If there are significant populations in areas where no contractor or staff fluent in the language is available, the Program Level LAP Coordinator for that location/program works with the DCA LAP Coordinator to identify locally available interpretation services. DCA will provide guidance to individuals identified in the language bank to insure the appropriate level of interaction with LEP individuals. DCA recognizes the use of the language bank does not supplant the need for certified translation services but augments the availability of immediate LEP services.

The DCA LAP Coordinator is responsible for updating and monitoring the language bank. The DCA LAP Coordinator coordinates with the appropriate human resource staff and DCA management to ensure the Language Bank is up-to-date and reflects the most recent staffing changes for all bilingual DCA employees, contractors, Housing Recovery Center staff, and subrecipient staff that have direct contact with the public.

"I Speak" Cards

In order to further identify the LEP individuals seeking access to CDBG-DR funded services, programs and activities, DCA and its subrecipients are using language identification cards or "I Speak" cards when engaging in direct contact with the public. Housing Recovery Center staff is trained in the use of "I Speak" cards to identify the language needs of visitors.

A version of the "I Speak" Card that all Outreach staff and Housing Recovery Center staff have on hand is included in Appendix 6.

Provision of Language Access Services

All CDBG-DR programs with direct contact with the public are responsible for providing written or oral language services.

For oral encounters, program staff has access to a "Language Line" that can interpret program information into the applicant's native language. The program applicant will identify him/herself as an LEP individual. By way of this designation, public facing program staff is instructed to call a toll free number and assist applicants with the help of the telephone operator and interpreters available through this service. The toll-free language line number is 1-800-822-5552.

DCA provides access to in-person interpreters for Spanish, specifically in all the Housing Recovery Centers. Housing Recovery Centers have at least one housing advisor who is bilingual in Spanish and English on staff. In Essex County, there is also one housing advisor who is bilingual in Portuguese and Spanish.

DCA has in-house staff to provide written translation services in Spanish. For the other 10 languages, a state contracted entity provides translation services on demand for DCA and its subrecipient partners. The contact information of the approved contractor will be provided to all subrecipient agencies and updated as needed.

Translation of Vital Documents

All documents defined as "vital documents" will be translated into Spanish. Vital documents will be made available in the other 10 languages upon request. A "vital document" is defined as a document that includes information regarding program eligibility requirements, applications and instructions, program eligibility determinations, and appeals procedures. DCA will define vital documents by program, upon approval of this LAP. Upon this determination, DCA will incorporate this information in all policies and procedures and training documents for DCA staff, contractors and subrecipients.

Public Hearings and Citizen Participation Periods

All written materials requesting input and participation from the public for any CDBG-DR related activity will be translated into Spanish. These documents will also be made available in the other 10 languages upon request. This includes materials distributed during Citizen Participation periods when Substantial Action Plan Amendments are being considered. A "language disclaimer" is included at the bottom of all printed materials intended for public outreach. This "language disclaimer" can be found in the sample document included in Appendix 7.

Notices of public hearings will be translated into Spanish and made available in the other 10 languages upon request. Notices of public hearings will also indicate that interpreters in any one of the 11 languages can be made available upon request to attend the public hearings to provide interpretation services to attendees. This includes public hearings about CDBG-DR programs as well as public hearings regarding Substantial Action Plan Amendments.

Updating Sandy Recovery Websites

DCA will combine the DCA Sandy Recovery website and the reNewJerseyStronger website into one website that will be available in English and Spanish. The Sandy Recovery Websites will include the following notice in the other 10 languages:

"If English is not your primary language, you may request language translation services for Sandy Recovery documents that are available to the public. These language translation services are available free of charge. If you need more information about translation services, please call 1-855-SANDYHM (1-855-726-3946). When the agent answers the line, inform them of the appropriate language. The agent will either be able to immediately connect you with an interpreter or arrange for an interpreter to return your call at your convenience."

DCA will also update the websites to include the name and contact information of the DCA LAP Coordinator in the 11 languages identified in the Four Factor Analysis. Additionally, the Spanish translations of vital documents will be posted on these websites, as appropriate, and will be updated every time the English information on the website is updated. For recipients needing translation in languages other than Spanish, translation services will be made available upon request. As outlined in the LEP Four Factor Analysis, DCA reserves the right not to translate a certain document into a particular language if it is determined that the overall cost to the program far outweighs the benefits.

The New Jersey Housing Resource Center that lists all available units supported with CDBG-DR funding through HMFA and DCA will be available in both <u>Spanish</u> and <u>English</u>. The database provides information on affordable rental properties across New Jersey (within and outside the nine counties) for individuals seeking rental units, tenant based rental assistance (TBRA), and/or project based vouchers.

The tool provides detailed information about rental properties, enabling individuals and families searching for housing to locate a unit that best fits their needs. The site also provides a tool for rent calculations, moving costs, a budget worksheet, and rental checklists.

Application deadlines, legal notices for Release of Funds and Finding of No Significant Impact (FONSI), and Citizen Participation Notices will be published, at a minimum, in Spanish on DCA's website, in select Spanish weekly papers, and in the general circulation daily publications to ensure the broadest possible public access. Legal notices will be published, at a minimum, in both Spanish and English in general circulation daily newspapers.

Subrecipient Language Access Plans

All DCA CDBG-DR subrecipients will be required to adopt this LAP. DCA will monitor subrecipients to ensure that they are following the terms of this LAP and related guidance materials and are taking reasonable steps to provide meaningful access to LEP persons for the subrecipients CDBG-DR funded programs. Program level LAP Coordinators will be responsible for reporting, at a minimum, the quantity and types of LEP services provided, based on their record of language access services, to the DCA LAP Coordinator on a monthly basis. The DCA LAP Coordinator will review this information to determine the subrecipient's compliance with Title VI, Executive Order 13166 and DCA's policy on providing language access services.

Complaints and Appeals

Any person that feels that DCA is not in compliance with Title VI of the Civil Rights Act of 1964, 42 U.S.C. 2000(d) and Executive Order 13166 regulations may file a complaint with the DCA LAP Coordinator if they believe they have been denied the benefits of this LAP. The program level LAP Coordinator may be the first point of contact for any complaints or appeals, but the DCA LAP Coordinator must be informed of all complaints and appeals and will provide oversight of the complaint/appeal resolution. Complaints will be investigated pursuant to DCA's Complaint procedures. To file a complaint with the DCA LAP Coordinator, submit the written complaint to:

LEP program applicants wishing to appeal eligibility or other programmatic decisions may also contact the Program Level LAP Coordinator directly for their specific program (DCA, EDA, DEP, HMFA and NJRA). The Program Level LAP Coordinator will provide an interpreter to assist the applicant with the appeals process and notify the DCA LAP Coordinator of the appeal. DCA and subrecipients will leverage the language line service and bi-lingual staff to provide interpretation services as needed for all appellate processes, all meetings related to program eligibility determinations and all meetings with contractors and subcontractors. Program applicants will have access to interpretation services throughout the process (rebuilding, loans for rehabilitation, identification of rental units, etc.) until they have successfully completed the process.

The public and advocacy groups will be notified that language assistance is available for appeals if an LEP individual's application for disaster recovery services is deemed ineligible. This information will be posted in the Housing Recovery Centers as well as in EDA, DEP, and HMFA offices, and on the Housing Resources website.

Data Collection and Reporting

To facilitate the tracking of requests for language assistance received for all CDBG-DR programs, DCA has developed the functionality to document if an applicant is LEP and if so, the language with which s/he requires assistance within DCA's Sandy Integrated Recovery Operations and Management System (SIROMS) system. Reporting on this field is mandatory for all programs subject to LAP requirements including all DCA, EDA, DEP, and HMFA programs with services provided directly to the public (individuals and businesses). The LAP Coordinator will collect the language assistance data for all programs on a monthly basis. The data will be used to ensure that all programs are in compliance with asking about LEP need (or lack thereof) as well as to identify trends or high occurrence of needs within different programs and/or geographic areas.

TRAINING STAFF

DCA is implementing a training program with the following four components:

- 1. LEP Awareness and LAP Protocol
- 2. LAP and LEP Issues Training
- 3. Guidance and Technical Assistance for Subrecipients
- 4. Training on LEP and LAP Compliance and Monitoring of State Agency Subrecipients

LEP Awareness and Current Protocols

Training on LEP awareness and current protocols was developed for all Sandy Recovery staff having contact with the public. This training was conducted as in-person training with the option for teleconference participation by DCA Sandy Recovery staff, Housing Recovery Center staff, and subrecipient/contractor staff. The goal of this mandatory training was to provide an overview of the LEP individuals within the Sandy Recovery Program and the state and federal regulations regarding language access. The training also explained DCA language access procedures.

LAP and LEP Issues Training

Training on LAP and LEP issues will be developed for all DCA Sandy Recovery staff, Housing Recovery Center staff, contractors and subrecipient staff who have direct contact with the public. DCA will develop two mandatory training courses for LAP and LEP issues: Basic LEP/LAP and Advanced LEP/LAP. Sandy Recovery staff that does not frequently come into contact with the public will receive only the Basic LEP/LAP training. Sandy Recovery staff that frequently interacts with the public, such as Housing Recovery Center managers and HUD certified counselors will receive Advanced LEP/LAP training. In addition to creating the LEP/LAP courses, DCA will also develop and deliver training specifically for the individuals in DCA's Language Bank. A summary of the training curriculum details are below:

- Basic LEP/LAP Training will cover an overview of the definition of LEP persons, overview of the state and federal regulations governing language access, roles and responsibilities of Sandy Recovery staff, DCA language access procedures, and the LAP complaints/appeals process.
- Advanced LEP/LAP Training will cover an overview of the definition of LEP persons, overview of
 state and federal regulations governing language access, basic customer service skills and telephone
 etiquette, cultural sensitivity, roles and responsibilities of Sandy Recovery staff, how to identify the
 language needs of an LEP individual, DCA language access procedures, how to track the use of
 language services, and the LAP complaints/appeals process.
- Language Bank Training will cover an overview of the role and responsibility of Language Bank Interpreters and translation and interpretation ethics.

DCA is incorporating LEP awareness and LAP protocol modules in new hire orientation offerings for all new Housing Recovery Center staff, as well as DCA Sandy Recovery employees who come in contact with the public. Training will also be created for bilingual Housing Recovery Center staff. Trainings will be conducted at locations throughout the State to insure full participation of staff. Staff will be informed of upcoming training with the exact date, time and location of training. All trainings will be overseen by the DCA LAP Coordinator. Upon completion of the training, the trainer will provide a list of the staff in attendance to the DCA LAP Coordinator.

Guidance and Technical Assistance for Subrecipients

Guidance and technical assistance training in providing language access services will be developed for subrecipient staff that frequently interacts with the public. Additionally, training will be created specifically for Program LAP Coordinators and cover topics such as roles, responsibilities, and data collection. This assistance and guidance will cover an overview of the state and federal regulations governing language access, advanced LEP/LAP training, and Program LAP Coordinator roles and responsibilities.

Training on LEP and LAP Compliance and Monitoring of State Agency Subrecipients
Training for DCA Compliance and Monitoring staff responsible for monitoring subrecipients will be
developed. DCA will monitor whether its subrecipients have taken reasonable steps to provide
meaningful access to LEP persons. This in-person training will cover components of a meaningful
language access plan, LAP file review, LAP reporting requirements, and the LAP complaints/appeals
process.

PROVIDING NOTICE TO LEP INDIVIDUALS

DCA and its subrecipients will provide notice to LEP individuals of their eligibility for benefits, programs, and services in a language they understand, to the maximum extent practical. All correspondence from DCA related to CDBG-DR programs which impact individuals and small businesses that are sent to prospective or existing applicants includes a provision indicating that free language interpretation services are available by contacting a toll free number that serves LEP persons in the appropriate language. In addition to individuals, LEP small business owners will also be provided language interpretation services when specifically requested. The Sandy websites have posted information about how to obtain language access services as an LEP person. The Housing Recovery Centers have posted language access information in conspicuous locations and in multiple languages the availability of language access services.

DCA has developed an **LEP and LMI Outreach and Marketing Plan** that will ensure that all the LEP communities in the nine most impacted counties receive, via a variety of mediums, notification about all of the open CDBG-DR funded programs where funds and/or units may be available to them. These programs include the LMI Homeowners' Rebuilding Program, Lead Hazard Reduction Program, Tenant Based Rental Assistance Program, Landlord Incentive Program, Neighborhood Enhancement Program, Sandy Special Needs Housing Program, and rental units developed by HMFA's Fund for Restoration of Multi-Family Housing Program and the Landlord Rental Repair Program.

All outreach efforts will be culturally appropriate and utilize demographic data to ensure campaigns are reflective of and targeted towards the specific needs of the LEP communities throughout the region. DCA aims to ensure that all outreach efforts are timely, relevant and offered via multiple mediums. The specific outreach efforts DCA will conduct are outlined in detail in DCA's LEP and LMI Outreach and Marketing Plan.

All outreach materials are translated into Spanish and include a notice in the other identified languages stating that language assistance services are available in these languages upon request. DCA is also providing translations of outreach materials in languages other than Spanish, as appropriate, when outreach efforts are targeted towards LEP communities and applicants of CDBG-DR funded programs and it is applicable to provided translations in other languages.

DCA and its contracted communications experts will provide outreach services to LEP populations. All teams working on outreach will report directly to the DCA LAP Coordinator on a regular basis regarding specific LEP outreach activities and numbers of LEP individuals contacted (as available). DCA will regularly assess and maintain an accurate record of language assistance services, in order to improve LEP outreach programs and activities in accordance with customer need and program resources and capacity.

MONITORING, EVALUATING AND UPDATING THE LAP

On an annual basis, DCA will update this LAP to reflect any change in the plan based on the prior year's activity, as needed. DCA will update the LAP to ensure relevancy and quality control of language access services. As part of this monitoring and evaluation effort, DCA will review procedures for providing

language access services, existing training programs, outreach activities, the Language Bank, and the language access data to periodically update the language access program. The DCA LAP Coordinator and the Sandy Recovery Division Assistant Director for Compliance and Monitoring are jointly responsible for monitoring, evaluating and updating the language access program for all CDBG-DR programs. This LAP is a living document that, through monitoring and evaluation, can be updated as the needs of the LEP population and the demands on DCA to service this population evolve.

This monitoring and evaluation may include, but is not limited to the following:

- Observing and evaluating agency interactions with LEP individuals
- Keeping current on LEP community demographics and needs by annually reviewing census data and engaging school districts, faith communities, refugee resettlement agencies and other local resources
- Considering new resources, including funding, collaborations with other agencies, human resources, emerging technologies and other mechanisms for ensuring improved access for LEP individuals

Additionally, DCA will update their database to reflect data collected on LEP individuals who request language access services. DCA may leverage these data to determine the frequency with which LEP individuals are encountered and the types of language access services required.

DCA will maintain a monitoring file on each subrecipient including the following information:

- Documentation of LEP guidance and/or technical assistance provided by DCA;
- Number of LEP individuals/businesses serviced and the services provided; and
- Number of appeals and resolution

APPENDICES

Appendix 1: Definitions

DCA: The New Jersey Department of Community Affairs.

DCA LAP Coordinator: DCA employee responsible for overseeing and implementing the terms of the LAP.

Federal Financial Assistance: This includes (1) grants, loans, and advances of federal funds, (2) the grant or donation of federal property and interests in property, (3) the detail of federal personnel, (4) the sale and lease of, and the permission to use federal property or any interest in such property without consideration or at nominal consideration, or at a consideration which is reduced for the purpose of assisting the Recipient, or in recognition of the public interest to be served by such sale or lease to the Recipient, and (5) any federal agreement, arrangement, or other contract which has one of its purposes the provision of assistance. The term "Federal financial assistance" does not include a contract of insurance or guaranty. 24 C.F.R. § 1.2(e).

Housing Advisor (HA): Sandy Recovery Division employees who process grant applications.

Housing Counselor (HC): Employees of HUD-approved housing counseling agencies that provide housing counseling services to existing and prospective applicants.

Housing Recovery Centers (HRCs): The Housing Recovery Centers operated by DCA to provide information and assistance for applicants regarding CDBG-DR funded programs.

HUD: The United States Department of Housing and Urban Development.

Interpreter: A person who translates orally from one language into another.

Limited English Proficient (LEP) Persons: Persons who have a limited ability to read, write, speak, or understand English, and may be entitled to language assistance with respect to a particular type of service, benefit, or encounter.

Language Assistance Plan or Language Access Plan (LAP): A written implementation plan that addresses identified needs of the LEP persons they serve. Recipients should have a process for continuously monitoring and updating the Plan.

Nine Most Impacted Counties: In the State of New Jersey the county jurisdictions of Atlantic, Bergen, Cape May, Essex, Hudson Middlesex, Monmouth, Ocean and Union that suffered from Superstorm Sandy damage.

Program LAP Coordinator: Subrecipient representative tasked with reporting to DCA LAP Coordinator, LEP and LAP request, complaints and appeals.

Recipient(s): The State of New Jersey and the New Jersey Department of Community Affairs, collectively.

Sandy or Superstorm Sandy: The storm that made landfall in New Jersey on or about October 29, 2012.

Subrecipient: Per the VCA the following agencies are subrecipients; the New Jersey Redevelopment Authority, the New Jersey Housing and Mortgage Finance Agency, the New Jersey Economic Development Authority, and the New Jersey Department of Environmental Protection.

Translator: A person who translates written text from one language into another.

Vital Document: Any document that is critical for ensuring meaningful access to DCA's and its subrecipients' major activities and programs by beneficiaries generally and LEP persons specifically.

Appendix 5: LEP Four Factor Analysis

Introduction

The New Jersey Department of Community Affairs (DCA) is responsible for administering Community Development Block Grant Disaster Recovery (CDBG-DR) funds in the nine counties most impacted by Superstorm Sandy including Atlantic, Bergen, Cape May, Essex, Hudson, Middlesex, Monmouth, Ocean, and Union counties.

Pursuant to the non-discrimination requirements of Title VI at 24 CFR 1.4, DCA must take steps to ensure meaningful access for Limited English Proficient (LEP) individuals to federally funded DCA programs and activities. As described in HUD's 72 FR732, the starting point for ensuring meaningful access is a four-factor analysis that takes into account the:

- 1) number or proportion of LEP persons in the eligible service population,
- 2) frequency with which LEP individuals come in contact with the programs,
- 3) nature and importance of the service provided by the programs, and
- 4) resources available to the recipient and costs

DCA undertook a four-factor analysis to identify the needs of LEP persons throughout the nine most impacted counties. The findings are presented here and are being used to inform DCA's Language Access Plan³ (LAP) and outreach efforts to ensure that LEP individuals have meaningful access to CDBG-DR funded programs.

Definition of LEP Persons

LEP is defined as persons who have a limited ability to read, write, speak, or understand English, and may be entitled to language assistance with respect to a particular type of service, benefit, or encounter. DCA used the American Community Survey and Migration Policy Institute's definition to define LEP persons as any individual who reported speaking English "not at all", "not well" or "well." Persons who speak only English or who report speaking English "very well" are considered proficient in English.

Four-Factor Analysis

1. The number or proportion of LEP persons served or encountered in the eligible service population

All data used to estimate the proportion of LEP persons in the nine county service area comes from the Census Bureau's American Community Survey (ACS) 3-year file (2009–2011) – Table "B16001: Language Spoken at Home by Ability to Speak English for the Population 5 Years and Older." DCA received a file prepared by the Migration Policy Institute, from HUD's Office of Fair Share Housing and Equal Opportunity (FHEO), which provides county level ACS estimates of the LEP population by language spoken. Estimates in the file were rounded to the nearest hundred. This is reflected in Tables 1 and 2 below.

For all counties in New Jersey, including the nine most impacted, no LEP population other than Spanish speakers exceeds 5% of the county's population. Each county, however, with the exception of Cape May, has more than 1,000 individuals that speak a language other than English or Spanish. Bergen

³ Note: the VCA calls the LAP the Language Assistance Plan. In line with Federal rules and guidance, DCA refers to the LAP as the Language Access Plan.

County has the most, with 18 different languages meeting the threshold. Across the nine counties, there are 24 languages that meet the threshold (see Table 1).

As illustrated in Table 2, DCA is focusing its efforts to provide meaningful access to the top three foreign language speaking populations in each of the most impacted counties. This includes 11 different language speaking populations. DCA will also provide language access services to foreign language speaking populations that do not constitute the top 3 in the county but are one of the 11. For example, in Essex County, there is a small LEP population that speaks Gujarati (600 individuals). Even though Gujarati is not one of the top three languages in Essex County, DCA will provide the 600 LEP individuals with language access services upon request.

Notably, DCA worked with FHEO to determine how many languages to focus on in its LAP. DCA observed that the fourth highest LEP population in each county does not exceed 1% of the total population. Based on this analysis of the data, DCA and FHEO met on June 23, 2014 and agreed that DCA would focus on the top three languages in each county where the specific LEP population is equal to or exceeds 1,000 people. Moreover, this focus is consistent with the Voluntary Compliance Agreement (VCA) entered into between DCA, FHEO, the Latino Action Network, New Jersey State Conference of the National Association for the Advancement of Colored People, and the Fair Share Housing Center.

DCA has also compiled data on the top three LEP populations in the nine most impacted counties at the Census tract level. The total number of LEP individuals, the percentage of low moderate income (LMI) individuals, and the total number of units that sustained major or severe damage in each census tract by county are included in Appendix 2. The maps included in Appendix 1 visually illustrate this information

with shading to represent the relative cumulative percentage of LEP individuals in each tract. The cumulative percent ranges are as follows:

- 1. 0%
- 2. >0% to 25%
- 3. >25% to 50%
- 4. >50% to 75%
- 5. >75% to 100%.

This allows DCA to analyze where the greatest number of LEP individuals by language are located in each county. DCA is also taking into account those census tracts with a high concentration of LMI populations and where damage was sustained as it plans its LEP outreach. For further explanation regarding the cumulative percentage methodology, refer to Appendix 3.

- 2. The frequency with which LEP individuals come into contact with the programs CDBG-DR programs address the long-term needs of New Jersey's Sandy-impacted residents and communities by providing direct assistance to homeowners, tenants, developers, landlords, businesses and local governments. The frequency with which LEP individuals interact with a program will depend on the nature of the program. Of particular importance will be those instances when DCA or one of its subrecipients is providing a direct service to an individual, business or household. For example, homeowners, renters, rental property owners, and small business owners who apply for various CDBG-DR programs are likely to have frequent contact with the program. This may include such interactions as filing applications, meetings with advisors to review applications, initial site inspections, approval of final construction designs, preconstruction meetings, and submission of receipts and proof of construction work. For these programs, DCA's strategy will ensure that these populations have meaningful access throughout the process.
- 3. The nature and importance of the program, activity, or service provided by the programs The more important the activity, information, service, or program, or the greater the possible consequences of the contact to the LEP persons, the more likely language services may be needed.

Those programs that provide a means of helping individuals obtain or get back into damaged housing, are critically important to LEP individuals. There remains significant need to support the replacement and development of multifamily housing to serve renters who were displaced by Superstorm Sandy. There is an urgent need to expand the supply of affordable housing, to stimulate economic activity, and to replace housing stock lost to the storm. The importance of CDBG-DR programs for homeowners, landlords, and renters, including LEP individuals has been demonstrated by the response to already active programs and the waiting lists that have developed. LEP outreach will focus on the programs that provide critical services to homeowners, landlords and renters.

4. The resources available to DCA and costs

DCA is taking all reasonable steps to provide meaningful access for LEP persons to DCA CDBG-DR programs and activities. The availability of resources, however, may limit the provision of language services in some instances. "Reasonable steps" may cease to be reasonable where the costs imposed substantially exceed the benefits. DCA's LEP and LMI Outreach and Marketing Plan will balance the needs of the LEP community with the funding resources available.

Activities aimed at providing meaningful access to the LEP population will be incorporated and funded across all of the CDBG-DR programs outlined in its Action Plans as well as the new programs outlined in the VCA:

- \$240 million for existing programs to assist renters, including \$200 million which is planned as part of the third allocation of funding and \$40 million from existing programs where needs will otherwise not be met or are not as substantial.
- The new \$40 million LMI Homeowners Rebuilding program detailed in the State's Substantial Amendment #7 to the Action Plan with an initial \$10 million set-aside for mobile homeowners.
- \$15 million for tenant-based rental assistance in addition to the \$17 million already proposed by the State.

In addition, DCA has committed \$2 million for extensive outreach to LMI homeowners and renters of which LEP individuals will likely overlap.



Attachment 3: Further Explanation of Cumulative Percentage Map Methodology Representing the cumulative percentage of LEP individuals in each county by census tract allows DCA to begin to identify where the greatest number of LEP individuals are located in each county. This will help DCA to better and more efficiently plan outreach efforts.

In order to identify where LEP populations reside within each county, Census tracts were sorted by language from least number of speakers to greatest number of speakers. Those tracts with zero speakers are highlighted in grey on the maps.

In order to identify where the greatest number of LEP individuals live within a county, the census tracts were organized in order from least number of LEP individuals of a particular language to most and the cumulative percentages calculated (this was done separately for each language). Based on the cumulative percent calculation, tracts were divided into 5 groups:

- Tracts with no speakers;
- Tracts with the fewest speakers (i.e. those with a cumulative percent >0-25%)
- Tracts with the 2nd fewest speakers (i.e. cumulative percent >25-50%)
- Tracts with the 3rd fewest speakers (i.e. cumulative percent >50-75%)
- Tracts with the most speakers (i.e. cumulative percent >75%)

There are more tracts in the lowest quartile group (>0-25%) than there are in any other group, because each tract in that group has fewer speakers than the tracts in the subsequent groups. Conversely, there are fewer tracts in the highest quartile group, because each tract in that group has more speakers than any of the preceding groups.
