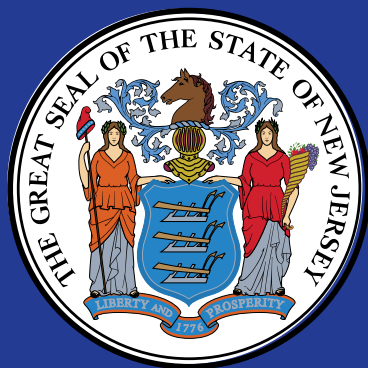

## DIVISION OF CODES AND STANDARDS

The **Division of Codes and Standards** establishes and enforces building codes, in partnership with the state's municipalities, to protect the health and safety of residents. The Division houses the Bureau of Housing Inspection; implements construction codes including building, plumbing, fire protection, radon subcodes, asbestos and lead abatement; and oversees carnival/amusement ride inspections, LP gas installations, rooming and boarding house licenses, and the State's New Home Warranty Program.

<b>Type of Assistance:</b>	 
<b>Description:</b>	Provides information to owners of planned residential real estate including condominiums, cooperatives, single-family homes, or townhouses with owner-controlled associations, about their rights concerning access to financial records, open public meetings and alternate dispute resolution.
<b>Other Information:</b>	Technical assistance is offered to attorneys and members of boards to establish alternate dispute resolution procedures. Information is also provided regarding sample bylaws for associations.

## CONDOMINIUM AND COOPERATIVE CONVERSION SENIOR CITIZENS AND DISABLED PROTECTED TENANCY

<b>Type of Assistance:</b>	  
<b>Description:</b>	Monitors procedures established by law and protects eligible senior citizens and disabled persons from eviction when their buildings are converted to condominium or cooperative forms of ownership. Receives forms from tenants seeking Protected Tenancy.
<b>Assistance Provided:</b>	Supplies forms and information on procedures to be followed in applying for Protected Tenancy. Assists municipalities and counties in developing their administrative processes.
<b>Assistance Provided To:</b>	Landlords, tenants, counties, municipalities, attorneys, and purchasers and sponsors of condominium and cooperative housing.

## CONTINUING CARE RETIREMENT COMMUNITIES

<b>Type of Assistance:</b>	
<b>Description:</b>	Reviews required documents adding a layer of protection for residents of continuing care retirement communities from a provider becoming insolvent or unable to provide responsible care.
<b>Other Information:</b>	The provider is required to obtain a Certificate of Authority to operate the facility by filing an application for certification that contains a number of affidavits, legal description of the facility, the condition of title, extensive financial information, health program disclosure, proof of compliance with applicable governmental regulations, and brochures used for advertising and promotional purposes.
<b>Assistance Provided To:</b>	Providers and current/potential residents of continuing care retirement communities.

## NEW HOME WARRANTY PROGRAM

## Type of Assistance:



## Description:

Requires all builders of new homes in New Jersey to be registered with the Department. Registration is renewable every two years, and a warranty is required for every new residential unit that is sold within the state.

## Other Information:

Builders must enroll in one of several Warranty Insurance Plans. A number of private plans, as well as one offered by the State, are currently available.

## Assistance Provided To:

All home building entities engaged in the construction of new single family, duplex, condominium or cooperative units and all purchasers of new units seeking assistance.

## PLANNED REAL ESTATE DEVELOPMENT

## Type of Assistance:



## Description:

Provides consumer protection by requiring disclosure of pertinent information regarding retirement communities, condominiums, cooperatives and other developments in which common elements are shared.

## Other Information:

The developer is required to register with the Division and file an application for registration containing a variety of exhibits concerning the legal status of the property, condition of title and financial information, as well as brochures used for advertising and promotional purposes. Developers must apply and become registered before offering units for sale.

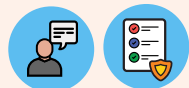

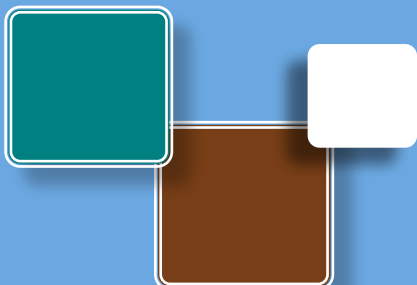

## AFFORDABLE HOUSING TRUST FUND

The Affordable Housing Trust Fund Program provides municipalities, for-profit and non-profit developers with financial assistance to spur the development of affordable housing across the state. These affordable housing developments have the potential to not only provide high-quality, much-needed housing for NJ citizens, but also to strengthen neighborhoods and stimulate economic development across the state. With this allocation of the Affordable Housing Trust Fund, the NJ Department of Community Affairs (DCA) seeks to support municipalities with court-sanctioned affordable housing settlements in creating needed housing, to build on existing assets and collaborations by funding projects that leverage other state or local investments and public-private partnerships to increase the impact of these funds, and to support innovation and projects that maximize impact.

## NEW JERSEY NATIONAL AFFORDABLE HOUSING TRUST FUND

## Type of Assistance:



## Description:

The National Housing Trust Fund (HTF) is exclusively targeted to help build, preserve, rehabilitate, and operate housing affordable to people with the lowest incomes. In 2016, the first \$174 million in HTF dollars were allocated to states. To date, the states have received over \$1.2 billion in HTF funds. The HTF is the only federal housing program exclusively focused on providing states with resources targeted to serve households with the clearest, most acute housing needs.

## Funding Source:

Because the HTF is funded outside of the appropriations process, it has no cost to the federal government. By statute, the initial source of funding for the HTF is a slight fee (0.042%) on Freddie Mac and Fannie Mae activity, only 65% of which goes to the HTF.

Non-profit or For-profit Affordable Housing Developers that demonstrate strong financial, organizational, and development capacity.

**UNIVERSAL SERVICE FUND (USF)****Type of Assistance:****Description:**

The Universal Service Fund (USF) Program was created by the New Jersey Board of Public Utilities (NJ BPU) to help keep energy affordable for low-income households. USF provides monthly credits on residential electric and natural gas costs. USF keeps energy costs between two and four percent of annual income, up to a cap of \$180 per month for gas and electric combined. To be eligible for USF, a household must have an electric or gas account in a household member's name and gross household income at or below 60 percent of the State Median Income (approximately \$7,676 per month for a family of four). Customers can apply for USF and LIHEAP with the same application.

## WINTER TERMINATION PROGRAM

**Type of Assistance:****Description:**

The Winter Termination Program (WTP) protects specific categories of customers from having their water, wastewater, gas or electric shut off between November 15 and March 15 of each year. These categories include: 1) Lifeline Credit Program; 2) Home Energy Assistance Program (HEAP); 3) Temporary Assistance to Needy Families (TANF); 4) Federal Supplemental Security Income (SSI); 5) Pharmaceutical Assistance to the Aged and Disabled (PAAD); 6) General Assistance (GA) benefits; 7) Universal Service Fund (USF); or 8) Persons unable to pay their utility bills because of circumstances beyond their control. Such circumstances shall include, but shall not be limited to, unemployment, illness, medically related expenses, recent death of an immediate family member, and any other circumstances, which might cause financial hardship. Customers should make every effort to apply for utility assistance and pay their bill during WTP to avoid a large overdue balance at the end of WTP. Service cannot be disconnected during this period.

Between November 15 and March 15 of each year.

Created in 1978, the ROID program offers two grants to assist municipalities and counties in delivering both short-term special events and comprehensive recreational services for individuals with disabilities. ## NEIGHBORHOOD REVITALIZATION TAX CREDIT (NRTC)

### Type of Assistance:



### Description:

The Neighborhood Revitalization Tax Credit Program (NRTC) is designed to foster the revitalization of New Jersey's distressed neighborhoods. NRTC offers business entities a 100 percent tax credit against various New Jersey state taxes. Credits are provided to business entities that invest in the revitalization of low- and moderate-income neighborhoods in eligible cities. Sixty percent of the tax credit funds must be used for activities related to the development of housing and economic development. The remaining balance may be used for complementary activities such as the provision of assistance to small businesses, removing barriers to self-sufficiency, and promoting the integration of mixed-income neighborhoods. A total of \$15 million per year is available in tax credits.

NRTC funds are used by neighborhood-based non-profit organizations that have prepared, submitted and received approval from the Department for a revitalization plan for the neighborhood it serves. The funds must be used by the eligible organizations for projects and activities that will implement the goals and strategies of the approved neighborhood plan. The maximum amount per application is \$1,000,000.

The Neighborhood Preservation Program (NPP) began with the passage of the “Maintenance of Viable Neighborhoods Act” in 1975. This legislation established a program of grants to encourage and promote the social and economic strengthening and development of principally residential neighborhoods. It was envisioned that this would be achieved through the cooperative, concentrated efforts of residents, local lending institutions, businesses, municipal governments, and the State of New Jersey. In 2019, after a hiatus of several years, NPP restarted anew with a focus on revitalizing mixed-use districts, commercial corridor neighborhoods and downtowns.

## LOCAL FINANCE BOARD

The Local Finance Board is a statutorily created body with the overall responsibility for promulgating rules and regulations on the fiscal operations, fiscal reporting and fiscal conditions of all New Jersey municipalities, counties, local authorities and special districts. It has specific statutory authority in a number of ways including: the authority to approve, reject, or conditionally approve, or to render findings on applications submitted by municipalities, counties, local authorities and special districts concerning financing and debt matters, the authority to approve the creation or dissolution of local authorities or special districts, the authority to assume fiscal control over local governments, and the authority to assist local governing bodies in financial and operational matters. The Board also is responsible for administering the Local Government Ethics Law. The director of the Division serves as the Board's chairperson. Other members are nominated by the Governor and confirmed by the State Senate.

# DIVISION OF DISASTER RECOVERY AND MITIGATION

The **Division of Disaster Recovery and Mitigation** promotes the long-term resilience of New Jersey's communities by supporting initiatives to fortify housing, neighborhoods, and infrastructure against severe weather events and flooding damage. The Division also manages the majority of the federal funds used to assist the state in recovering from Hurricane Ida and Superstorm Sandy. These funds come from the Community Development Block Grant Disaster Recovery (CDBG-DR) programs of the U.S. Department of Housing and Urban Development (HUD).

HUD approved the state of New Jersey's Hurricane Ida Action Plan on how it will use CDBG-DR funds for Ida recovery. The Division launched several Hurricane Ida recovery programs in the first quarter of 2023 and will launch additional programs.

The Division is also the grant manager for the Coronavirus State Fiscal Recovery Fund (SFRF) and the Coronavirus Capital Projects Fund, allocated to New Jersey through the American Rescue Plan Act. SFRF monies are designed to help address the COVID-19 public health emergency and its effects on the economy. The Capital Projects Fund provides the state with federal dollars to help communities have access to modern infrastructure. The Division is responsible for overseeing the allocation of this funding and ensuring it meets all U.S. Treasury requirements.

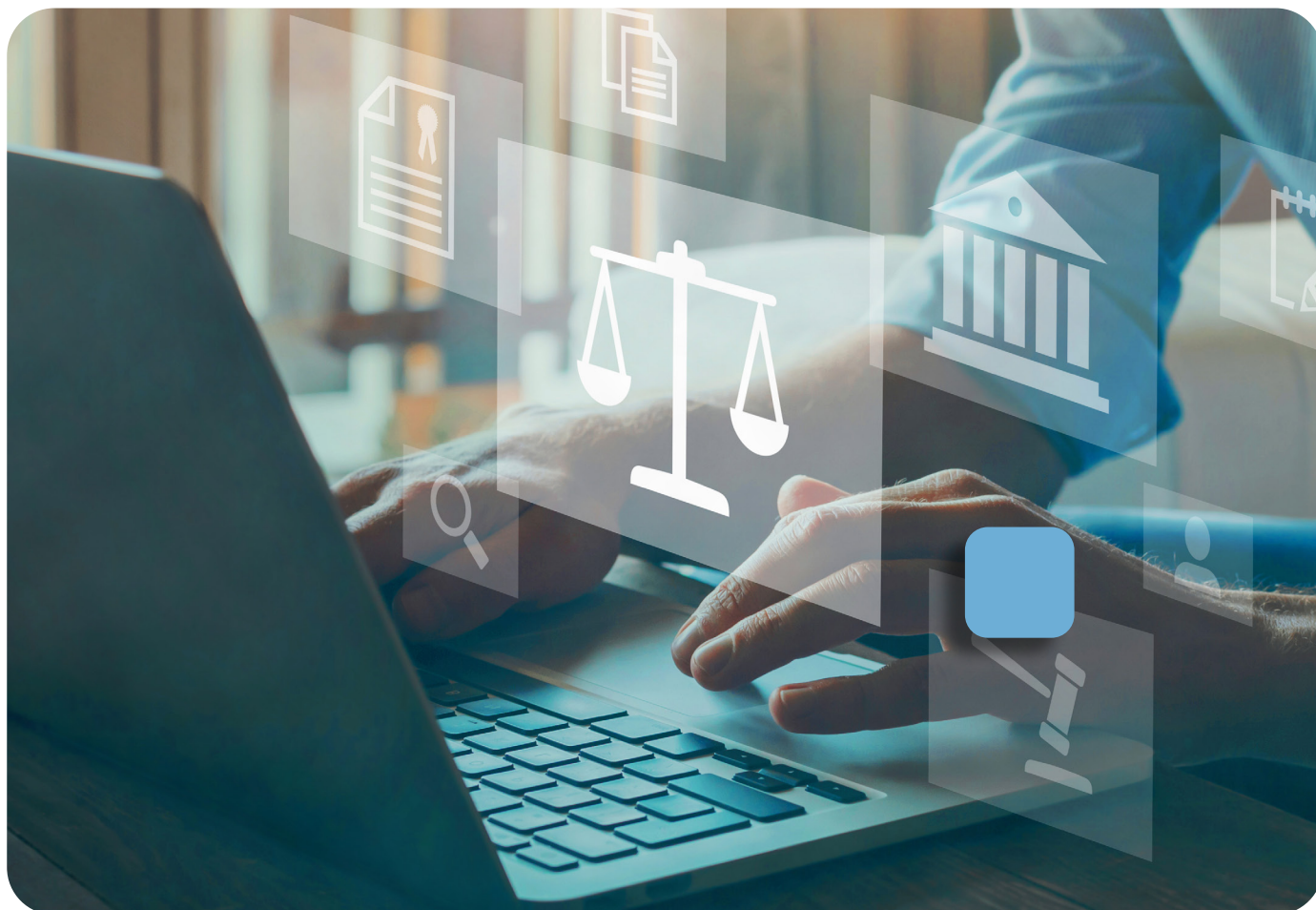

# GOVERNMENT RECORDS COUNCIL (GRC)

**The Government Records Council (GRC)** was established by the Open Public Records Act (OPRA) to govern public access to government records. The GRC assists public agencies and members of the public by providing guidance and information, as well as resolving denial of access disputes. There is no fee for services provided by this agency.

The Council comprises the Departments of Community Affairs Commissioner (or their designee), who serves as chair, plus eight (8) public members: four (4) who are initially appointed by the Governor directly, two (2) appointed directly from persons recommended by the Speaker of the Assembly, and two (2) appointed directly from persons recommended by the Senate President. Of those, no more than four (4) can be from the same party affiliation.

## The Council:

- Receives, hears, reviews, and adjudicates complaints concerning a denial of access to a government record by a records custodian;
- Maintains a toll-free helpline and an informational website;
- Establishes and maintains an official OPRA request form required to be adopted by public agencies subject to OPRA;
- Delivers training on OPRA;
- Administers an informal mediation program; and
- Issues public information about OPRA and services provided by the Council.

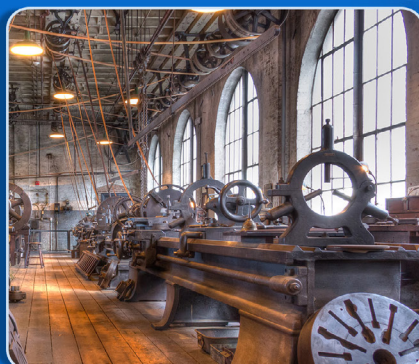

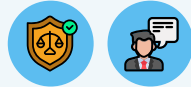

## THE LOW-INCOME HOUSING TAX CREDIT PROGRAM

HMFA is the designated tax credit allocating authority for the state of New Jersey, thereby vesting HMFA with the administrative responsibility of allocation and compliance oversight of the federal Low-Income Housing Tax Credit Program within the state.

## LOW-INCOME HOUSING TAX CREDITS

### Description:

Federal Low-Income Housing Tax Credits provide a dollar-for-dollar reduction in federal tax liability and act as a catalyst to attract private investment to the affordable housing market. The additional capital mitigates the debt burden incurred in the construction and rehabilitation development process. Per capita tax credits are available through competitive rounds each year. State regulations and the Internal Revenue Code impose minimum construction/rehabilitation requirements. Once credits are allocated, the project must maintain continuous compliance with the program for a minimum of 15 years. Affordability restrictions on rent and income are imposed for a minimum of 15 years.

HMIS serves 319 agencies and over 2300 different programs throughout all 21 counties in the state of New Jersey to deploy software, train staff, monitor data quality and assist in applying for funding opportunities. Recently, HMIS staff deployed the finger scanning bio-metric technology at five sites in four counties to perform real time information and improved data quality.

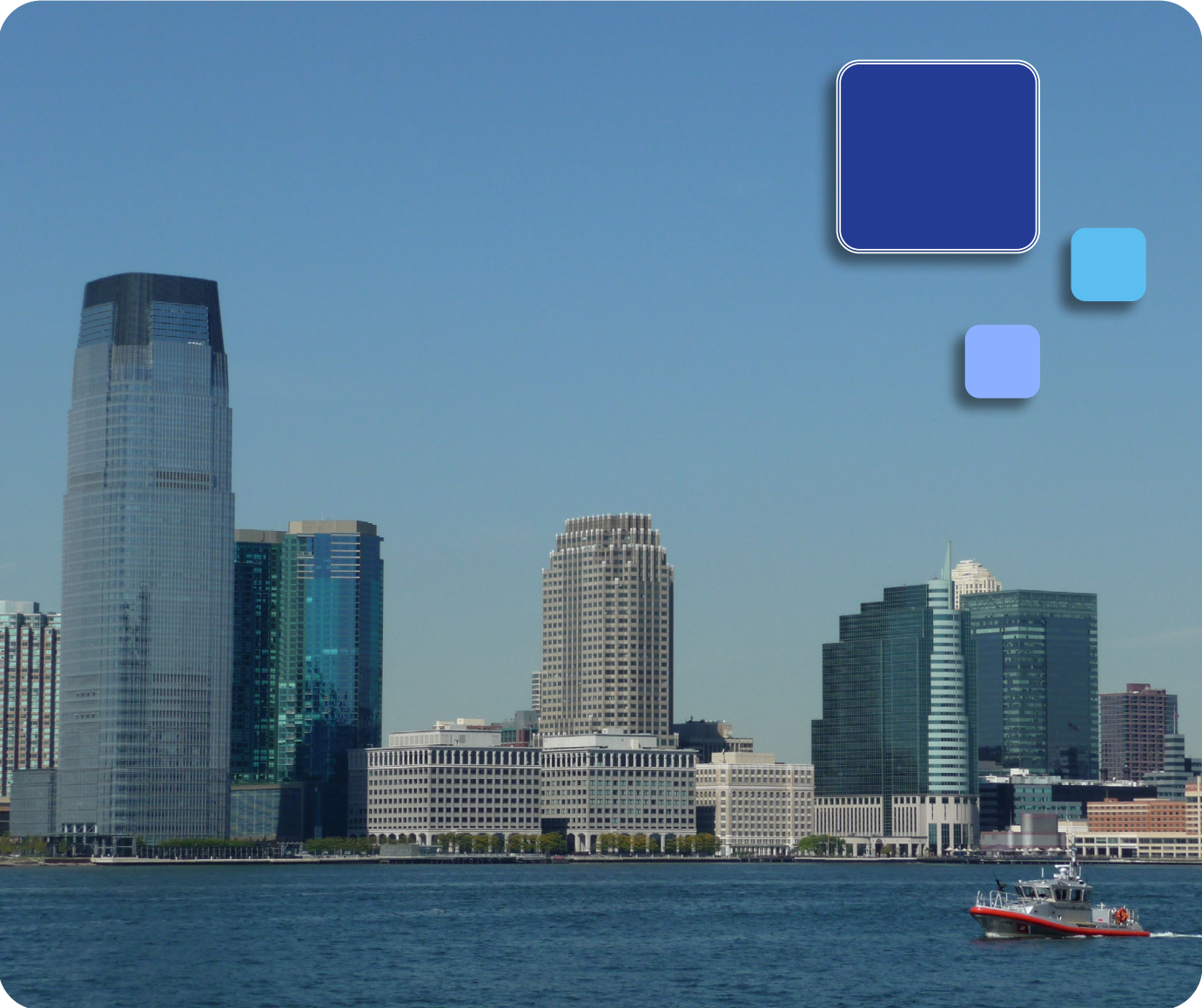

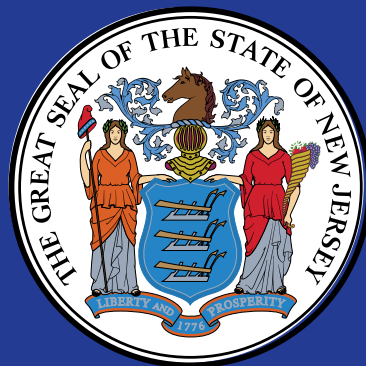
