


**CWS Referrals Assigned to Local Offices**



**Caseload Compliance (Individual Worker Level)**




**Response and Investigation Timeliness**




**Referrals to Early Intervention**



**Worker - Child Visits**







of Youth Ages 14-18 years






IAIU Investigation Timeliness




IAIU Caseload Report by Region



**Rate of Children in Care Management by Count**



**Children in Out of Home Treatment Settings**










