District and School Access to NJ4S

School and District Engagement as of Sept. 29, 2023

- Of the 1,031 schools eligible to apply for Tier 2 and Tier 3 services through NJ4S:
 - 674 (65%) have successfully provided contact information for the application system
 - 357 have not yet applied or provided incomplete information
 - 120 of the 357 restarted the survey or provided some information for follow-up by Division of Family and Community Partnership to obtain additional information



Examining the 674 Successful Schools (Survey Completers)

- These 674 schools provided 1,121 total contacts (primary/secondary)
- Of those primary and secondary contacts, 982 have a unique email addresses
- Why are unique email addresses important?
 - System Security
 - We are reaching back out to respondents who have used the same email address for multiple school buildings or for multiple districts or a combination of district and schools.
