1. Unsanitary Conditions: Sanitary conditions are not maintained at the center. The center is dirty and there may be an infestation of fleas or bedbugs.	1. At the time of the investigation sanitary conditions were maintained in all areas of the center. Interviews with the director and staff and a review of the cleaning schedules within each classroom revealed that the center is cleaned as required. The director and staff denied the allegation that the center is infested with fleas or bedbugs and stated that there were several cases of lice over the past 2 months. The parents were notified of the possible exposure, the children with lice were excluded from the program and required parents to submit a clearance from their health care provider before returning to the center. Additionally, the local public health nurse was contacted regarding the outbreak. As a result of observation, interview and documentation this allegation could not be substantiated.	1.
