## History of The New Jersey Domestic Violence Fatality & Near Fatality Review Board

The New Jersey Domestic Violence Fatality and Near Fatality Review Board (DVFNFRB) was created by individuals who were concerned about domestic violence related deaths in the state. A genesis group was formed in 1998, which coincided with the national effort to establish fatality review as an innovative method of addressing the problem of domestic violence and identifying its risk factors. An Executive Order signed in March 2000 established the New Jersey Fatality Review Board. The work began by reviewing homicide-suicides that occurred between 1994 and 1999 totaling 125 fatalities. The NJDVFNFRB evolved out of this original endeavor in 2003 and is currently focused on homicides and near death fatalities.

### Mission of the DVFNFRB

The mission of the New Jersey Domestic Violence
Fatality and Near Fatality Review Board is to
understand, intervene, and prevent domestic
violence related homicides, suicides and near
fatalities in the state. The Board conducts
multidisciplinary in-depth reviews of domestic
violence fatalities and near fatalities to prevent
future deaths. It also reports on all domestic violence
related deaths in the state. The Board attempts to
make sense of each death in its cultural context to
promote effective and sustainable safety for victims
of domestic violence.

## **Reports and Resources**

The Board has published a number of reports regarding domestic violence deaths in New Jersey, allowing us to further examine specific populations affected by Intimate Partner Violence (IPV), including IPV among African Americans, teens and immigrants.



# NJ Domestic Violence Fatality & Near Fatality R E V I E W B O A R D

Focusing on Helping Our Communities Understand, Prevent and Intervene





- Intimate partner violence affects individuals of all races, ethnicities, genders, religions, and sexual identities
- Intimate partner violence accounts for 15% of all murders in the United States.\*
- Half of all female homicide victims are killed by intimate partners.\*\*\*
- 1 in 3 women and 1 in 4 men have been victims of some form of physical violence by an intimate partner in their lifetime.\*
- The New Jersey homicide rate is 1.08 per 1,000 while the national rate is 1.09 per 1,000.
- Black women are especially at risk and are murdered at a rate 2.5 times greater than white women. The exception is victims over the age of 65 are more likely to be white women.\*\*
- A total of 1,616 women were killed by intimate partners nationally in 2013.\*\*

### **Objectives of the Review**

- Prevent future domestic violence and homicides.
- Provide safer provisions for battered women.
- Hold accountable both the perpetrators of domestic violence and organizations that come into contact with the involved parties.
- Identify trends in domestic violence deaths and integrate an understanding of possible risk factors into the various service systems functioning.
- Develop policy and system change recommendations from the review of facts and circumstances of domestic violence deaths.

The NJ DVFNFRB is authorized under the statute N.J.S.A. 52-27D-43.17d and is housed in the Department of Children and Families.
