I. Membership Update

The committee was informed that the membership vote was not conducted in the March task force meeting due to a lack of quorum. Applicants were encouraged to continue to attend meetings as guests

and informed that their work in workgroups continues to be valuable and meaningful to the subcommittee.

II. SUMMARY OF DISCUSSIONS

- A. The committee discussed the charter that is in the process of being drafted. The membership list was discussed to assure that necessary seats are represented without duplication and are relevant to the new vision and goal of the subcommittee.
- B. Workgroup Updates: members were encouraged to engage with workgroups and recommend stakeholders who may be able to collaborate with the groups.
 - 1. Training and Education
 - Overview of current policies and practices aimed at the protection of children, particularly within schools and child-serving institutions.
 - A highlight on the necessity for uniformity in training across districts to address inconsistencies.
 - Consideration of boundary-setting training as a preventative measure to curb institutional abuse.
 - 2. Policy and Legislation
 - Review of the 'Pass the Trash Legislation' concerning personnel conduct in schools as well as the two proposed pieces of legislation that are aiming to address deficits in the current legislation.
 - Examination of CARI Checks processes for school employees; issues identified include manual processing inefficiencies affecting the scale of checks.
 - Discussion extended to comparing state-level legislation and identifying best practices that could be adopted.

This memo aims to maintain transparency and provide the public with an overview of the task force's recent deliberations. The committee values community input and engagement as we collectively strive to enhance the welfare of children and families across New Jersey.
