


To Whom It May Concern, I am writing to officially request a no cost twelve (12) month grant extension of the FFY 2014 Sexual Assault Service Program (SASP) grant funds (grant #2014-KF-AX0034) in that amount of \$41,303, which currently expires on 07/31/2016. We are seeking approval to extend this grant until 07/31/2017. Within this time frame, New Jersey will write and disseminate a Request for Proposal (RFP) which will include provisions for direct services to victims of sexual violence whom represent underserved populations (male victims, communities of color, the LGBTQ community, the disabled/handicapped community, etc). It is our intention to utilize the aforementioned FFY 2014 SASP funds, as well as a portion of the FFY 2015 SASP allocation to fund the direct services to victims spelled out in the RFP. In an effort to achieve this in an efficient manner and due to the procurement process with this state, the New Jersey Department of Children and Families' Division on Women (DCF-DOW) will have to request the grant extension prior to the 90 window allotted for such a request. Without official documentation from the federal Office of Violence Against Women approving this a grant extension, the state will not approve the projected usage of these funds beyond the current expiration date.
