#### **Section I – General Information**

# A. Purpose:

The New Jersey Department of Children and Families (DCF) announces the availability of up to \$121,000 for a twelve (12) month contract to be awarded to one organization that will 1) contribute to the finalization of the NJ ACEs Action Plan for planned release in or around January, 2021; 2) develop a process through which to support, organize and monitor the work undertaken as part of the NJ ACEs Action Plan; and 3) support the ongoing work of the NJ ACEs Interagency Team; and 4) provide expert consultative support to the Office of Resilience.; and the through meeting design and facilitation, stakeholder engagement, meeting support, process management and material development.

# B. Background:

Through the Office of Resilience, DCF is leading a cross-section of state agencies to design, implement and support a statewide Adverse Childhood Experiences (ACEs) Action Plan. ACEs - or adverse childhood experiences - are traumatic life events that occur during childhood. When experienced in greater numbers and/or for extended periods of time without the nurturing and support of

a caring adult, ACEs can result in long-term, negative health and social consequences that impact not only that child, but can have intergenerational effects. In light of the COVID-19 pandemic - which is likely to be classified as traumatic event - the loss of financial security; threats to health, education, and access to social services; and the unavoidable loss of life make strengthening the infrastructure, programs, practices and policies across state agencies and in communities across the state even more critical than when this effort began. DCF seeks to create an process by which to hold itself accountable for advancing the goals outlined in the Action Plan; ensuring the meaningful engagement of those most impacted by ACEs in communities across the state, and public, private and philanthropic partners; and creating a model that can inform the efforts of other states to become trauma-informed/healing-centered.

# C. Scope of Work:

1. Action Plan Final Report: Provide final content, proofreading and design recommendations for the January or February 2021 release of the NJ ACEs Action Plan.

Project Deliverables:

- Final Action Plan for publication and release.
- **2. Convening and Facilitation:** Advise and support DCF/OOR in the design and facilitation of convenings to implement the NJ ACEs Action Plan.

Project Deliverables:

Meeting agendas, runs of show and collateral materials.

3. Interagency Team: Advise and support DCF/OOR in the design and facilitation of convenings to ensure the engagement of state agency leaders to advance trauma-informed/healing-centered policy and practice across state government and in through grant programs.

#### Project Deliverables:

- Ata least once per month, eeting agendas, collateral materials, and tools and templates to support the assessment of existing policies and practice and to inform the development of future policies and practice.
- **4. Office of Resilience**: Advise DCF in the development of a community-based strategy to reduce child abuse and neglect through the cross-sector coordination of services and initiatives.

#### Project Deliverables:

Connection to key organizations and entities in the ACEs community
across the state, identification of best/emerging practices related to
trauma-informed/healing centered policy and practice, subject matter
expertise, and convening/facilitation support.

#### 5. Additional Project Deliverables:

 Within 60 days from contract start date: A mutually agreed upon final project plan, outlining key roles, timelines and production schedule for the deliverables mentioned in the Scope of Work, above.

#### **6.Other Project Requirements**

All applicants are advised that any software purchased in connection with the proposed project must receive prior approval by the New Jersey Office of Information Technology.

Applicants are also advised that any deliverables, work product and/or data collected or maintained through the implementation of the proposed program shall remain the property of DCF. By accepting this opportunity, the applicant agrees to abide by the Federal Funding requirements in Exhibit E

# **D. Funding Information:**

All funding is subject to appropriation. For the purpose of this initiative, the Department will make available up to \$121,000 in federal funding. Applicants will be required after award to register in NJSTART (the State of New Jersey's eprocurement portal) in order to be paid. Applicants are also advised that any data collected or maintained through the implementation of the proposed program shall remain the property of DCF.

# E. Applicant Eligibility Requirements:

- Applicants must be for profit or not for profit corporations and/or Universities agree to be duly registered to conduct business within the State of New Jersey. Out of State Universities may apply and need to meet any requirements for performing these services in New Jersey.
- 2. Applicants must be in good standing with all State and Federal agencies with which they have an existing grant or contractual relationship.
- 3. If Applicant is under a corrective action plan with DCF (inclusive of its Divisions and Offices) or any other New Jersey State agency or authority, the Applicant may not submit a proposal for this RFQ if written notice of such limitation has been provided to the Agency or authority. Responses shall not be reviewed and considered by DCF until all deficiencies

- listed in the corrective action plan have been eliminated and progress maintained to the satisfaction of DCF for the period of time as required by the written notice.
- 4. Applicants shall not be suspended, terminated or barred for deficiencies in performance of any award, and if applicable, all past issues must be resolved as demonstrated by written documentation.
- 5. Applicants that are presently under contract with DCF must be in compliance with the terms and conditions of their contract.
- 6. Applicants must have the capability to uphold all administrative and operating standards as outlined in this document.

#### G. Administration:

#### 1. Screening for Eligibility, Conformity and Completeness

DCF will screen proposals for eligibility and conformity with the specifications set forth in this RFQ. A preliminary review will be conducted to determine whether the application is eligible for evaluation or immediate rejection.

The following criteria will be considered, where applicable, as part of the preliminary screening process:

- a. The application was received prior to the stated deadline
- b. The application is signed and authorized by the applicant's Chief Executive Officer or equivalent
- c. The application is complete in its entirety, including all required attachments and appendices
- d. The application conforms to the specifications set forth in the RFQ

Upon completion of the initial screening, proposals meeting the requirements of the RFQ will be distributed to the Proposal Evaluation Committee for its review and recommendations. Failure to meet the criteria outlined above, or the submission of incomplete or non-responsive applications constitutes grounds for immediate rejection of the proposal if such absence affects the ability of the committee to fairly judge the application.

#### 2. Proposal Review Process

DCF will convene a Proposal Evaluation Committee in accordance with existing regulation and policy. The Committee will review each application in accordance with the established criteria outlined in Section II of this document. All reviewers, voting and advisory, will complete a conflict of interest form. Those individuals with conflicts or the appearance of a conflict will be disqualified from participation in the review process. The voting members of the Proposal Evaluation Committee will review proposals, deliberate as a group, and then independently score applications to determine the final funding decisions.

The Department also reserves the right to reject any and all proposals when circumstances indicate that it is in its best interest to do so. The Department's best interests in this context include, but are not limited to: State loss of funding for the contract; the inability of the applicant to provide adequate services; the applicant's lack of good standing with the Department, and any indication, including solely an allegation, of misrepresentation of information and/or non-compliance with any State of New Jersey contracts, policies and procedures, or State and/or Federal laws and regulations.

All applicants will be notified in writing of the Department's intent to award a contract.

#### 3. Special Requirements

The successful Applicant shall maintain all documentation related to products, transactions or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request.

Applicants must comply with the requirements of <u>N.J.S.A.</u> 10:5-31 et seq. and <u>N.J.A.C.</u> 17:27, the State Affirmative Action policy. A copy is attached as <u>Exhibit A.</u>

# H. Appeals:

# J. Post Award Requirements:

Selected applicants will also be required to comply with all applicable State and Federal laws and statutes, assurances, certifications and regulations regarding funding.

Upon receipt of the award announcement, and where appropriate, selected applicants will be minimally required to submit one (1) copy of the following documents:

# A. Proposal Requirements and Review Criteria:

All applications will be evaluated and scored in accordance with the following criteria:

The narrative must be organized appropriately and address the key concepts outlined in the RFQ.

Each proposal narrative must contain the following items organized by heading in the same order as presented below:

#### 1) Organizational Capacity

(20 Points)

- a) Provide an overview of the organization's vision and mission.
- b) Describe the organization's governance structure and its administrative, management and organizational capacity. Note the existence, if any, of professional advisory boards that support the operations. Attach a current organizational chart as an appendix.
- c) Describe the organization's experience working with at least three (3) other jurisdictions in a similar capacity.
- d) Describe the organization's expertise and experience with:
  - Use of geospatial analysis to predict child maltreatment and maltreatment related fatalities.

- Project management, including, but not limited to, expert consultation services, meeting support, collateral development, coaching, mentoring, technical assistance and troubleshooting.
- Development of community-based strategy to reduce child abuse and neglect through cross-sector coordination of services and initiatives.
- Coaching jurisdictions to build the internal capacity to perform the analysis on an ongoing basis.
- e) Indicate how this opportunity fits into the organization's vision and overall programming.

#### 2) Project Plan

(40 Points)

- a) Describe organization's proposed approach to developing the work as described in **Section C-Scope of Work**.
- b) Describe how the predictive analytics model is compliant with the DCF Research Review Committee requirements as outlined in the DCF Research Review Committee Protocol and Application for Proposed Research Projects Involving Existing Client Records and Data.
- c) Describe how the organization shall secure data.
- d) Describe how the organization shall manage personally identifiable information within a secure network in accordance with DCF Research Review Committee requirements as outlined in the DCF Research Review Committee

Protocol and Application for Proposed Research Projects Involving Existing

Client Records and Data.

- e) Provide a draft timeline and implementation plan for the project, indicating contingencies where appropriate .
- f) Describe project staffing. Indicate the number and qualifications of all staff for this initiative. Indicate if staff are existing. Please provide resumes of any existing staff, in the appendices. Indicate if staff will need to be hired. For any currently vacant positions that would be filled by new hires, provide job descriptions that include all educational and experiential requirements, in the appendices.
- g) Include an organizational chart for the proposed staffing model, in the appendices.
- h) Provide a description of any partnerships, collaborative efforts or processes that will be used to provide the proposed services or provide creative, in-community locations for the services (attach any affiliation agreements or Memoranda of Understanding, if available).
- Outline how your organization will monitor and report on progress and performance for plan outlined.

#### 3) Budget Narrative

(20 Points)

The budget form for this RFQ is provided and the Standard Annex B budget form is not required. The <u>Budget Worksheet</u> is provided as Exhibit C with the RFQ for your reference. If you wish to complete a different form or format, that will be accepted.

4) References (20 points)

Include name, affiliation and contact information for three references. References should be able to address experience with your organization that is relevant to the proposed project.

#### MANDATORY EQUAL EMPLOYMENT OPPORTUNITY LANGUAGE N.J.S.A. 10:5-31 et seq. (P.L. 1975, C. 127) N.J.A.C. 17:27

#### GOODS, PROFESSIONAL SERVICE AND GENERAL SERVICE CONTRACTS

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable, will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex. Except with respect to affectional or sexual orientation and gender identity or expression, the contractor will ensure that equal employment opportunity is afforded to such applicants in recruitment and employment, and that employees are treated during employment, without regard to their age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex. Such equal employment opportunity shall include, but not be limited to the following: employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the Public Agency Compliance Officer setting forth provisions of

this nondiscrimination clause.

The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex.

The contractor or subcontractor will send to each labor union, with which it has a collective bargaining agreement, a notice, to be provided by the agency contracting officer, advising the labor union of the contractor's commitments under this chapter and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor or subcontractor agrees to make good faith efforts to meet targeted county employment goals established in accordance with N.J.A.C. 17:27-5.2.

The contractor or subcontractor agrees to inform in writing its appropriate recruitment agencies including, but not limited to, employment agencies, placement bureaus, colleges, universities, and labor unions, that it does not discriminate on the basis of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex, and that it will discontinue the use of any recruitment agency which engages in direct or indirect discriminatory practices.

The contractor or subcontractor agrees to revise any of its testing procedures, if necessary, to assure that all personnel testing conforms with the principles of job- related testing, as established by the statutes and court decisions of the State of New Jersey and as established by applicable Federal law and applicable Federal court decisions.

In conforming with the targeted employment goals, the contractor or subcontractor agrees to review all procedures relating to transfer, upgrading, downgrading and layoff to ensure that all such actions are taken without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex, consistent with the statutes and court decisions of the State of New Jersey, and applicable Federal law and applicable Federal court decisions.

The contractor shall submit to the public agency, after notification of award but prior to execution of a goods and services contract, one of the following three documents:

Letter of Federal Affirmative Action Plan Approval

Certificate of Employee Information Report

Employee Information Report Form AA302 (electronically available at www.state.nj.us/treasury/contract\_compliance).

The contractor and its subcontractors shall furnish such reports or other documents to the Department of Children and Families, the Division of Purchase & Property, CCAU, EEO Monitoring Program as may be requested by the office from time to time in order to carry out the purposes of these regulations, and public agencies shall furnish such information as may be requested by the Department of Children and Families, the Division of Purchase & Property, CCAU, EEO Monitoring Program for conducting a compliance investigation pursuant to **Subchapter 10 of the Administrative Code at N.J.A.C. 17:27**.

# TITLE 10. CIVIL RIGHTS CHAPTER 2. DISCRIMINATION IN EMPLOYMENT ON PUBLIC WORKS

N.J. Stat. § 10:2-1 (2012)

§ 10:2-1. Antidiscrimination provisions

Antidiscrimination provisions. Every contract for or on behalf of the State or any county or municipality or other political subdivision of the State, or any agency of or authority created by any of the foregoing, for the construction, alteration or repair of any public building or public work or for the acquisition of materials, equipment, supplies or services shall contain provisions by which the contractor agrees that:

- a. In the hiring of persons for the performance of work under this contract or any subcontract hereunder, or for the procurement, manufacture, assembling or furnishing of any such materials, equipment, supplies or services to be acquired under this contract, no contractor, nor any person acting on behalf of such contractor or subcontractor, shall, by reason of race, creed, color, national origin, ancestry, marital status, gender identity or expression, affectional or sexual orientation or sex, discriminate against any person who is qualified and available to perform the work to which the employment relates;
- b. No contractor, subcontractor, nor any person on his behalf shall, in any manner, discriminate against or intimidate any employee engaged in the performance of work under this contract or any subcontract hereunder, or engaged in the procurement, manufacture, assembling or furnishing of any such materials, equipment, supplies or services to be acquired under such contract, on account of race, creed, color, national origin, ancestry, marital status, gender identity or expression, affectional or sexual orientation or sex;
- c. There may be deducted from the amount payable to the contractor by the contracting public agency, under this contract, a penalty of \$ 50.00 for each person for each calendar day during which such person is discriminated against or intimidated in violation of the provisions of the contract; and
- d. This contract may be canceled or terminated by the contracting public agency, and all money due or to become due hereunder may be forfeited, for any violation of this section of the contract occurring after notice to the contractor from the contracting public agency of any prior violation of this section of the contract.

No provision in this section shall be construed to prevent a board of education from designating that a contract, subcontract or other means of procurement of goods, services, equipment or construction shall be awarded to a small business enterprise, minority business enterprise or a women's business enterprise pursuant to P.L.1985, c.490 (*C.18A:18A-51* et seq.).
