#### 1. There are 4 different types of car seats:

Infant – Infant Convertible – Infant / Toddler High Back – Toddler Booster – child

Should we price the convertible/toddler as 1 type and then the case worker would choose which they want – convertible vs. high back?

No. The convertible should be its own seat. The "High Back" booster is not for toddlers. They are to be used for children in the age group similar to the backless boosters, as indicated on the booster seat's manufacturer's label.

Boosters can be priced together, and the worker can choose which type of booster they want, the regular booster or the high back booster. These are the types of car seats, as indicated in the list above:
