## Today's Speakers



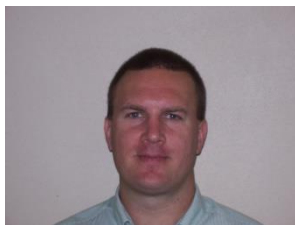
Bob Kettig is currently Bureau Chief of the Bureau of Energy and Sustainability at The New Jersey Department of Environmental Protection. In his 27-year career at NJDEP, Bob has worked in a number of programs that have included managing the Air Permitting Program, serving as DEP Representative for the Regional Greenhouse Gas Initiative (RGGI) and overseeing stack emission monitoring testing with The Bureau of Technical Services.



Dave Stangis serves as Vice President-Corporate Responsibility and Chief Sustainability Officer for Campbell Soup Company. He reports to Campbell's President and Chief Executive Officer. Dave designs Campbell's corporate social responsibility (CSR) and sustainability strategies, goals, policies, and programs. He leads the Company's strategies and external engagement related to CSR Strategy, Responsible Sourcing, Sustainable Agriculture, and Operational Sustainability. Working closely with other senior leaders, he advances Campbell's operational and communication strategies in these areas.



Michael Downs is the Global Environmental Health & Safety Specialist for Campbell Soup Company. Mike leads the EHS function at the Camden WHQ site and oversees various Global EHS management systems, including compliance, audit tracking and collection of key performance metrics.



Chris Waldron has been the Director of Sustainability and Shared Services for Camden County since 2012. Prior he worked at the Philadelphia Zoo for 19 years; serving various roles as a zookeeper, primate and carnivore curator, and the first Director of Sustainability. Chris is also a LEED Accredited Professional through the U.S. Green Building Council and a professor at the Animal Behavior Institute as well as an adjunct professor at Burlington County College and Richard Stockton University.



Melissa Donnelly is Senior Manager of Global Supply Chain Sustainability for Campbell Soup Company. She leads sustainability work across Campbell's manufacturing sites and drives progress on Campbell's commitments to climate, water and waste. She also leads the Company's commitment to reduce food waste and develops processes to integrate sustainability into business functions. She serves on the Consumer Goods Forum Food Waste Working Group, the ReFED Advisory Council and manages Campbell's executive membership with Champions 12.3.
