



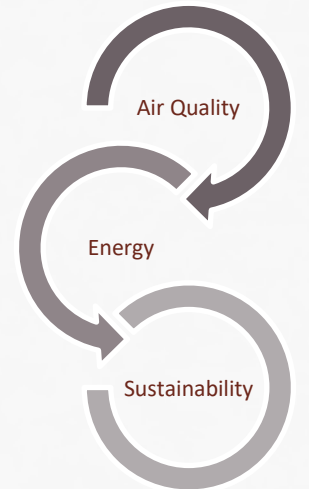

SEVEN-DAY-NOTICE:
AN APPLICATION OR A LETTER

THREE TYPES OF SEVEN-DAY-NOTICES (MINOR FACILITIES ONLY)

- Seven-day-notice changes to existing source [N.J.A.C. 7:27-8.20]
- Special provisions for construction but not operation of a new source [N.J.A.C. 7:27-8.24]
- Special provisions for pollution control equipment or pollution prevention process modifications [N.J.A.C. 7:27-8.25]

SEVEN-DAY-NOTICE RADIUS APPLICATION

- Use of a new raw material not specified in the permit if the use would not cause any of results listed under N.J.A.C. 7:27-8.18(a)3(i) through (iii) [N.J.A.C. 7:27-8.18(a)3]
- A change made to a permitted source which meets all three of the requirements listed under N.J.A.C. 7:27-8.20(b)1(i) through (iii) [N.J.A.C. 7:27-8.20(b)]
- Construction or installation of a new insignificant source if the emissions from the insignificant source shall be released through the same control device as emissions from an existing, permitted significant source [N.J.A.C. 7:27-8.20(c)]

SEVEN-DAY-NOTICE RADIUS APPLICATION

- The applicant should submit a RADIUS application. If all of the requirements of N.J.A.C. 7:27-8.20 are met, the permittee may begin the actions proposed in the notice of a seven-day-notice change starting seven days after the application has been submitted to the Department
- The applicant acting under the authority of a seven-day-notice change does so at risk.
- The applicant should pay the application fee
- The Department will review the application
- The Department will take final action (approve or deny)

SEVEN-DAY-NOTICE LETTER

- N.J.A.C. 7:27-8.24 Special Provisions for Construction but not Operation
 - The applicant has submitted a complete application to the Department, proposing the construction, reconstruction, installation, and/or placement of the source;
 - The applicant should submit **a letter** notifying the Department seven days prior to beginning of the construction if the construction is not prohibited by any State or Federal law or requirement (PSD, MACT, Acid Rain, N.J.A.C. 7:27-18)
 - The applicant shall only construct, reconstruct, install, and/or place the source on footings or a foundation as proposed in the application. The applicant shall not test or operate the source
 - The Department will not review the letter. Applicants proceed at their own risk

SEVEN-DAY-NOTICE LETTER

- N.J.A.C. 7:27-8.25 Special Provisions for Pollution Control Equipment or Pollution Prevention Process Modifications
 - The applicant has submitted a complete application to the Department, proposing construction, installation, reconstruction or operation of a control apparatus serving an existing source or implementation of a pollution prevention process modification, as defined at N.J.A.C. 7:27-8.1, involving one or more existing sources.
 - The applicant should submit **a letter** notifying the Department seven days prior to beginning the activities
 - The Department will not review the letter. Applicants proceed at their own risk
