

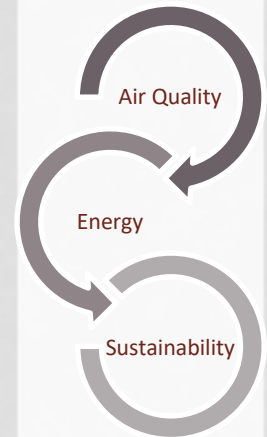

GP-017A	Boiler(s) and Heater(s) each less than 5 MMBTU per hour	Revised to implement MACT 6' Js for Industrial, Commercial and Institutional boilers. This GP will replace the existing GP-017.	Effective Date: March 20, 2017
GP-018A	Boiler(s) and Heater(s) each greater than or equal to 5 MMBTU per hour and less than 10 MMBTU per hour	To implement MACT 6' Js for Industrial, Commercial and Institutional boilers. This GP will replace the existing GP-018.	Availability Date: August 07, 2017
