**Request for Comments on the Draft Supplemental Environmental Impact Statement
for the Proposed American Dream Meadowlands Project
to be Constructed Within the NJSEA's Meadowlands Sports Complex
- 30-Day Extension of Public Comment Period -**

PLEASE TAKE NOTICE that the New Jersey Meadowlands Commission (NJMC) and the New Jersey Department of Environmental Protection (NJDEP) are providing a 30-day extension to receive comments from the public on the draft supplemental environmental impact statement (DSEIS) for the proposed American Dream Meadowlands Project (Project) to be constructed within the New Jersey Sports and Exposition Authority's (NJSEA) Meadowlands Sports Complex in East Rutherford, New Jersey. The comment period, which was scheduled to close on December 19, 2011, has been extended and will close on January 18, 2012.

At the close of the public comment period on January 18, 2012, the hearing officers will transmit copies of all public comments received to the NJSEA. Upon receipt of the public comments, the NJSEA will complete the final supplemental EIS, which shall include responses to the public comments made during the scoping process, and submit it to the NJMC and NJDEP in February 2012. The NJSEA will also make the final supplemental EIS available to the public in February 2012.

The hearing officers shall complete their report by April 9, 2012 and copies of the Hearing Officers' Report will be made available to the public upon completion at the locations listed. Thereafter the Hearing Officers' Report shall be submitted for review and action to the NJMC's Board of Commissioners and the Commissioner of NJDEP.
