WITNESSETH:

WHEREAS, Owner is the owner of certain real property designated as Lot(s) _____,

WHEREAS, pursuant to the Commission's regulations set forth at N.J.A.C. 7:45 et seq. (the
Regulations), the Commission has reviewed and issued an approval (the Approval) on

WHEREAS, the Approval granted by the Commission requires Owner to enter into a stream corridor conservation easement agreement with the Commission to ensure against any adverse impacts on the stream corridor and to otherwise comply with the Commission's requirements and with the Master Plan for the Delaware and Raritan Canal State Park; and,

WHEREAS, a portion of the stream corridor (the Corridor) of _____,
(name of stream)
which is subject to Stream Corridor Impact review by the Commission, is located on the Property, and this portion of the stream corridor is shown on the plan(s) entitled _____, prepared by _____, and dated _____, and is more fully described in Exhibit A, which is attached hereto and incorporated herein by reference. The information on this plan (or plans) shall supersede any information in this Agreement.

NOW THEREFORE, in consideration of the Approval granted by the Commission, Owner and the Commission agree as follows:

1. The Corridor is regulated by the Commission pursuant to the Regulations effective the date of the issuance of the Commission's Approval for this project.
2. Any uses approved by the Commission as part of this Approval and as depicted on the plan(s) in Exhibit A (hereinafter collectively referred to as the "Permitted Uses") shall be permitted.
3. Except for the Permitted Uses, all other uses are prohibited.

4. The Commission and its successors shall have the right to enforce the terms and conditions of this Agreement in accordance with law.
5. This Agreement is binding upon the Owner, its successors and assigns. It shall be construed as a conservation easement running with the land and shall be binding upon any person to whom title to the Property or any portion thereof within the Corridor is transferred, as well as upon the heirs, successors and assigns of all such persons.
6. This Agreement shall be construed as if drafted jointly by both parties.
7. Owner agrees to record this Conservation Easement Agreement and any amendment thereto and to provide the Commission with evidence of same.
