# RECYCLED CONTENT WAIVER APPLICATION FORM

To apply for a waiver from the postconsumer recycled content requirements of New Jersey's Recycled Content Law (N.J.S.A. 13:1E-99.135-157), the Facility Contact, as identified in the manufacturer's registration, must complete, and submit this form. Only manufacturers that have registered with the New Jersey Department of Environmental Protection are eligible to submit a waiver application. If the manufacturer has not yet registered, please visit Manufacturer Registration. Applications received from unregistered manufacturers will be denied.

Please note that the manufacturer will be billed a \$1,000 waiver application fee upon receipt of this application unless the manufacturer generated less than \$5,000,000 in gross revenue.

Waivers are intended to provide manufacturers with <u>temporary</u> relief from the law's postconsumer recycled content requirements. If approved for a waiver, manufacturers are expected to take all feasible actions to ensure the reduction, collection, recycling, and reuse of rigid plastic containers, plastic beverage containers, glass containers, paper carryout bags, plastic carryout bags, or plastic trash bags made from non-postconsumer recycled plastic, glass, or paper, as applicable, and to ensure the use of postconsumer recycled content for the duration of the approved waiver.
