Dear Mr. Guerra:

The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a proposed amendment to the Hudson County District Solid Waste Management Plan (County Plan) dated January 30, 2018. This amendment to the County Plan proposes County Plan inclusion of the revised hours of operation for waste acceptance and processing on a six-month trial basis at the Lincoln Recycling Services, Inc. Transfer Station/Materials Recovery Facility (TS/MRF) located at 4711 Dell Avenue, Block 91, Lot 1; Block 93, Lots A & B; Block 95, Lot 1 and Block 100, Lots 24-27 in the Township of North Bergen. At the termination of the six-month trial, the Hudson County Improvement Authority shall affirm to the Department the revised operating hours in the County Plan. If no correspondence is received after the six-month trial, the revised hours of operation will prevail.

Specifically, the following revised hours of operation are included in the County Plan for the Lincoln Recycling Services, Inc. TS/MRF:

Acceptance of waste: Monday through Friday: 5:00 a.m. to 7:00 p.m.

Saturday: 5:00 a.m. to 3:00 p.m.

• Processing of waste: Monday through Friday: 5:00 a.m. to 10:00 p.m.

Saturday: 5:00 a.m. to 5:00 p.m.

Pursuant to <u>N.J.A.C.</u> 7:26-6.11(b)14, the inclusion of revised hours of operation can be accomplished via an administrative action. Therefore, the County Plan inclusion of the revised hours of operation at the Lincoln Recycling Services, Inc. TS/MRF is hereby approved as an administrative action pursuant to <u>N.J.A.C.</u> 7:26-6.11(f).

Please be advised that this administrative action approval shall not be construed as an expression of the Department's intent to issue a permit modification to the subject facility for the above noted operational changes.
