Dear Mr. Newman:

The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a proposed amendment to the Monmouth County District Solid Waste Management Plan (County Plan) dated July 8, 2019. This amendment to the County Plan proposes County Plan inclusion of designated traffic routes for solid waste vehicles accessing the Republic Services of New Jersey, LLC (RSNJ) Transfer Station / Materials Recovery Facility (TS/MRF) located at 1861 Wayside Road in Tinton Falls. Specifically, the July 8, 2019 request specifies that all solid waste vehicles accessing the RSNJ TS/MRF will utilize the following truck routes for entering and exiting the facility:

From Garden State Parkway Southbound

• Follow Garden State Parkway South to Wayside Road (Exit 105). Follow Wayside Road and turn right into the facility.

From Garden State Parkway Northbound

 Follow Garden State Parkway North to Wayside Road (Exit 105). Follow Garden State Parkway exit ramp, merging onto NJ Route 18. Follow NJ Route 18 North to Wayside Road (Exit 15A). Follow Wayside Road and turn right into the facility.

From NJ Route 18 North

 Follow NJ Route 18 North to Wayside Road (Exit 15A). Follow Wayside Road and turn right into the facility.

From NJ Route 18 South

• Follow NJ Route 18 South to Wayside Road (Exit 15A). Follow Wayside Road and turn right into the facility.

From NJ Route 36

- Follow NJ Route 36 and turn left onto Hope Road. Follow Hope Road and turn right onto Shafto Road. Follow Shafto Road and turn right onto Wayside Road. Follow Wayside Road and turn right into the facility.
- Follow NJ Route 36 and turn left onto Hope Road. Follow Hope Road and turn left onto Tinton Avenue. Follow Tinton Avenue and turn left onto Wayside Road. Follow Wayside Road and turn left into the facility.

From NJ Route 35 South

• Follow NJ Route 35 (south) and turn right onto Tinton Avenue. Follow Tinton Avenue and turn left onto Wayside Road. Follow Wayside Road and turn left into the facility.

From NJ Route 35 North

- Follow NJ Route 35 (north) and turn left onto Tinton Avenue. Follow Tinton Avenue and turn left onto Wayside Road. Follow Wayside Road and turn left into the facility.
- Follow NJ Route 35 (north) and turn left onto NJ Route 36. Follow NJ Route 36 and turn left onto Hope Road. Follow Hope Road and turn right onto Shafto Road. Follow Shafto Road and turn right onto Wayside Road. Follow Wayside Road and turn right into the facility.
- Follow NJ Route 35 (north) and turn left onto NJ Route 36. Follow NJ Route 36 and turn right onto Hope Road. Follow Hope Road and turn left onto Tinton Avenue. Follow Tinton Avenue and turn left onto Wayside Road. Follow Wayside Road and turn left into the facility.

<u>From Tinton Avenue</u>

• Follow Tinton Avenue to Wayside Road. Follow Wayside Road and turn left into the facility.

<u>From Pinebrook Road</u>

 Follow Pinebrook Road (west) and turn left onto Wayside Road. Follow Wayside Road and turn left into the facility.

From Squankum Road

• Follow Squankum Road (east) and turn right onto Wayside Road. Follow Wayside Road and turn left into the facility.

From Wyckoff Road

Follow Wyckoff Road (south) which becomes Shafto Road after crossing NJ Route 18.
 Follow Shafto Road and turn right onto Wayside Road. Follow Wayside Road and turn right into the facility.

From Shafto Road

 Follow Shafto Road (north) and turn left onto Wayside Road. Follow Wayside Road and turn right into the facility.

Pursuant to N.J.A.C. 7:26-6.11(b)2, the inclusion of designated traffic routes for solid waste vehicles accessing a solid waste facility can be accomplished via an administrative action. Therefore, the County Plan inclusion of designated traffic routes for solid waste vehicles accessing the RSNJ TS/MRF in Tinton Falls, is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
