Dear Mr. Zaayenga:

On July 20, 2001, the Department of Environmental Protection's Division of Solid and Hazardous Waste received a request for an administrative action to include in the Monmouth County District Solid Waste Management Plan (County Plan) operational changes at Freehold Cartage, Inc.


Freehold Cartage, Inc., which occupies Block 43, Lot 18, on Route 33, in Freehold Township, was added to the County Plan on August 9, 1984, and the amendment was certified on January 1, 1985. Freehold Cartage, Inc. has been conducting a bulky recyclables operation under a NJDEP Class B recycling facility permit, but without limitations and conditions that are now commonly cited for newly proposed Class B recycling facilities. The proposed administrative action request would provide limitations and conditions for Freehold Cartage, Inc. as both a Class B recycling facility and transfer station. The average daily capacity shall be limited to 300 tons per day (TPD), Monday through Saturday, with no more than 60 TPD consisting of type 10 municipal waste from truckloads containing significant amounts of recoverable recyclable material. The remaining unused daily allowance would be used for bulky and non-hazardous manufacturing type wastes (types 27, 13 and 13C). Total waste deliveries received from Monday through Saturday may not exceed 1800 tons; and no single day may exceed 400 tons. Solid waste may be received on Sunday, but the total shall not exceed 100 tons, and will not be used to calculate the daily average. The hours of operation will remain consistent with those presently in place within the Class B approval.

Pursuant to N.J.A.C. 7:26-6.11(b) 5, site expansion and on-site operational changes at an existing facility may be considered for approval through the administrative action process. Therefore, this amendment is hereby approved as an administrative action pursuant to

N.J.A.C. 7:26-6.11(f). The approval of this administrative action should not be construed as an approval by the Department to begin the proposed recycling activities at the facility. This activity shall be preceded by the acquisition of all necessary permits and approvals pursuant to N.J.S.A. 13:1E-1 et seq., and all other applicable laws.
